EXPLANATORY PREFACE

This volume is a supplement to the "First Records of Baltimore Town and Jones Town 1729-1797," and "Records of City of Baltimore (City Commissioners) 1797-1813," previously issued. The data here given should have been included in the foregoing volumes, as it covers the same period and is of the same general character. The records, however, were not discovered until after the first books were issued; hence this supplement is actually a part of the previous publications and should be read in connection with them.

This work contains boundary establishments of tracts, lots, streets and levels (or grades), which are not recorded in the volumes of 1905-6. The records are those of the City Commissioners, the originals being in custody of the City Librarian. In order to avoid confusion it may be well to note that the City Commissioners were not alone entrusted with the duties of making establishments and grades.

The records of a Special Commission 1728 to 1797; Western and Eastern Precinct Commissioners 1810 to 1817, which were engaged in the same work, will be published later, and should be consulted to exhaust the subject of early "establishments," "grades," etc.

The Special Commission referred to above should not be confused with (temporary) special commissions which laid out certain streets. Legislative Acts show that sundry commissioners of this character were authorized, but their records are very meager.

This printed copy has been made to conform to the originals as nearly as possible. There was no effort to correct, revise or interfere in any detail.

List of Levels

commencing the 17th July 1797

GEORGE STREET

17th July 1797.

RESOLVED, that the level of George Street be as follows, beginning opposite Peter Steele's door, and thence West with a descent of one Inch in every ten feet to the Market Square, and from the same beginning East with the same Descent to Ann Street.

PITT STREET

21st August

RESOLVED, that Pitt street have the following level, to wit Beginning at the centre of an Alley, between Dr. John Coulter's & Lewis De Rochburne's lots, thence eastwardly with a regular Descent to the water, and from said Alley westwardly with a regular Descent to Ann Street.

WATER STREET

4th September.

RESOLVED, that the level of Water Street be as follows, beginning at the level of the pavement in Public Alley, thence with a Descent of one Inch in every ten feet, to the Centre of the Alley on the west side of Job Smiths Warehouse, thence ascending with an equal grade to the pavement on the west side of Calvert street, and that the Alleys leading from the said street to Front street, have the following levels, to wit Beginning at the level of Water street, and thence with a graduel descent to the tops of the logs at the head of the dock back of Messrs Yellot and Hollingsworth's Warehouses.

BOND STREET

28th July 1798.

RESOLVED, that Bond Street from the North side of Fleet Street, have an Ascent of one Inch and one sixteenth of an Inch in every ten feet to the South side of Wilks Street.

WILKS STREET

16th May 1799.

RESOLVED, that wilks Street, have one inch and one half of an inch, Descent in every ten feet from Bond street to

Caroline street, and from thence to Spencers Alley an ascent of one inch in every ten feet and from thence West to the East side of Eden street a Descent of one inch in every ten feet.

HOWARD STREET

28th May

RESOLVED, that Howard Street from the north gutter of Saratoga Street to the South gutter of Mulberry street have an Ascent of four inches in every ten feet, and from the North gutter of Mulberry street to the South gutter of Franklin Street an ascent of four inches & a half in every ten feet.

FAYETTE STREET

11th July 1799.

RESOLVED, that Fayette Street have a Descent of about five inches & one fourth of an inch, in every ten feet from Howard Street to the west side of North street and from the East side of North street an even regular Descent to the west side of Liberty street.

CHARLES STREET

30th July.

RESOLVED, that Charles Street have a Descent of one inch and a half in every ten feet from the Centre of said street from the south gutter of Pratt street to the North gutter of Campden street and that said Charles Street have an ascent of one inch in every ten feet from the south gutter of Campden street to the Centre of the square between Campden and Conway Streets and a descent of one inch from said Centre to the North gutter of Conway Street, and that the same grade shall be adopted between Conway and Barre Streets as is fixed between Conway and Campden streets.

ALICE ANNA STREET

20th August.

RESOLVED, that Alice Anna Street have a Descent of three fourths of an inch in every ten feet from the East gutter of Market Street to the west gutter of Ann Street—Extended Sec. 27th March 1801.

CONAWAGO STREET

19th March 1800.

RESOLVED, that Conawago Street, have an even regular descent from two inches below the top of a Stone marked *RS* at the North East corner of Richardson Stuarts Brick Nail Manufactory on the south side of said street to Liberty street.

EUTAW STREET

8th April.

RESOLVED, that Eutaw Street have an ascent of one inch and three quarters of an inch in every ten feet from the thickness of two bricks above the stone work of Daniel Raymonds brick House on the North side of Lexington street at its intersection with Eutaw street to the height of twenty-six inches above the sills of George Kurtz frame House at the intersection of Eutaw and Saratoga streets.

MARKET SPACE

9th April.

RESOLVED, that Market Space have one and a half inch ascent in every ten feet from the south gutter of water street to the distance of thirty six feet south, & then that the west side of said space have one inch Descent in every ten feet conducting the water from the westward of the Centre of said space into the Dock; and that the East side thereof have the same grade to the North gutter of Pratt Street.

PRATT STREET

Also RESOLVED, that Pratt street from the Centre of Market space, have one inch and a half descent in every ten feet to Jones's Falls.

JONES STREET

29th April.

RESOLVED, that Jones Street have one inch ascent in every ten feet from the front door of Jacob Millers Brick House to the Bend in said Street and from thence to have one even descent to thirty inches below the stone work of Saml. Davis's brick Building standing on the west Extremity of Jones Town.

PITT STREET { *NB. This grade lays over for further consideration.*

Also RESOLVED, that Pitt Street have an Ascent East from High street to Milk lane in every ten feet from thirty inch below the top of the sill of the East door of Amos Underhills Brick House.

PUBLIC ALLEY

19th May.

RESOLVED, that Public Alley have a Descent of one inch in every ten feet from the south side of New street to the end of the Wharf at the line of the south side of Pratt street.

LANCASTER STREET

9th June 1800.

RESOLVED, that Lancaster Street from Bond street have a Descent of one inch and a half in every ten feet for the distance of one Hundred feet from west side of Bond street.

PRATT STREET

28th February 1801.

RESOLVED, that Pratt street from the west gutter of Light Street have an ascent of four inches in every ten feet for the distance of fifty feet, then with one even ascent to the East gutter of Charles Street, and in consequence of an over proportion of Water falling into the Bason at the end of Light Street,

RESOLVED, that all the water which comes down Pratt Street west of Charles Street shall be conveyed down said street to Camden street and thence into the Bason, but for the present as a temporary convenience it is agreed that the water may pass down Pratt Street untill Charles street is paved between Pratt and Camden Streets and no longer.

CALVERT STREET

2nd March.

RESOLVED, that Calvert Street extended have a Descent of six inches in every ten feet for the distance of sixty five feet from the center of East street, thence a Descent of four

inches in every ten feet for the further distance of one Hundred and twenty feet.

ALICE-ANNA-STREET

27th March 1801.

RESOLVED, that Alice-Anna street have a Descent of three quarters of an inch in every ten feet from the East Gutter of Market Street to Washington Street.

MARKET STREET FELLOES POINT

28th April.

RESOLVED, that Market Street have a regular ascent from the North gutter of Lancaster Street to the south gutter of Alice-Anna street and from the North gutter of Alice-Anna street one inch in every ten feet to the South gutter of Fleet street.

FLEET STREET

Also RESOLVED, that Fleet street have a regular Descent from the west gutter of Market street to the East gutter of Bond street.

GEORGE STREET

Also RESOLVED, that George street have a Descent of one inch in every ten feet from the East gutter of Ann Street to Washington Street.

LANCASTER STREET

1st June 1801.

RESOLVED, that Lancaster street from the Market square have one inch ascent in every ten feet to the distance of seventy feet, from thence one inch descent in every ten feet to Ann street the West side thereof, and not less than seven eighths of an inch in every ten feet from thence to the Water.

ARGYLE ALLEY

Also RESOLVED, that Argyle Alley have an uniform descent from fleet street to Alice-Anna street.

STILL HOUSE STREET

15th June.

RESOLVED, that Still House street have a descent of one inch in every ten feet from the North side of King George street to Still House Alley, then with an ascent from the North side of still House Alley to the top of the Stone wall of the foundation of the North East corner of the Still House.

CAROLINE STREET

17th July 1801.

RESOLVED, that Caroline Street have a Descent of three quarters of an Inch in every ten feet from the south gutter of Wilks street to the North gutter of Fleet Street.

FLEET STREET

Also RESOLVED, that Fleet Street have one uniform Descent from the West side of Bond street to the East gutter of Caroline Street from thence with a descent of three Quarters of an inch in every ten feet to the East gutter of Harford Street, or the Canal which may hereafter be fixed there.

LEXINGTON STREET

29th July.

RESOLVED, that Lexington Street have a Descent of one inch & one quarter of an inch in every ten feet from the East gutter of Howard street to the West gutter of Liberty street.

CAMPDEN STREET

31 July.

RESOLVED, that Campden Street have a regular ascent from West gutter of Hanover Street to the East gutter of Howard Street.

TEN FEET ALLEY

1st February 1802.

RESOLVED, that ten feet Alley have an even regular Descent from the Intersection of said Alley and Conawago Street to the North gutter of Chatham street.

FRONT STREET

Baltimore 15th march 1802.

WHEREAS the whole of the proprietors of lots situated on Front street between Baltimore street and Pitt or Wapping street by their petition dated the 17th. february last have set forth that they will be considerably injured if the said Front street is paved according to the grade established on the 27th day of June 1785 and praying that said grade may be made null & void & that the City Commissioners may establish such grade as to them may seem best — The City Commissioners having considered said petition & judging the same to be reasonable, therefore RESOLVED, that Front street have an even regular descent from Baltimore Street extended to Pitt street or Wapping Street.

ALBEMARLE STREET

April 23d, 1802

RESOLVED, that Albemarle street have an ascent of one inch in every ten feet from the South Gutter of Polly street to the Northside of Wilkes Street and then have a descent of one Inch in every ten feet to the North Gutter of Wilkes street.

WILKES STREET

RESOLVED that wilkes street have a descent of one inch & one quarter in ten feet from the East Gutter of Albemarle street to Harford street, & that said Wilkes street have a descent of one Inch and a quarter in ten feet from the West Gutter of Albemarle street to Jones's Falls.

FLEET STREET

BALTO., 1st. June 1802.

RESOLVED that Fleet street have a descent of three quarters of an Inch in every ten feet from the East side of Market street to the West side of Ann street, and from the East side of Ann street an ascent of one Inch in every ten feet to the West side of Wolf street, & from the East side of Wolf street a descent of one Inch in every ten feet to the West side of Washington street.

ORANGE ALLEY

June 9th 1802.

RESOLVED that Orange Alley at the distance of one foot six inches below the top of the stone sill of Doctor Goodwin's Shopdoor have a regular descent each way to Gay and Holliday streets.

HOWARD STREET

June 29th 1802.

RESOLVED that Howard street from South side of Franklin street to the North side thereof have an ascent of one Inch and a half in every ten feet.

FRANKLIN STREET

RESOLVED that Franklin Street from the East Gutter of Howard street have an ascent of ten inches in ten feet for the distance of sixteen feet & a half, thence with a descent of one Inch & a quarter in ten feet to Lawe's alley.

DUGAN'S WHARF

July 6th, 1802.

RESOLVED, that Dugan's Wharf have an ascent of one inch in ten feet, for the distance of Sixty feet from the Northeast corner of George Schaeffer's Brickhouse & from thence on a level to the Southeast corner of William Murphy's Warehouse & an even regular descent from the foot pavement the whole distance to the Dock.

KING GEORGE STREET

October 4th 1802.

WHEREAS the whole of proprietors of lots situated on King George Street, between Exeter & Harford Streets by their petition bearing date the 1st day of July last have requested that the Grade heretofore fixed by the special Commissioners for Said King George street be made null & void as it cannot be conveniently carried into effect, & have requested that the same may be graded in such manner as this Board may think fit. —

We therefore judging the said Petition to be reasonable, therefore. —

RESOLVED, that King George Street have an ascent of one inch and a quarter of an Inch in every ten feet from the East side of Exeter street to the East side of Loyd street, thence with a descent of one inch in every ten feet to the West side of Harford Street.

HIGH & GRANBY STREETS

October the 18th, 1802.

RESOLVED that High street from the South side of Baltimore street extended & Granby street have a regular descent from the south side of Baltimore Street extended as aforesaid to the North side of King George Street.

NORTH STREET

November 1st. 1802.

RESOLVED, that North street have a regular descent from the south side of Sarratoga Street to the North side of Waggon alley, thence continuing to the North side of Lexington street, thence from the South side of Lexington street to the North side of Dutch alley, then from the south side of Dutch alley to have an ascent of one inch in every ten feet to the distance of ninety feet, thence to descend with a regular Grade to the North side of Fayette street.

MARKET STREET FELLS POINT

RESOLVED that Market Street Fells' point have an ascent of one Inch and a half in every ten feet from the North side of Fleet Street to the South side of Wilkes street.

HIGH STREET

April 19th, 1803.

RESOLVED, that High Street from the North West Gutter of Pitt street or Wapping street have an ascent of one inch and a quarter in ten feet, from thirty six Inches below the top of the sill of the East door of Amos Underhills Brick house, to the bend in High street, thence a descent of one inch and a quarter in ten feet to the south east side of Low Street, then from the North west side of Low Street a regular ascent to the South East side of Bridge Street fourteen inches above the present Gutter of Bridge Street; and that High Street have a regular ascent from the South east side of Pitt or Wapping Street to the Northwest side of Baltimore street extended fourteen inches above the present gutter.

CONWAY STREET

Baltimore 11th march 1803.

RESOLVED, that said Street have an even regular ascent from the West gutter of Hanover street to the East side of Sharp street to the height of two feet four inches below the level of the upper part of the Stone work of the German Church on Conway street.

GUILFORD STREET

March 28th 1803.

RESOLVED, that said Street have an ascent of one inch and a half in every ten feet from the West side of South Street to the centre of the door of the dwelling house of David Armour on said Street & from thence an even regular descent to Franklin lane.

LIBERTY & HOWARD STREETS

April 5th 1803.

RESOLVED that the North west Gutter of Liberty Street from the North side of Lombard Street have a descent of one Inch in every ten feet to the East gutter of Howard Street, & that Howard Street have a regular descent of the North Gutter of Pratt Street to two feet nine inches below the level of the water table of — Shanes house on Howard and Pratt Streets.

PRATT STREET

RESOLVED that Pratt Street have an ascent of two inches and a half in every ten feet from the West Gutter of Howard Street to the East side of Eutaw Street.

EUTAW STREET

RESOLVED that Eutaw Street have a regular ascent from the North Gutter of Pratt Street to the South side of Lombard Street.

FOREST STREET

April 14th 1803.

RESOLVED that the North East side of Forest Street at its intersection with the outline of the City be twenty inches above the top of the present stone pavement crossing the York road leading through the Canal to Jones's Falls, then to have a Descent of two inches in every ten feet to the North West Gutter of North street & the Gutter to be so formed as to carry the Water down North street.

CHARLES STREET

July 19th, 1803.

RESOLVED that the west Gutter of Charles Street at the intersection of the North Gutter of North West street be eight feet four inches below the level of the top of the stone work of John Cockey's brick house now occupied by Jehu Bouldin, and that Charles street, from said intersection have an ascent of three inches and a half inch in every ten feet to the Outline of the city.

PITT STREET

September 12th, 1803.

RESOLVED, that said street have an ascent of three inches and a quarter in every ten feet from the East Gutter of High street to the West side of Green street, thence with an ascent of four Inches and a half in every ten feet to the distance of one hundred and forty feet east from the east side of milk lane.

FIFTEEN FEET ALLEY

Sep. 17th 1803.

RESOLVED that said alley have an even grade from Franklin Street to Mulberry street to intersect a grade of Mulberry street at three inches & three quarters of an Inch in every ten feet ascent from West Gutter of Howard Street.

TEMPLE STREET

Octo. 18th 1803.

RESOLVED that Temple Street have an ascent of one inch & a half in every ten feet to the South West corner of John Britten's Brickhouse from the Northside of Baltimore Street extended, thence an even regular descent to Pitt Street.

SHARP STREET

Nov. 9th 1803.

WHEREAS the Special Commissioners of Baltimore by their resolve of the 10th day of April 1787 Did establish and fix the grade of Lombard Street with an ascent of about six inches in ten feet to Sharp Street and further, that on the first day of April 1793, the said Special Commissioners did fix and establish Sharp Street to have an ascent of four inches & three quarters in ten feet to Lombard street & from thence to have a descent to Baltimore street.

And Whereas it appears that the aforesaid Grades are such as cannot be carried into execution there not being sufficient descent upon the least possible fall to carry the water on Sharp street from its intersection with Lombard street

The Board considering themselves only bound to carry into effect such acts of their Predecessors as are practicable, therefore, after mature deliberation—

RESOLVE that Sharp Street have an ascent of two inches from the South side to the North side of Lombard street, thence to have a regular descent to three feet three inches below the top of the sill of the North Door of St. Peter's Church on the South side of German Lane.

FOREST STREET

RESOLVED, that said street have an even ascent from the North side of German street & German lane to Baltimore Street.

GERMAN LANE

RESOLVED that said lane have a regular Descent from Forest to Hanover Street.

EUTAW STREET

Balti. 7th May 1804.

RESOLVED, that Eutaw Street have a descent of one Inch in ten feet from the South gutter of Pratt street to the North gutter of Camden Street.

YORK STREET

April 30th 1804.

RESOLVED that York Street have an ascent of one inch in ten feet from the East gutter of Granby Street to the centre of the square between that & Exeter Street and from thence a descent of one inch in ten feet to the Sewer in Harford Street.

QUEEN STREET

May 28th 1804.

RESOLVED that Queen street have an ascent of one inch & a half in ten feet from Granby street to Exeter Street.

FRONT STREET

RESOLVED that Front street have a regular descent from Bridge Street to Low Street.

SHARP STREET

Sep. 10th 1804.

RESOLVED that Sharp Street have an even regular ascent from the South side of Camden Street to the North side of Conway street & from the South side of Conway street an ascent of one inch in ten feet to the centre of Homespun alley & from thence a descent of one Inch in ten feet to the Northside of Barre Street & from the South side of Barre Street a descent of one inch & a quarter in ten feet to the North side of Lee Street.

SARATAGO STREET

22d. Nov. 1804.

RESOLVED, that Saratago Street have an even regular ascent from Howard Street to Eutaw Street.

EUTAW STREET

Baltimore 15th April 1805.

RESOLVED that the west gutter of Eutaw Street between Saratoga & Baltimore Street be six inches higher than the east gutter thereof, & that the crown of said Street between Saratoga & Baltimore Streets be extended six feet west beyond the centre thereof.

QUEEN STREET

23d. April 1805.

RESOLVED that Queen Street have a descent of one inch & a half in every ten feet from the west side of Albemare Street to the centre of Columbia street and from thence a regular ascent to the bridge.

NORTH STREET

20th May 1805.

RESOLVED that North Street have a descent of two inches in every ten feet from the Northeast gutter of Forest Street

to the Southwest gutter of Union Street and from thence a descent of one inch and one quarter in every ten feet to the Northeast gutter of High Street.

HIGH STREET

RESOLVED, that High street have an ascent of one inch in every ten feet from Bridge street until it intersects an ascent of one inch in every ten feet from the Southeast gutter of North street & from North street one inch descent in every ten feet to the outline of the city.

FISH MARKET SPACE

Baltimore 22d March 1805.

RESOLVED that Fish Market Space have a descent of one inch in every ten feet from the gutter at the intersection of the Fish Market & Market space at Caleb Hanna's to the line of the Falls.

EAST STREET, UNION STREET & GREEN STREET

27th May, 1805.

RESOLVED that East street, Union Street and Green Street have an ascent of one inch in every ten feet from Bridge Street until it intersects an ascent of one inch in every ten feet from North Street.

WAPPING STREET

June 19th 1805.

RESOLVED that Wapping Street from High street to the Southwest side of Front street have a grade of one inch & three quarters of an inch in every ten feet descent, which is intended to strike fourteen inches below the top of the Stone foundation of I. Balderson's house at the corner of Wapping & Front Streets & from thence to have a grade of four inches & a quarter in every ten feet descent to Jones's Falls corresponding to the height of two feet six inches above the wharf generally termed Andrew's wharf.

PRIMROSE ALLEY

BALTO., 2d July 1805.

RESOLVED, that Primrose Alley from the West gutter of Light street, have an ascent of three inches & three quarters of an inch in every ten feet to the west side of Richard Russells brick House & from thence a regular ascent to the East side of Charles Street.

MARKET STREET FELL'S POINT

July 12th. 1805.

RESOLVED that Market Street from George Street to the end of the present County Wharf have a descent of one Inch & one eighth of an inch in every ten feet.

HOWARD STREET

18th July 1805.

The owners of property on that part of Howard Street between Baltimore & Lexington Street, having Petitioned to have the said Street raised & the footways extended agreeably to a supplement of an Ordinance for extending footways, dated 20th March 1805—

RESOLVED, that the stone pavement from the southside of Cowpen Alley to the Kirbstones that are already fixed in Howard Street near Lexington street be raised, & that the grade thereof be altered from its present situation as follows—

That is to say, that Howard street from the South side of Cowpen alley, have an ascent of one inch in every ten feet to the North side of Fayette Street and from thence a regular descent to the Kirb stones already fixed as above mentioned.

WOLFE STREET

Balt. 12. August 1805.

RESOLVED that Wolfe Street from the North gutter of George Street to the North side of said street have an ascent of seven inches & from thence a regular descent to the South gutter of Lancaster Street.

RESOLVED, that Wolfe Street from the North gutter of Pitt Street have an ascent of one inch in every ten feet until an elevation is obtained that will take one inch descent in

every ten feet to carry it to the south side of George street & from the aforesaid elevation with a descent of one inch in every ten feet to the south side of George Street as aforesaid.

CHARLES STREET*

Charles Street grade altered at the solicitation of the proprietors of Lots in said Street, see the proceedings of the City Commissioners.

Baltimore 13th August 1805.

RESOLVED that Charles Street from the present pavement in Chatham Street have an ascent of seven inches & a quarter or thereabouts in every ten feet to the South side of Conowago street to a point three feet seven inches below the level of the top of a stone marked *R. S.* standing at the corner of Richardson Stewart's Nail Manufactory, thence to have an ascent of four inches in every ten feet until it intersects a grade of three inches & a half ascent in every ten feet from the intersection of Charles & Northwest Streets.

ST. PAUL'S LANE

grade altered at the request of the proprietors

16th August 1805.

RESOLVED that the grade of St. Paul's Lane from a Pump standing on the east side thereof near Thomas Hollinsworth's brick house be altered from the present grade & that the same have a descent of two inches & a half or thereabouts in every ten feet to the intersection of the West gutter of said Lane & the south gutter of new Church street, there to meet a point eight feet seven inches below the level of the top of the Water table of William Lorman's brick house standing on the west side of St. Paul's Lane.

NEW CHURCH STREET

RESOLVED, that New Church street from Charles street have an ascent of three inches in every ten feet, until a elevation is obtained from which by having a regular descent passing a point four feet six inches below the level of the stone sill of the door of Robert Walsh's Brickhouse on New Church Street it will strike a point at the intersection of the South

gutter of New Church street and the West gutter of St. Paul's Lane eight feet seven inches below the level of the top of the water table of the William Lorman's brick house on the West side of St. Paul's Lane.
