

Kent County Levy FOR 1884.

Annual Levy List for Kent County, Maryland, for the year 1884, levied by the County Commissioners at July Session 1883, and published by their order, in accordance with the provisions of the Public Laws, which provide that the County Commissioners shall cause to be published annually in at least two newspapers published in their respective counties, if there be two, a detailed, minute and accurate statement of the expenses of their said counties, specifying therein each particular item of expense, and for what and to whom paid; and shall deliver to the sheriff of their respective counties as many copies of such statements as there are election districts in the county at least ten days before each general election; and the sheriff shall within six days after the receipt of such copies, set up one of them at the place of holding elections in each election district, and the clerk to the county commissioners and the sheriff who shall perform the duty imposed by this section shall each forthwith the sum of one hundred dollars.
