

it will set up controls for the protection of City property in the Stadium against vandalism. He said that his Department would cooperate fully with the City police in these matters.

On the question of marking the field and the laying of the tarpaulin, the President said that it was the responsibility of the Park Board to keep the field presentable at all times to the best of its ability.

Commenting about the possible damage to temporary boxes, Commissioner Hammerman said it should not be too difficult for the police to protect these temporary installations.

Mr. Ditman suggested that the schools get their own M.P.'s. to aid the police in their work at the Stadium.

Mr. Thomsen stated that a plan of this nature was being considered by the School Board.

Capt. Taylor agreed to remove the ramp which leads into Sections "K" and "L" on the west side after each Navy game if this would interfere with the football games held by the Professional Football Club.

It was brought out that the Navy owns the bleacher stands which are used only during the Navy-Notre Dame game, and that since this game would not be played in Baltimore in 1947 the bleacher stands would therefore present no problem.
