LIGHT YOUR HOME BY ELECTRICITY.
A Cheap and Powerful Battery Which is
to Do Away With Dynamos.

The use of electricity for lighting houses, factories and stores has depended almost entirely on the dynamo. It costs a great deal to put in a boiler, an engine and the dynamo, and after the machinery has been put in place a large item of expense is the cost of hiring a man to attend to them. A young Englishman, of Brooklyn, James H. Moon, has recently invented a battery, and says that a dynamo will be needed any longer in order to have one's home lighted by electricity. He has patented the battery, and has a plan on a pretty large scale. Part of the battery has been partitioned off so as to form a large dark room. Suspended from the ceiling and sticking out from the sides of this room are various kinds of electric lamp fixtures, connected by wires with a battery outside the room, in another part of the loft.

This battery includes the chief feature of Mr. Moon's invention. There are seven stone plates just like those in which housewives keep pickles. The capacity of each is four gallons. In each is placed a set of zinc and carbon plates which are used ordinarily in batteries. The feature of the solution in which the plates are immersed. It is thought proper to publish in connection with this notice the substance of the provisions of the law, which bear particularly upon the rights of the citizen and the powers and duties of the Registrar.

Section 3. And he is empowered, that each of the said officers of registration shall have in addition to the other powers conferred upon him by this Act or which may be hereafter conferred upon him by law,
