What are listed as the degenerative diseases—usually occurring in middle age, or in the older age groupswere responsible for 12,110 deaths or over half of the total, an increase of more than 200 over the total for the same causes in 1936. The deaths in this group for the two years were as follows: Heart disease, 5,268 in 1937 and 5,069 in 1936; nephritis, 2,328 in 1937 and 2,364 in 1936; cancer, 2,257 in 1937 and 2,149 in 1936; cerebral hemorrhage, 1,815 in 1937 and 1,839 in 1936; diabetes, 442 in 1937 and 459 in 1936.

Deaths from typhoid fever rose from 27 in 1936, to 31 in 1937. There were more deaths from influenza-291 in comparison with 209 in 1936 but there were decreases in pneumonia, tuberculosis and diphtheria. There were 1,827 deaths from pneumonia, 1,426 from tuberculosis, and 25 from diphtheria in 1936.
