The willingness to do, at times when excitement is high is not by any means the solution of the present defense problems. It is the willingness to take a routine job, that in many cases is without glory or color, and stick to it at the sacrifice of time and convenience, that will count and help bring about a victorious end.

"The first shock of war has passed. The unprovoked 'hit and run' attack followed by Japan's declaration of open hostility was immediately answered, as might have been expected, by America's unanimous resolution to defend on all fronts and in all possible ways the ideals of liberty and democracy for which this nation stands.

"We are now settling down calmly and grimly to the long task ahead. It will not be brief and it will not be easy. It will be a burden of labor not unmixed with sorrow until that blessed day comes when an armistice is sought by our defeated enemy and our problems suddenly become those of reconstruction under the terms of victorious peace.

"Because the burden is great and because the struggle will not be brief, we are being cautioned by our leaders to avoid hysterics, to think clearly, to give no credence to unsupported rumors, to act promptly when called upon by those in authority, to avoid embarrassing our leaders with shoutings that we know a better way to operate than do those in whose hands authority has been placed; in short, to do all our usual daily tasks with a calmness, a determination, and an efficiency which will make us able to assume the huge added burdens brought by the emergency with a certainty that both the usual and the unusual will be successfully handled.

"This does not mean 'business as usual' and nothing more. Business as usual is impossible in wartime; but it does mean all our ordinary jobs plus the great inevitable addition which war has placed upon us.

"America is strong enough to do it because her citizens individually are capable of carrying this load. Racing an engine does not increase the pulling power of the car. It is the steady, solid application of power, not jerky or spasmodic, which carries the heavier load up the longer hill.

"This must be the American way and in this every individual in the total population of America's many millions can daily and hourly contribute. In this then let us all be calm, determined, efficient, and finally victorious."

There is plenty to do even if bombs have not already dropped in Kent County. An example of being thoroughly organized before things actually happen is the activity of the seven listening posts in this County. Last fall, before there was evidence of our being in the war any time soon, a seven day test period was held for the aircraft spotter stations. The result was that last week, when General McConnell, of Mitchell Field, ordered all posts manned 24 hours a day, they went into action immediately and today are located in small heated houses in various parts of the county and all planes passing over this county are reported immediately. This is just one branch of civilian defense but it is an example of the efficiency that can be accomplished by civilian volunteers.

This week the C & P Telephone Company, in an advertisement, is requesting its patrons to refrain from making long distance calls except where necessary. This reverse in business procedure is due to the need of long distance lines for governmental and defense messages. This possible sacrifice of business in order to assure communications for the armed and civilian defense is to be admired.
