HUSBAND OF MURDERED WOMAN FILES SUIT

William L. Fisher, husband of Mrs. Emily V. Fisher, victim in the Perryville "gossip slaying," asks \$20,000 damages from Mrs. Rachel Gillespie, in a suit filed in Circuit Court at Elkton.

Mrs. Gillespie was convicted of manslaughter in Mrs. Fisher's death and sentenced to four years in the House of Correction. Frederick Lee Cobourn, counsel for Fisher, filed the suit. Cobourn is a brother of State Senator Harold E. Cobourn, counsel for Mrs. Gillespie.

The bill of particulars alleged that Mrs. Fisher's "wrongful killing" deprived Fisher of "the support and pecuniary benefit and advantages provided for him by the said Emily V. Fisher."

Mrs. Gillespie was accused of shooting Mrs. Fisher March 28, 1936, after she had heard gossip concerning her husband, Walter Gillespie, and Mrs. Fisher.

State Senator Harold Cobourn, counsel for Mrs. Rachel Gillespie, has abandoned plans to seek a new trial for her in the shooting of Mrs. Emily Fisher.

WORLD'S GREATEST AUTO RACING DRIVERS AT LANGHORNE

Langhorne, Pa., June 18.—More than 50 of the world's greatest automobile racing drivers are arrayed here for the carnival of super-speed to be presented by Ralph A. Hankinson next Sunday afternoon at Langhorne Speedway after track and weather conditions made the running of the events impossible on the original date, Sunday, June 14.

These drivers, headed by such noted ones as Lou Meyer, Wild Bill Cummings, Ted Horn, Doc Mackenzie, Mauri Rose, Rex Mays, Babe Stapp, Joel Thorne, Chester Gardner, George Connor, Russ Snowberger, Zeke Meyer and Wilbur Shaw, are ready to assault Father Time on the world's fastest circular mile speedway.

At the present moment, Mackenzie holds the track record of 36 seconds for one qualifying lap, exactly 100 miles per hour, and those whose voices carry authority claim this mark is virtually certain to fall before the firing ceases.

Eighteen cars will start in the 100-mile grind, these to be determined by three five-mile elimination heats. Time trials will start at 12:30 p. m. Sunday, daylight time, with the first competitive event scheduled to begin at 2:30 o'clock.

WARNING

DEATH FROM SPOTTED FEVER
One death from Rocky Mountain Spotted Fever, sometimes called Spotted Fever or Tick-Bite Fever, occurred in the county on Friday, June 12th. Rocky Mountain Spotted Fever is caused from the bite of an infected tick and the State Department issues the following precautions and the Health Department hopes that the people of the county will heed these warnings:

1. Avoid ticks. Be particularly careful when walking along trails through the woods.
2. Remove ticks when found on the person or on animals, as speedily as possible, but take great care in doing so, that the ticks are not crushed between the fingers. If the insect is already embedded in the flesh, use forceps or tweezers. A slight break in the skin will serve as a portal of entry for the infectious virus.
3. Cut out undergrowth and weeds; cut grass very short around dwellings, along paths, near bathing pools and shores. Remove or burn debris.
4. Wear suitable clothing in going through tick-infested areas.
5. On hikes or camping trips, or in heavily tick-infested areas, both clothing and body should be carefully inspected, at least twice daily, but especially on retiring.
6. Since tick-infested dogs are potential carriers of the infection, it is not only important that dogs be kept free from ticks, as advised in item 2, but care should also be taken to prevent dogs, from sections in which the disease has appeared, from roaming at large and from invading other counties. Persons who take their dogs from one section to another, should be especially careful to see that their dogs are free from ticks.

The ticks that carry the infection responsible for "Tick-Bite Fever" are particularly active in the early spring. Fortunately not all ticks are infected, but it is better to regard them all as potentially dangerous, disease-bearing insects and to act accordingly.

WARRANT ISSUED FOR BEER DISTRIBUTOR

The first warrant for a violation of the new beer tax law was issued Tuesday against A. Fabrizio, of Havre de Grace. It charges Fabrizio, who operates the West Side Distributing Company, with bringing into the State beer on which the State tax had not been paid.

A truck and 250 cases of beer consigned to Fabrizio was seized at his warehouse. John W. Frist, of Colora, driver of the truck, said he brought the beer from a Philadelphia brewery. His truck was held as security for his appearance as a State witness.

The new beer tax of 6 cents per case went into effect on April 1, with the proviso that after June 15 caps showing that the tax had been paid should be affixed to the beer bottles at the brewery. These caps are se-
