

### Automobile Drivers Are Required To Reregister

#### New Law Sets December 31st As Deadline For Registration

Maryland automobile drivers are sending in their applications for new drivers' licenses in accord with the provisions of the re-registration act passed at the last regular session of the State Legislature, at the rate of between 2,500 and 3,000 a day.

According to Harry Bullen, supervisor of registration, the most common mistake made in filling in the renewal applications is the omission of the required witness' signature. This, he said, is necessary before new drivers' cards can be issued. Many people, the supervisor added, send in the wrong amount of money. He stressed the fact that no notary fee is required, \$1 being the total expense. He also stated that many people appeared to be in doubt as to how to answer the question about traffic violation convictions. Inasmuch as there is no room on the blank to record more than one violation, applicants may simply write, "See record your office." Parking, he added, does not constitute a traffic violation.

Some trouble with illiterates has been experienced. The supervisor said the office clerks had to help large numbers of them to fill out their forms.

The deadline for applications is the last day of this year. Failure to apply for a new license before December 31, will make it necessary for late applicants to take a new driving test—something not required in the registration—and to pay the full license fee of \$3.50.

Numbering the present driving cards began in 1910. Since that time there has been no registration, and Mr. Bullen said it was impossible to know the exact number of unused cards still carried on the books. He added that many motor vehicle operators had changed their addresses and a number of times without changing their license cards. Considerable inconvenience has been experienced by the motor vehicle authorities as a result.

#### NINETY-ONE YEARS YOUNG

Walking from his home to King Street Market, Wilmington, and return, or making an average of three miles a day is not unusual for Jesse J. Tyson, who observed his ninety-first birthday anniversary on Tuesday. Mr. Tyson lives with a daughter, Mrs. Walter L. Turner, 1207 West Ninth Street, in that city.

Mr. Tyson's family consists of Mrs. Turner; four other children, Mrs. Mary E. Sayers, Martin Jesse J. Jr., and William E. D. Tyson, sixteen grandchildren and six great grandchildren. He has a sister, Mrs. Emma Mooney, who lives in Atlantic City.

Mr. Tyson is best known as having conducted a horse bazaar for many years. At one time his sales stable was on West Street, where the duPont Building now stands. Later he moved to Fourth and Walnut streets, then went to Philadelphia. He still prefers horses to automobiles.

He was born at Rising Sun, Md., July 20, 1846, a son of the late Israel Isaac and Hannah Ann Smith Tyson. The family moved to Lancaster county in 1861.

On July 20, 1861, Mr. Tyson began carrying mail on horseback on a 38 mile rural route. He continued carrying mail until after the Battle of Gettysburg, when his father compelled him to give up the route because many soldiers traveled through the vicinity. A part of his route was through a dense woods where it was said escaping slaves were concealed. After giving up his job as a mail carrier, he worked for a time in his father's feed and flour mill.

In 1882 Mr. Tyson came to Wilmington and in 1884 opened a sales stable. Later he entered the hauling business. He turned this business over to his sons about 15 years ago. The business was then known as it is today as the Tyson Transfer. Mr. Tyson still delights in walking each day and declares he would rather drive a horse and buggy any time than ride in an automobile. Sunday he still walks to Asbury M. E. Church when the weather is fair.

#### MRS. EMMA WILLES

Mrs. Emma Willes died at the home of her sister, Mrs. Dorsey Dunlap, at Glen Burnie, Md., after an illness of several months. Besides her sister, she is survived by two daughters, Mrs. Mary Stephens, of Glen Burnie, and Mrs. Thomas, of Ardmore, Pa. Mrs. Willes had spent most of her life in Chesapeake City, where she had taught in the Chesapeake City school. Service and interment were at Bethel cemetery.

Benjamin W. Sidwell died at his home in Chester, Pa., July 5. Funeral the following Wednesday, interment in Longcroft cemetery. Mr. Sidwell was a native of West Nottingham township, near Fremont. He was in his 77th year. Four children survive in Chester and Newark, Del., and one sister, Mrs. John T. Holland, East Nottingham.

#### MRS. EVA KOBBS

The funeral of Mrs. Eva Kobb, 55 years old, wife of the Rev. George Kobb, of Perryville, a Free Methodist preacher, was held from her late home Thursday, the Rev. Dr. Treadway, of Salisbury, Md., and the Rev. W. F. Hopkins, of Elkton, officiating. Interment was in Union cemetery, near Leeds. Mrs. Kobb had been ill for ten weeks.

Before her marriage she was Miss Eva Smith of Pleasant Hill. Besides her husband she is survived by two sons, Harold, of West Virginia, and Raymond at home. She is also survived by her mother and five brothers.

#### T. EUGENE CONNER

T. Eugene Conner, aged 63 years, a former resident of Rising Sun, died suddenly at his home near Oxford, Pa., on Wednesday last. He was a son of the late Caleb and Charlotte Lee Conner, his father conducting a creamery business here for a number of years.

Funeral services were held Saturday afternoon, and interment made in Oxford cemetery.

Surviving at his wife, Malinda Wilson Conner, and these children: Leora, wife of James Purcell, Oxford, and Eugene and Roberta, at home; also one grandchild and a brother, S. Lee Conner.

#### EDWIN KINCAID

Edwin Kincaid died in Sydenham Hospital, Baltimore, on Monday afternoon from spinal meningitis. He was taken to the hospital Saturday morning after having become suddenly ill the day before.

The deceased was a son of Mr. and Mrs. Charles Kincaid, who reside on the Mrs. Ellis Duyckinck farm, near Calvert. He was 37 years of age, and was born near Colora, in which section most of his life had been spent. For two years past he had been employed in Baltimore. His death was the first break in a family of twelve children. He is survived by his wife; also his parents, four brothers and seven sisters, all of whom are living at home.

Services were held Wednesday afternoon at the Tyson funeral home, in Rising Sun, and interment made in West Nottingham Presbyterian cemetery.

#### JOHN T. WHALEN

John T. Whalen, aged 78 years, retired hotel operator, died July 10, at his home in Havre de Grace. He was a native of Port Deposit, but most of his life was spent in Havre de Grace. His wife, Mrs. Mary Regina Sitzer Whalen, died about eighteen years ago from injuries received in an auto accident.

In his early life Mr. Whalen learned the moulder's trade and for some years was employed in the stove foundry of the B. C. Bibb Company, Port Deposit, and Armstrong Stove and Manufacturing Company of Perryville. Later he went to Havre de Grace and until the advent of prohibition conducted the Farmers Hotel.

During the prohibition era he conducted a men's store at the site of the hotel and for the past few years had lived a retired life. Interment was made in Mt. Erin cemetery.

#### WINTER L. WILSON

Winter Lincoln Wilson, 70, Bethlehem, Pa., well-known railroad engineer and former professor at Lehigh University, died Wednesday in a hospital at Sandy Springs, Md., after a nervous breakdown several weeks ago.

Mr. Wilson gained recognition for the part he took in surveying for the intercontinental railroad between Ecuador and Peru and in helping to settle a boundary dispute between Guatemala and Mexico.

Born in Elkton, he was graduated from Lehigh in 1888, and shortly afterward began his work in South America.

He taught at Tulane University, in New Orleans, from 1901 to 1907, returning to Lehigh to become professor of railroad engineering. He retired three years ago.

The deceased spent his early life on a farm about a mile east of Elkton. He was the eldest son of the late John Emory Wilson, for many years a member of the Elkton bar. He was twice married. Two sons survive him, also several brothers and sister.

The remains were brought to Elkton Monday afternoon, with services at 2 o'clock. Interment in the family lot in Elkton cemetery.

### Highway Accidents Increase In State

#### Chairman Of Motor Vehicle Commission Urges Motorists To Use Caution

Highway accidents in Maryland took a toll of fifty-one lives in June, bringing the fatality list for six months to 265, an increase of 35 1/2 per cent over the same period of 1936.

In Cecil County, four deaths were recorded for June as against one for the same month last year. For the first six months of this year, fifteen persons have lost their lives in motor accidents on Cecil County highways as compared to five during the corresponding period of last year.

Walter R. Rudy, commissioner of motor vehicles, said, the fifty-one deaths in June were one more than in June of a year ago. Only one month, April, has had fewer fatalities than in the same month of 1936.

Commissioner Rudy, in announcing the motor fatality report for last month said:

"During the next few months nearly every automobile that can be operated will be using the roads of this State in search of relaxation and pleasure."

"Therefore, I call upon every motorist to use the utmost caution in the operation of his car to help decrease this ever-mounting toll of accidents, which result in the death of some pedestrians, passengers and often the drivers themselves."

Of the fifty-one persons killed in June, seventeen were pedestrians, twenty-one passengers of vehicles involved in accidents, and thirteen drivers. Of the 59 machines involved, forty-one were passenger automobiles and fifteen trucks.

Ten persons died in accidents in Baltimore city. Baltimore county had seven fatalities; Howard and Prince George's counties, six each. Counties having no highway deaths were Anne Arundel, Caroline, Calvert, Carroll, Frederick, Garrett and Kent.

The fatalities for the other counties were: Cecil four; Dorchester, Montgomery and Wicomico, three each; Allegany, Charles, Harford, Queen Anne's, St. Mary's, Somerset, Talbot, Washington and Worcester, one each.

Speeding was given as the major cause of the accidents. The report said twenty-nine drivers were operating their machines too fast for conditions. Two did not have the right of way, two were on the wrong side of the road, two improper wide right turns, and one disregard to a stop signal.

#### CANTALOUPE SEASON AT HAND

The cantaloupe season in Maryland and adjoining Delaware counties is beginning with prospects of the biggest season in a great many years.

The cantaloupe industry is probably the largest fruit industry on the Delmarva Peninsula, not excepting the stawberry and peach industries. Some of the large cantaloupe centers are located at Federalsburg, Salisbury, Seaford, Laurel, Delmar and Bridgeville. Here the 'loupes are brought in daily by a steady stream of trucks and other vehicles and "knocked down" to the highest bidders, the farmers returning home with cash in their pockets.

While the bulk of the crop leaves the cantaloupe centers in trucks for northern and New England markets, thousands of carriers are shipped in refrigerator cars, specially to western cities. The industry has grown so large that state and government inspectors are located at all the leading centers to pass judgment on the melons as they pass under the auction blocks.

#### LOCUST TREES IN CELLAR

Since the cutting of the locust tree in front of the Pogue & Roberson lot, at the corner of Main and Walnut streets, in this town, and the laying of concrete about the newly-erected gas filling station, the roots of the tree have found their way under the store building adjoining the lot, and are sending up vigorous shoots through the cracks of the floor in the basement, in several places.

These shoots are already more than a foot in height, and some of them are sixty or more feet from where the parent tree stood.

#### MISS MARY MAHONEY

Miss Mary Mahoney, 79 years, died at her home on East High Street, Elkton, on Friday, after a 10 days illness. Miss Mahoney was a daughter of the late John and Caroline Mahoney of that town and the last surviving member of the family. The funeral was held from her home Sunday afternoon, with interment in Cherry Hill M. E. Cemetery.

### To Force The Removal Of Roadside Sign Boards

#### Attorney General Rules Forestry Group May Enforce Law Against Advertising

Usurping the authority of the State Forestry Department, the State Roads Commission has granted permits to advertisers to erect hundreds of signs along State rights of way, State Forester F. W. Besley charges.

Armed with an opinion from Attorney General Herbert R. O'Connor, defining the Forestry Department's powers, Mr. Besley said that he intended to force the advertisers to remove all the signs, under penalty of paying a \$10 fine for each one.

Mr. Besley said that the first he knew of the signs was when his men found them on the rights of way along State roads. After they had torn down about 100 of them, he said, the advertisers complained to the State Roads Commission for protection.

He then was informed by Paul Sutherland, of the State Roads Commission, he said, that permits to erect signs on the State rights of way had been granted to approximately a dozen advertisers, whose names were listed.

Denying the right of the State Roads Commission to grant such permits, Mr. Besley then called upon Mr. O'Connor for a definition of the jurisdictions of the two departments.

Mr. O'Connor's ruling states that Maryland statutes give the State Forestry Department the authority to enforce a law prohibiting the erection of signs, posters, advertisements, etc., within the limits of a public highway.

Amelia Earhart, America's greatest woman flier, is now listed as dead by the Navy. Search for her and her navigator, Frederick J. Noonan, carried on since they were forced down in the Pacific ocean July 2, was abandoned Monday.

The couple were lost on the New Guinea-Howland Island leg of their world-girdling flight. George Palmer Putnam, Miss Earhart's husband, refused comment as Admiral Orin G. Murfin, commander of the 14th naval district, announced the end of the greatest search the Navy ever conducted, and at a cost of \$4,000,000.

#### THE CAMBRIDGE STRIKE
