MARYLAND UNEMPLOYMENT CLAIMS

The last two calendar weeks of February brought a material reduction in the number of benefit claims received by the Maryland Unemployment Compensation Board, in sharp contrast with the month of January, which was marked by the large increase, due to seasonal causes.

Original claims received in the week ending February 24 numbered only 542, the smallest weekly figure since the close of December. The last recorded two week in February averaged 725 original claims, the preceding five weeks averaged 1160.

BATA SHOE COMPANY FILES SUIT

The Bata's Shoe Company has filed a suit in the Federal District Court in Washington, D. C., to prevent deportation of forty-five men and women who were brought to the plant at Belcamp, Harford county, as instructors. The complaint states that the company uses machinery not familiar to American workmen, and that the service of the forty-five instructors are necessary for the proper running of the factory.

Originally the company received permission from the Labor Department to employ one hundred foreign instructors, but later the company was advised that it would retain only ten instructors and fifteen other aliens in administrative capacities. The Department further ruled that the persons thus prevented from working at the plant would be deported if they were found to be still working.
