Club to sponsor tour to Annapolis in fall, date depending on convening of the Naval Academy for school year. 8. Film strip of Short Course to be shown. 9. Morning session to be conducted as in past with County Peace Chairman, Reading Chairman, Freshman, Short Course representative, Short Course president and club presidents reporting.

Eastern Shore Fair

To all Cecil Countians:

For sometime past the Maryland State Fair Board has been anxious to develop an annual agricultural fair on the Eastern Shore. Funds where available provided a group of men could be found to organize and promote an Eastern Shore Fair. They received \$5000.00 from the State Board for premium awards, raising the money to cover the expenses, and promised to see what could be done to set up the Fair on a permanent basis.

The 1939 Eastern Shore Fair was held and was a great success. The State Fair Board was so well pleased that it has now allotted \$7,000 as premium money for a 1940 fair. And we are again faced with the problem of supplying some permanent supporting organization.

With these facts in view it has been decided to set up an Eastern Shore Agricultural Society for the promotion of the Eastern Shore Fair and for the benefit of a better agriculture on the Shore.

This Society shall not in any way detract from the work carried on by local state or national organizations, but shall in every possible way encourage and assist them.

You are invited to attend a meeting for the purpose of discussing Cecil County's part in the permanent organization. Five of Shore county have already held such meetings and endorsed the proposed plan as tentatively drawn up by last year's Executive Committee for the Eastern Shore Fair. This plan will be fully explained and discussed at the Cecil County meeting.

Please bring with you to the meeting anyone interested in the advancement of Eastern Shore agriculture.

NORTH EAST TOWN ELECTION

North East held quite an exciting town election, Monday, March 18, 1940, for the purpose of electing two Commissioners. There was great interest taken by all, as there were two men running who were in favor of "Water", Mr. George C. Rawson and Mr. Clayton B. Craig, and two against the issue, Mr. Arthur P. Harvey and Mr. Charles W. Grant.

Mr. Marion E. Rose, the President, and his Commissioners took extra precaution with this election by erecting booths in the town building, and conducting it on the same principle as our State and County elections, so that the election could not be contested, which seemed to please the voters intensely.

The results showed an overwhelming majority for the "Drys" as they were won by ratio greater than two to one. This plainly proves the sentiment of the voters, who turned out to cast their vote with all sincerity to save themselves from burdensome taxes which would be too great for them to stand.

The figures of the election were as follows: Mr. Harvey 276 votes, Mr. Grant 268 votes, Mr. Craig 112 votes, and Mr. Rawson 111 votes.
