Philadelphia, June 15, 1807.

His Britannic majesty's consul-general for the middle and southern states of America, having observed great inaccuracy in the manner of preparing quarantine manifests for goods shipped from hence, for the ports of Great-Britain, recommends to the merchants engaged in that trade a particular attention to the regulations heretofore published.

The quarantine manifests are to be proved affirmatively or negatively, as to the growth, produce or manufacture of the respective articles, before a magistrate, according to the forms prescribed and attested by his majesty's consul, or where there is no consul, by two known resident British merchants. These manifests are to be written in words at length, and in continuity, upon a separate paper, distinct from any documents from the customs, and totally unconnected with any invoice, bill of lading, certificate or notarial attestation whatsoever.

Appointment by the President of the United States.

JACOB B. CLEMENT, esq. of Gloucester County, New-Jersey, consul for the United States, for the Island of Porto Rico.

The Richmond Enquirer of the 13th, says "The court have been occupied during the last three days on the motion to obtain a subpoena duces tecum, addressed to the president of the United States."

The arrival of gen. Wilkinson at Richmond is very fortunate, as the debate on the above motion for procuring certain papers had become very animated, and the parties evinced a high degree of warmth. Mr. Martin in contending for their right to these papers, exerted all his powers on behalf of "his persecuted friend." He said, "This is a peculiar case, sir. The president has undertaken to prejudice my client by declaring that 'of his guilt there can be no doubt.' He has assumed to himself the knowledge of the Supreme Being himself, and pretended to search the heart of my highly respected friend. He has proclaimed him a traitor in the face of that country, which has rewarded him. He has let slip the dogs of war; the hell-hounds of persecution to hunt down my friend. And would this president of the United States, who has raised all this absurd clamor, pretend to keep back the papers which are wanted for this trial, where life itself is at stake? It is a sacred principle, that in all such cases, the accused has a right to all the evidence which is necessary for his defence. And whoever withholds this information, is substantially a murderer, and is so recorded in the registers of Heaven!"

No decision was had at the last report on this motion.

**GEN. WILKINSON AND SUITE.**—We congratulate our country on the arrival of this important character in our city. We rejoice at this event, much on his own account; but still more in relation to his country and to the cause of truth. We confidently trust, that the veil of mystery which has hitherto enshrouded so many of the transactions of the western country, is about to be rent in twain; and that every man concerned will be seen for what he is. The eyes of this country are fixed upon this interesting drama; and future times may rue or bless the catastrophe which awaits it. But whatever may be the consequence of this arduous trial, there is one great sentiment which every honest heart will re-echo. May mystery expire; may the light of truth beam upon us; and may justice be faithfully rendered to every man!

General Wilkinson arrived at Hampton Roads on Wednesday the 10th, in the U. S. schooner Ranger, from New-Orleans. On passing the frigate Chesapeake, lying in Hampton Roads, the Ranger fired a salute, which was returned by the frigate. On his arrival at Hampton, gen. Wilkinson had the precaution to dispatch immediately an express to the attorney for the U. S. in this city. He left Hampton at 4 o'clock on Wednesday, and arrived about the same hour on Thursday. The object of this dispatch was to communicate the general's arrival to Mr. Hay, and through him to the court; and thus to prevent a premature discharge of the grand jury.

Gen. Wilkinson arrived this morning in the stage from Hampton. He is accompanied by his son, lieut. Murray, and servant; lieut. Gains, lieut. Smith, and Mr. Graham and servant. Sergeant Dunbar, whose affidavit was lately put aside in court, and some other witnesses accompanied the general as far as Hampton, and came up in a pilot boat to this city.

G. W. left governor Claiborne at New-Orleans. Richmond Enquirer, June 13.] Gen Victor Leopold Berthier, chief of the first corps of the French army and one of the commanders of the Legion of Honor, died at Paris, on the 24th March, after a months illness.

On Thursday, the 4th instant, about 4 miles from the city of Schenectady, aside of the Mohawk turnpike, sitting under a tree, I discovered PERRUS GROOT, who was supposed to have been slain in the Oriskana battle, under general Herkimer, on the 6th of August, in the year 1777. I immediately recognised him, and on conversing with him he confessed himself to be the person I took him to be. I then carried him to

the nearest tavern, where I left him to be sent to his children and brothers; from whence, however, he departed before day the next morning, and was seen in Albany on Friday. His mental faculties are much impaired, supposed to have been occasioned by a wound of a tomahawk near the forehead of his head, though he is at most times tolerably rational. His head is bald; the circle or scar of the scalping-knife is plainly to be seen on it, and a stab on the side of his neck near his shoulder—Had a small scar near his ankle—is a middle-sized man—has blue eyes, a long countenance, and stoops much in the shoulder. He speaks English, French, Dutch and Indian; and says he has been last prisoner among the Indians north of Quebec—Had on an old dark grey coat and old brownish pantaloons—Has a large pack with him.—He refused to go home, as one of his former neighbors whom he saw would not recognize him, he was fearful his children and brothers would not. He said he would go to the governor's.—Being at times deranged, it is feared he will stray too far away for his friends to find him. He is of a very respectable family and connections. Any person who will take him up and bring him to the subscriber, at Schenectady, shall be well compensated for their care and trouble, and will receive the sincere thanks of his children and relatives, and be the means of relieving the poor unfortunate man from his distress, by restoring him to his family and friends. N. B. The printers in this and the neighboring states are requested to give the above a few insertions in their respective papers, to aid in restoring a poor sufferer to his children and relatives; who has been 30 years a prisoner among the Indians. He is now 63 years of age. He was a lieutenant in the militia at the time he was supposed to have been slain.

The number of persons migrating to this state during the last four weeks is estimated at two hundred souls per day. The streets of this town are frequently crowded with the carriages, carts and waggons of moving families. While the great demand for provisions has considerably raised the price. Corn, which was heretofore a drug at 25, is now scarce at 50 cents per bushel, and we are informed, that at some places on the road from this to Merco district, it is sold as high as a dollar and a half. A greater price is yet expected.

Banks of the Elbe, April 17.

The news of a British army coming into this river has excited the most sanguine expectations among all classes of inhabitants, and an equal degree of dismay among the Dutch troops, among whom a spirit of discontent and mutiny has lately prevailed, particularly the day before yesterday, when several detachments were marched from Hamburg, on the way to Lubeck, for the defence of that city, whose governor and garrison hourly feared to be attacked by a corps of victorious Swedes, of whom scouring parties of horse were seen near Bergedorf a few nights ago. On this account most of the Dutch at Hamburg were ordered to march to that little town situated half way between the former town and Lubeck. On this occasion many of the soldiers openly mutinied, swore they would throw away their arms and go over to the Swedes or the Prussians. The mutiny grew so serious, that some actually threw down their arms, and waving their hats high in the air, called aloud, "Long live the kings of Sweden and Prussia! We won't fight without pay! We won't fight against our friends!" It was found necessary to employ martial law against some of the rioters, who were sent off tied on waggons, and several of them have since that been tried by a council of war, and shot.

In different parts of Pomerania and the duchy of Mecklenburg, the Dutch threw down their arms at the approach of the Swedes, and surrendered themselves prisoners. Besides Rostock, the Swedes had also taken Prenzlau, at a small distance from Stettin, to which place 2000 Dutch troops had retreated from Mecklenburg. They were also masters of Uckerunde, Wollin, Usedom, &c.

All the news of an armistice between the belligerent powers of the continent, as well as the intelligence of negotiations for peace having been opened between France on the one part, and Russia and Prussia on the other, are idle tales.

London, April 25.

Finkenstein, whether the French headquarters have been removed, is 50 English miles further back than Osterode. No cause is assigned for the removal.

There appears to be some foundation for a rumor, which was circulated in the course of yesterday evening, and which this morning maintained its credit upon the exchange, namely, that Hamburg and dependencies had been evacuated by the French. The evacuation was unavoidable, from the mo-

ment the blockade of Stralsund was raised.

The following is a copy of a letter from Haque, dated the 17th instant, alluding to this, among other interesting topics:

"Although it is pretty generally acknowledged that the Dutch troops have sustained considerable loss before Stralsund, no official report of that affair has as yet appeared. It is said that only 12 men of one battalion remain; and that the park of artillery fell into the enemy's hands. The remains of the besieging army are now in the duchy of Mecklenburg. King Louis is much indisposed; it is said he is much affected at the reverses which our army has sustained.

Extract from the 69th Bulletin.

"The health of the emperor continues excellent; it is even remarked that it appears better than formerly. Some days his majesty makes excursions to the distance of forty miles on horseback. At Waraw it was last week believed, that the emperor had arrived there about ten o'clock at night—The whole town was immediately and voluntarily illuminated."

DEAL, April 23.

The French privateers begin to be very troublesome; two were over close in by Hythe the evening before last. Five British vessels have just been carried into Calais.
