A PROCLAMATION.

WHEREAS it hath been represented to me, on oath, that the Saw-Mill of James Carroll, esq. erected for the purpose of cutting Malogany, near the city of Baltimore, was, on the night of Monday, the eighth last, consumed by fire; and whereas it has been also represented that it is feared this villainy has been intentionally perpetrated by some wicked incendiary or incendiaries: And whereas application has been made to me to issue a Proclamation offering a pardon to any person, being an accomplice, who shall discover his or her associate or associates; I have therefore thought proper, in pursuance of the powers vested in me by law, to issue this my proclamation, thereby offering full and free pardon to any person, being an accomplice in the commission of the said crime, who shall discover the perpetrator or perpetrators thereof, so that they or any of them be brought to justice.
