FROM OUR CORRESPONDENT.

New-York, July 4.

"The ship Betsy, Lucas, 45 days from Liverpool. June 22, lat. 44. long. 65. spoke ship Latona, McCrea 7 days from N. York, for Liverpool. 24th. lat. 40. 54. long. 66, was overhauled by a British schooner. 20th, lat. 40. 20. long. 62. 45. spoke brig Harmony, Henry, from Boston, for Alexandria.

"The ship Brilliant, Gibbs, of New Bedford, 43 days from Cherbourg. [NO SE-COND BATTLE, but the armies were close together. Captain G. gave his latest papers to a British ship.] Left, May 22, ship in, to sail in a few days for New York; brig Eliza Haley, ready to sail for England; brig Commerce, of do. ready for Lisbon. May 24, 86 leagues west of Scilly, spoke ship Ann, Alexander, Snow, of New Bedford, 34 days from Leghorn for Copenhagen. 26th, lat. 49. 30. long. 11, spoke ship American Eagle, of New York, 4 days from Liverpool, for Wilmington; next day, the brig William, Waters, of New-York, 40 days from Charleston, for Rotterdam, with Dutch prisoners; same day, brig Sally, of Newport, 21 days from Baltimore, for Amsterdam; same day, ship William, 18 days from Baltimore, for Amsterdam, having on board the crew of the British brig Jason, which was wrecked in long. 52; same time, the William spoke an American ship, having on board the crew of the ship Liberty, of New Castle, wrecked the same time. June 17, lat. 48. long. 45. spoke brig Happy Couple, 9 days from Baltimore, for Bordeaux. 20th. lat. 32. long. 56. spoke the British ship George, from Cape Francis, for London. 27th, lat. 44. ship Stranger, of New-York, 47 days from Liverpool, for Nantucket.

"The British ship Brilliant, Barss, 10 days from Liverpool, N. S. The brig Hope was to sail in 5 days for New-York.

"The brig Lion, Cullum, 24 days from Montego Bay, Jamaica. Left, ship Fanny, Matthews; Ann Greenhill; Favorite, Mackle; Maria, Huzzy; Hiram, Gulin, all of N. York. June 19, was boarded by the Adamant, of 30 guns, and treated politely, she having two privateers, captured off Cuba. 30th, ship Bristol Packet, of Portsmouth, 24 hours from Philadelphia for Bordeaux. 29th, ship Piton, of Baltimore, 30 hours from Norfolk, for Amsterdam.

Venus, Hutchins, of Biddeford, just arrived; Ann and Eliza, of Providence, do.

"The schr. Eliza Sisson 16 days from P. Petre, Guadalupe. Sailed in co. brig Mary, for N. York. The ship Howard sailed the day before for do. Left ship Washington, German, for N. York in 10 days; brig Rising Sun; ship Eliza, for Norfolk; schr. Ceres, for Charleston; and Mercury for Boston. June 21, lat. 24. long. 67, was boarded by a Spanish brig from Cadiz for Porto-Rico.

"Cleared, ship Delaware, Thompson, Amsterdam; Hanover, Williams, Amsterdam; brig Fame, Veale, Leghorn, schr. Maria, Clark, Martinique; Jane Barnes, Wilson, St. Croix; Dreadnought, More, Halifax; Mary & Eliza, Sontag, Trinidad; Mariner, Gale, Curacao; brig Lovely Lass, Wheeler, Savannah.

"Extract from the log book of the Revenue Cutter Active. Monday June 29th, 1867. Cape Henry bearing South, distant about 2 leagues. At half past four, put the pilot on board of the pilot-boat. About this time a ship of the line, then about 2 leagues distant, fired a gun to bring us too; and at the same time manned one of her cutters armed with a swivel, and gave chase for three quarters of an hour, during which time they fired three times. Finding they could not come up with us, gave up the chase, being at that time about one mile and three quarters from us. At 5 P. M. saw a ship or some other vessel directly in our wake, until half past 10, having altered her course, as we altered ours; supposed to be a cruiser."

SPIRIT OF THE TIMES.

Since we issued our last number (Friday evening) the town has been full to overflowing, and the citizens not a little agitated, with rumors and reports. We are not insensible of the weight of these matters, nor will we ever appear slow to hand the dreadful word from our commander. But we will be permitted to suggest the propriety of doubting a little the veracity of *Rumor*, who

not infrequently asserts that which is utterly false. The following extract, taken from the coffee-house desk, is calculated to excite no small degree of alarm; it has nearly put a stop (momentary we are confident) to mercantile transactions. We hope the delusion will be of short duration. Although we cannot be supposed to doubt, for a moment, the veracity, or the good intention of capt. Decatur; nor can it be imagined that we are uninformed of the insolence and the barbarity of the commander of the Leopard; yet we would ask those acquainted with British policy and British history, whether they believe that an English naval officer dare assume the awful responsibility of declaring war? If the "British officers," as stated in the coffee-house letter, should declare war, and commence war operations by taking the Chesapeake, on receiving the president's proclamation, we will not hesitate to say, that such must have been the express instructions from their government; and we will most cordially join heart and hand in decisive measures against a people, thus lost to all sense of right, and who must then be denounced as the inhuman enemies of civilized man. But this, we do not anticipate; however a British officer may threaten and "look big;" however *Rumor*'s many tongues may distort facts, and freight with lies each coming breeze, still we are incredulous; we cannot yet believe that even those tyrants, against whom America so loudly, and with justice, complains, are the madmen represented.

We may be asked, has not the navy agent here received a draft from Norfolk for ammunition? We are well acquainted with the fact; we know that several thousand balls, 24's and 32's have been sent; and it is pleasing evidence of the spirit, the patriotism and the prudence of the people of Norfolk. Washington said—"to preserve peace, be prepared for war." Thus may the people of that place, even at the eleventh hour, prepare to meet the enemy; and possibly deter him from the attack.

We may be permitted to give an instance of the magnifying powers of *Rumor*. In the Norfolk Herald of the 2d it is stated, that "upwards of twelve thousand citizens attended the town meeting at Baltimore!" It was in consequence of no want of patriotism, that there were not 3,000 at that meeting.

A few days will dispel all doubt; for when the proclamation shall have reached Lynhaven Bay, the British squadron will sail: either from the waters of the Chesapeake, or at the fringe of that name. Possibly the schr. Revenge is waiting the result; as she was ready to receive her orders on Saturday.

Extract of a letter from Washington, dated Saturday night, 6th received: "A letter is this day received from capt. Decatur, (at Norfolk) stating that he had it from the most unquestionable authority, that the British officers have asserted positively that in case the president should issue a similar order to that issued respecting the Leander, they will consider it an act of hostility, and will commence hostilities immediately."

The French ship Patriot, commodore Klomro, is ordered up, and is expected off here in a few days. [Annapolis paper]

200 Dollars Reward. Whoever takes up said Negroes, and secures them in Baltimore jail, shall receive, if taken in the city, or within twenty miles thereof, fifty dollars, if a greater distance within the state, one hundred dollars, and if out of the state, the above reward, or in proportion for either of them.

To the Members of the Library Company of Baltimore. GENTLEMEN, It is now eleven years since the commencement of the Library Company of Baltimore; in its short period of time, a taste for useful reading, and polite literature, has silently spread among the young of both sexes. A profession so pleasing in its nature, and beneficial in its effects, which the institution has certainly accelerated, cannot fail of securing to it, a continuance of protection and patronage.

A Library, formed with a due respect to Religion, and morals, which does not exclude works of genius, and amusement, which contains the most esteemed writings of every country, and the best books on the different arts, and in every branch of science and literature to whose ample stores, all persons may have access at a trifling expense, must rank amongst the most useful, and laudable institutions in society.

To select a Library, in conformity with these principles, calls for the Union of different talents, and various information. It must however be recollected, that although with a limited annual sum, all valuable books cannot at once, be introduced, yet, that in time and successively, all of the greatest value, or importance, which can be procured, may find admission.

With such prospects, the Library company of Baltimore, was instituted, and under the influence of corresponding principles, it has been uniformly and steadily conducted down to the present hour. Believing it to be the wish of the members, to continue to society the advantages of the institution, will it not be considered indispensable?

1. That the directors should not be obliged to apply any part of the monies now annually expended in the purchase of Books to any other object?

2. That the means be provided competent to procure a lot of ground, in a suitable situation on which may be erected, when it shall become necessary, a commodious building for the deposit of the Books of the Company?

With respect to the first, The Directors would lament the occurrence of any circumstance, that should abridge the annual supply of Books, or the increase of the Library, upon this point, they felt assured they concur in opinion with the great body of Stockholders.

With respect to the second point, they also concur themselves with a concurrence, for,

although fixed in their determination to retain the room now possessed by the company, as long (if permitted by its proprietors) as it will serve to contain their books, yet, as the time must come when it will be inadequate to that purpose, the directors consider it prudent and advisable, that the company should be provided against such an event.

A Lot of Ground in a suitable situation, may be now had on reasonable terms. Should the purchase be deferred, who will insure to the company, that we shall be able to get a suitable lot hereafter? The probability is, if we neglect to buy now, that we either cannot be accommodated at market when we cannot longer do without a lot, or must pay, for a convenient situation, an extravagant price.

Acting under these considerations, the directors recently proposed to the company an additional contribution of two dollars per annum, to be paid on each share, for 8 successive years. This proposed contribution, so easy and equal in its operation, which to each member would have amounted to sixteen dollars only, was unanimously agreed to, at a meeting of the company, convened on the 26th May last, but at a subsequent meeting (the concurrence of two being required for its confirmation) from some members misapprehending the object of the measure, & the necessity of making the purchase, at this time, not being felt, or but slightly felt by others, it was rejected by a majority of the few who attended on that occasion.

The necessity of adopting the measure, still pressing upon the directors with undiminished force, they conceive it to be their duty, to call the attention of the company again to the subject, more especially as they cannot permit themselves to entertain a doubt that a revision by men, interested to the extension of the said literature among us, will lead to a favorable result. The following proceedings were accordingly had, at a meeting of their body, held the 1st July instant:

Resolved, That a general meeting of the members of the Library Company be, and hereby is requested, at the Library room, on the 17th of July inst. at 11 o'clock, A. M. in order to determine on the following propositions, which, if then agreed to and confirmed by the company at a future meeting, will become of constitutional force:

1. That every member of the Library Company of Baltimore shall pay annually, in addition to his present annual contribution, the sum of two dollars for eight successive years, which payments may be enforced under the regulations and in the mode prescribed for compelling payments of the said stated annual contributions: provided always, that any member shall be at liberty to advance fourteen dollars in one payment at any time on or before the first annual contribution becoming due, which advance shall be received in lieu of his eight years additional contributions.

2. That the directors of the Library Company of Baltimore be and are hereby authorized and required to appropriate the said additional contributions or so much thereof as may be necessary to the purchase of a suitable lot of ground, on which may be erected a commodious building for the deposit of the books of the Library when the funds will permit.
