THE INDIANS.

CAPT. PARRISH'S STATEMENT.

"As many persons, in consideration of  
the threatening aspect of our relations with  
Britain, and the intimate intercourse which  
exists between several tribes of Indians on  
our boarders and the British provinces of Up-  
per & Lower Canada, entertain very serious  
apprehensions of hostilities, it may, perhaps,  
be acceptable to the public, and have a ten-  
dency to remove such apprehensions, for  
me to state the transaction of a council of  
Indians, held at Buffalo Creek on the 31st  
day of March last, and on the 1st and 2d  
days of April instant.

"In the early part of March, a deputa-  
tion of the two chiefs from the seven tribes of  
Cahnawaga nation, residing in Lower Can-  
ada, appeared at Buffalo, inviting the  
Six Nations to meet with them in council,  
for the purpose of coming to a final decision  
upon what part it was expedient for them  
to take in the war, which they had been  
informed was shortly to be expected, be-  
tween Britain and the United States. Ac-  
cordingly a very respectable delegation of  
chiefs from the Six Nations assembled, to-  
gether with the Cahnawaga delegates at  
Buffalo Creek.

"Erastus Granger, Esq. Indian agent  
for the United States, and myself, being  
apprized of the meeting of this council, and  
having business to transact with the Six Na-  
tions, took the opportunity of this meeting  
to confer with them.

"After having completed our business,  
the chiefs voluntarily communicated to us  
the proceedings of their council.

"They said that the Cahnawaga dele-  
gates were duly authorized to meet the Six  
Nations in council for the purpose above  
specified—that the UNANIMOUS  
decision of the council was, that in the event  
of a war, they would resolutely REMAIN  
NEUTRAL, and use all their influence  
with the other tribes connected in any way  
with them, to induce them to remain neu-  
tral also. The chiefs then exhibited to us  
a war-belt, which they said had been pre-  
sented to them by Col. Closs, superinten-  
dant of Indian affairs for the British in Up-  
per Canada. On this belt was wrought,  
with beads, an emblematic representation of  
the British nation handing to the Indians a  
tomahawk, which they understood to mean  
that, if the British did engage in a war with  
the U. States, they requested the Indians to  
aid them in it—that the council, however,  
had unanimously determined to return the  
belt, and to inform Col. Closs that if his  
nation would go to war with the U. S.  
they must fight their own battles, and not  
look to them for any assistance—for in such  
a war, why should they become a party?  
"They once had suffered themselves to  
be persuaded into a war with the United  
States, without any sufficient reason, the  
consequences of which they well remember  
to have been the destruction of many of  
their villages and the loss of many of their  
warriors—that since that war had ceased,  
they had entered into various advantageous  
treaties with the United States, and that the  
stipulations of all those had been faithfully  
observed.

LONDON, April 15.

The following account has been received  
of the treacherous means by which the  
French hoped to obtain possession of the  
Citadel of Pampeluna, (Spain):  
"On the 16th of Feb. early in the morn-  
ing, a party of about thirty French soldiers,  
with two officers, went, as is usual, to the  
Citadel with empty bags, in order to receive  
rations. Under pretence of sheltering them-  
selves from a shower of snow, they took re-  
fuge in the guard-room at the gate;  
here, watching an opportunity, they seized  
the arms of the guard, which consisted of  
12 Spanish soldiers and an officer, and  
knocked down the sentinel, who attempted  
to make resistance. At a signal given by  
one of the French, two hundred soldiers,  
with arms, came to their assistance, entered  
the Citadel with an officer, overpowered the  
advanced guard, composed of four soldiers  
and an officer, threatening the latter, be-  
cause he made some opposition, and took  
possession of all the batteries. They also  
gave a hint to about 200 soldiers who were  
quartered in the fortress, that if they did not  
submit they might abide by the consequen-  
ces.—Successively then entered about 1000  
French soldiers, who had held themselves  
in readiness for this purpose from two in the  
morning, but observing till then the great-  
est silence, and artfully concealing them-  
selves. They afterwards made themselves  
masters of the bridges of the town, and of  
the powder magazine, about half a league  
distant, retaining in the Citadel only 110  
Spanish soldiers, to do duty alternately with  
them.

"The same day the following letter was  
addressed to the deputies by Davaagnac,  
commander of Division:  
Pampeluna, Feb. 16th, 1808.

"Gentlemen—Understanding that we  
are to remain some time in Pampeluna, I feel  
myself obliged to ensure its safety in a mili-  
tary manner; (with this view,) accordingly,  
I have ordered a battalion to repair to the  
Citadel, in order to garrison it and to do  
duty along with the Spanish troops. I be-  
seach you to consider this only as a trifling  
change, incapable of disturbing the harmony  
(interrupting the good understanding) which  
ought to subsist between the two faithful  
allies.  
"Have the goodness to represent it in  
this light to your fellow citizens and be as-  
sured of the perfect consideration with which  
I am your servant.

Admiralty Court. Doctor's Commons.

April 1. This day the right hon. sir Wm.  
Scott proceeded to the adjudication of the  
following cases:

Caroline, Doak, master. This American  
vessel, laden with cotton, rice, &c. was bound  
from New-York to Cherbourg at the time of  
capture. It appeared that she took on board  
public dispatches, which came from the  
French ambassador and consul resident  
at the United States, addressed to official  
persons in the government of France. The  
court was of opinion that a neutral merchant-  
man had no right to take public dispatches  
of this nature, but at the same time held,  
she had not subjected herself to confiscation,  
as in the cases already determined,  
where the dispatches were taken on board  
at the colony of the enemy and coming to  
the mother country, and therefore restored  
the ship and cargo, subject to all the captor's  
expences.

Susan Howard, master. This American  
ship, laden with wine, brandy, &c. was go-  
ing from Bordeaux to New-York at the time  
of capture. It appears that papers of a public  
nature were taken on board at Bordeaux,  
addressed to official persons at the Isle of  
France. Ship condemned, and cargo re-  
stored.

Marilla, Bennett, master. This American  
vessel, with a cargo of various merchandize,  
was bound from St. Domingo to Gottenburg.  
Ship and cargo restored, on payment of the  
captor's reasonable expences.

Thalia, Seliman, master. This American  
vessel, laden with wine, brandy, &c. was  
bound from Bordeaux to Philadelphia, at the  
time of capture (in violation of the order in  
council of the 11th of November.) Ship  
and cargo restored, subject to the captor's  
expences.

April 6. Union, Baker, master. This A-  
merican vessel, laden with various merchan-  
dize, was bound from Amsterdam to Madeira  
and thence to Santa Cruz, at the time of cap-  
ture. The ship had been already restored,  
and the question now was, with respect to  
the national character of the person who  
claimed the cargo. On the part of the captors  
it was contended that he was a Dutchman.  
The court, however, was clearly of opinion  
that he was to be considered as an American,  
and consequently was entitled to the restitu-  
tion of his property.

April 9. Hope, Jones, master. This A-  
merican ship, laden with various merchan-  
dize, on a voyage from Bordeaux to N. York,  
was captured by the privateer May, captain  
Vinnicombe, and carried to Falmouth. It  
appeared that the captors had consented to  
the restoration of the ship & cargo, but before  
possession was delivered, the captors obtain-  
ed information that a trunk, containing  
public dispatches, sealed with the imperial  
signet of France, and addressed to various  
persons at Martinique, was secreted in the  
hold, which were found. The court con-  
demned the vessel, but there being nothing  
to affect the cargo, the same was restored.

April 11. Globe, Coffin, master. This A-  
merican ship, laden with tobacco and coffee,  
was captured by the Venus privateer, R. Jolly,  
commander. Ship restored, and further proof  
directed to be produced as to the cargo.

KINGSTON, (JAM.) April 12.

Yesterday arrived, at Port Royal, the  
Avon brig of 18 guns, capt. Trush, from a  
cruise, with the British ship Ben. Lomood,  
capt. Burr, from Gonaives to London with  
coffee and cotton, detained on the 29th ult.  
Off Cape Nicholas Mole by the Dædalus  
and Avon.

British schr. Popham, Prudden, from  
New-Providence to Port-au-Prince, with  
dry goods, salt and warlike stores, detain-  
ed off Cape Nicholas Mole on 9th inst.

Young Roscius, 14 gun brig, 100 men  
under Haytian colours, commanded by  
chief de Dravion Parentem, detained on the  
9th inst. off the Platform. She originally  
sailed from Gonaives in company with two  
schr. of 10 guns and upwards of 100 men  
each, for the purpose of intercepting and  
making prize of several armed schrs. belong-  
ing to Petion, that were destined to cruise  
off Cape Nicholas Mole.

St. Jago de la Vega, April 23.

Yesterday arrived at Port Royal, the go-  
vernment brig Princess Charlotte capt. Ful-  
ford, from New-Providence, in 15 days  
having on board the first lieutenant and 60 men,  
late of his majesty's ship Muros, which we  
lament to state was lost in going into Baya  
Honda, a few leagues to leeward of Havan-  
na. It appears that the enemy were con-  
structing batteries at that place, which, not  
being completed, capt. Duff purposed des-  
troying, conceiving that they would prevent  
his majesty's ships from watering there, and  
that the bay might also serve as a lurking  
place for privateers from being well protect-  
ed. Impressed with the practicability of  
doing so, he was endeavouring to enter,  
when the Muros was run ashore by the pilot  
and totally lost. All the crew were lucki-  
ly preserved, and proceeded to New-Pro-  
vidence.

NEW YORK, May 30.

Government has chartered the brig Ham-  
let, of this port, to carry dispatches to the  
Portuguese government at Brazil. She will  
sail in 8 or 10 days.

On the 9th ult. the Haytian president  
Christophe had a bloody battle with Petion,  
near Cape Nicola Mole. Christophe is said  
to have had 1000 men killed. [Gazette.]

By the schr. Success, arrived yesterday  
from Jamaica, we learn that an engagement  
which lasted three days had taken place be-  
tween Petion and Christophe, within ten  
miles of Cape Francois. The carnage was  
dreadful; Christophe lost 10,000 men, and  
an immense number wounded. Flour at  
Kingston 30 dollars & rising. Other A-  
merican articles high and scarce. For her  
ship news see our marine list. [L'Oracle.]

Sailed on Thursday last for Londonderry,  
the ship Elizabeth, Hamilton Rea, master,  
having as passengers, Mrs. and two Miss  
Dickeys, two Miss Moores, Mr. Jackson and  
daughter, Dr. Hornidge and family, Dr. Horn  
and family, Dr. Clarke, Mr. Luke, Mr. Mc-  
Donnell, Mr. Girty, Mr. Leonard, and a  
number in the steerage.  
The steam-boat arrived at this port about  
half an hour after 7 o'clock on Saturday e-  
vening, in 30 hours from Albany.

PHILADELPHIA, May 31.

The Boston Palladium of Friday last con-  
tains the following article:—

"Arrived on Wednesday, schr Cushing,  
Brewer, from Passamaquoddy, 4 days.—  
Left, schr Morning Star, of Boston; schr  
Resolution, Bartlett, for do. ready for sea,  
not allowed to discharge her provisions;  
Wendell, Downs; and about 12 or 14 other  
vessels, with their outward bound cargoes  
on board. Sailed in co. with a schr for  
Manchester; and a number of others, with  
their outward cargoes. The U. S. sloop of  
war Wasp, arrived there on Thursday after-  
noon about 4 o'clock, landed a company of  
marines and 2 pieces of artillery on Moose  
Island, where they are erecting a battery.  
On the night the Wasp arrived no less than  
14 boats laden with flour, were captured by  
her launch, in endeavoring to cross the Brit-  
ish line; where a brig of 18, and a schr of  
of 16 guns, lay ready to receive it; and  
whose decks were seen covered with flour  
every day. Her launch in an excursion up  
the river, was obliged to return again for as-  
sistance, in consequence of the number of  
boats passing over. A sentinel was placed  
at the door of every store containing provi-  
sions, &c. and has 2 dollars per day. Capt.  
Brewer sailed from Philadelphia (armed) un-  
der the orders of government. While lay-  
ing at Passamaquoddy he took possession of  
a boat with 5 bbls of flour on board, but  
liberated the boat and the men belonging to  
her. The next day the owner of the boat  
came on board, and demanded what autho-  
rity he had to take his flour, and having  
been satisfied upon that point, he departed.  
But notwithstanding all these precautions,  
it will be almost impossible to prevent boats  
escaping over the British line with flour."

RICHMOND, May 24.

The following detail is intitled to notice.  
If we are correctly informed, a gentleman  
of high respectability in the neighborhood  
of Orange, where the Secretary of State  
resides, and who has been always a warm  
supporter for the present administration, un-  
fortunately when times were better, purchas-  
ed a crop of wheat of Mr. Madison.—Be-  
ing lately dunned for the sum which was  
due, the debtor gravely replied—'Go back  
and tell Mr. Madison, if he will take off the  
Embargo, I'll pay him for his wheat.'

"Died, lately, at Hammersmith, Eng.  
in his 83th year, John Rice, Esq. a charac-  
ter miserably and penurious. Mr. Rice was  
born in Westminster, and having received  
a musical education, he resolved to try his  
fortune in America. He sailed for New-  
York, where he settled and got an appoint-  
ment as an organist. In this situation, de-  
nying himself the common necessaries of  
life, accumulated a considerable sum of mo-  
ney, and returned to England. His habit  
was that of the most indigent beggar, and  
so deplorably miserably was his garb and ap-  
pearance, that he was turned out of two lod-  
gings he took. At length he obtained a  
room at a glazier's shop near Marsham-street,  
London, where he was taken very ill. He  
requested he might be decently clothed, and  
conveyed to Mr. Boyce, at Hammersmith,  
whose father, he said, was his most inti-  
mate acquaintance. He was accordingly  
taken there, where he survived only a few  
days. After his death, his will was opened  
by which it appeared that he had bequeath-  
ed 20,000l. to Mr. Boyce, and 10,000l.  
to the Bishop of New-York. He is said to  
have died worth 40,000l.

On Saturday morning last at half past nine  
o'clock, the Corner Stone of Fort Moultrie,  
was laid by a young lady of Charleston  
accompanied by several others. This work,  
when finished, will do honor to the go-  
vernment, the Engineer, and those employ-  
ed in the construction of it. From the ar-  
rangments and preparations that are made,  
it offers fair for a quick completion.
