PARLETT LLOYD**, of BALTIMORE, MD., my true and lawful Attorney for me, and in my name, place, and stead, with full power of substitution and revocation, to prosecute my claim for *Law* pension.

NOW, THIS AGREEMENT WITNESSETH. That for and in consideration of services done and to be done in the premises, I hereby agree to allow my Attorney, **A. PARLETT LLOYD**, of BALTIMORE, MD., the fee of TWENTY-FIVE DOLLARS, which shall include all amounts to be paid for any service in furtherance of said claim; and said fee shall not be demanded by or payable to my said Attorney in whole or in part, except in case of the granting of my pension by the Commissioner of Pensions, and that the same shall be paid to him in accordance with the provisions of Sections 4768 and 4769 R. S.
