DECLARATION FOR PENSION.

Act of May 1, 1920.

THE PENSION CERTIFICATE SHOULD NOT BE FORWARDED WITH THE APPLICATION.

STATE OF Maryland CITY OF Baltimore, ss:
On this 13th day of October, A. D. 1920, personally appeared before me, a Notary Public, within and for the county and State aforesaid, Charles Bennett who, being duly sworn according to law, declares that he is 81 years of age, and a resident of Baltimore City county of Maryland; and that he is the identical person who was ENROLLED at Baltimore City, under the name of Charles Bennett on the 27th day of September, 1863, as a Private in Company "E," Seventh Regiment of United States Colored Infantry (Here state rank, and company and regiment in the Army, or vessels if in the Navy.)

in the service of the United States, in the Civil War War, and was HONORABLY DISCHARGED at Indianola, Texas on the 13th day of October, 1866 That he also served (Here give a complete statement of all other services, if any.)

That his personal description at enlistment was as follows: Height, 5 feet 6 inches; complexion, Black color of eyes, Black; color of hair, Curly; that his occupation was Farmer; that he was born 1838 at Queen Anne's County Maryland; I do not remember day and month

That he requires the regular personal aid and attendance of another person on account of the following disabilities: paralysis of arm and leg and general disabilities (State in this space the nature of any and all disabilities.) the beginning of my paralysis was about 10 years ago and I have had another slight stroke of paralysis only 4 weeks from this present date That since leaving the service he has resided at Baltimore City Maryland

and his occupation has been general laborer up to last eight years. That he has applied for pension under Original No. 545735 That he is now a pensioner under Certificate No. 545735 That he makes this declaration for the purpose of being placed on the pension roll of the United States under the provisions of the act of May 1, 1920.
