Here give a full description of the disabilities, in accordance with Book of Instructions.

Bronchitis; Throat. No cough. No dullness on percussion. Respiratory sounds clear. Chest measures, expiration 32, rest 33, inspiration 35. No symptoms of bronchitis or disease of throat. No rating.

The actual or probable origin of every existing disability must be fully set forth. Whenever a disability is shown or is believed to be due to or aggravated by vicious habits the opinion of the board must be stated. When not due to such habits this fact must be stated.

Rheumatism; Heart. Except left leg, no deformity or limitation of motion of joints. His lumbar muscles and muscles of thighs and neck are sore to touch and painful in stooping and rising. Heart normal in size, position and function. No hypertrophy or dilatation. No dyspnea, cyanosis or oedema. Lumbago. Rating 6/18.

Catarrh; Hearing. Mucous membrane of nasal passage normal. Eustachian tubes pervious. Hearing not impaired. Each external and internal auditory apparatus in normal condition. Can hear with each ear ordinary conversation at a greater distance than six feet. No rating.

Each disability must be rated separately, the act of Congress of March 2, 1895, requiring "that the report of such examining surgeons shall specifically state the rating which, in their judgment, the applicant is entitled to."

Has an extreme outward curvature of the left leg and thigh, due to an injury to knee by being thrown from a horse. The knee was undoubtedly dislocated and was never properly reduced. Flexion of the leg upon the thigh is slightly impaired. As he walks, the leg curves more outward and seems to give away from under him, displaying considerable weakness. The injury causes a decided limp; there is no loss of tissue. The injury impaires his ability to perform manual labor to a considerable degree. Rating 8/18.

Except as above, all organs normal. Urine light amber. S. G. 1020. Acid. No albumen or sugar.

When rates are recommended solely on subjective evidence the strongest reasons must be given therefor.

No evidence of vicious habits.

His disabilities are permanent.
