

SUPPLEMENTAL DECLARATION FOR INVALID PENSION.

REPRODUCED AT THE NATIONAL ARCHIVES

Acts of June 27, 1890, and May 9, 1900.

To be executed before some officer authorized to administer oaths for general purposes. The official character and signature of any such officer not required by law to use a seal must be certified by the clerk of the proper court, giving dates of beginning and close of official term. aged 58 years, a resident of the Justice Mills

County of Talbot, State of MD, who, being

duly sworn according to law, declares that he is the identical John Blackwell

who was ENROLLED on the 26 day of September, 1863, in

Co B 7th U.S.C. Here state rank, company

and regiment if in the army, or vessel if in the navy

in the service of the United States in the War of the Rebellion, and served at least Ninety Days,

and was HONORABLY DISCHARGED at Baltimore Maryland, on the 26 day of

Sept 16th, 1866. That he was disabled for earning a support by manual labor in a pensionable

degree on or about, 1892, the date of filing his original declaration, by reason of the following disabilities:

rheumatism rupture affection of eyes
pain in breast right ankle affected

That he is also disabled for earning a support by General debility

the above disabilities are the same as

that he is now partially disabled for earning a support by manual labor in consequence of same.

That he makes this declaration for the purpose of reopening his claim and being placed on the pension-roll of the United States, under the provisions of the Acts of June 27, 1890, and May 9, 1900. He also requests that his original or first claim filed under the said Acts, be re-examined and considered under the provisions of the Act approved March 6, 1896, and also under the decision of the Hon. Assistant Secretary of the Interior, of June 17, 1896, in the case of James J. Durkee, Vol. 8, P. D., p. 152, giving construction to said Act, and that he be given an opportunity to show by evidence that his claim, if allowed, should date back to the time of filing his original or first application for pension, under the Act of June 27, 1890. HE HEREBY APPOINTS, WITH FULL POWER OF SUBSTITUTION AND REVOCATION,

SOULÉ & CO., OF WASHINGTON, D. C.,
 his true and lawful Attorneys, to prosecute this claim, and he directs that the sum of Ten Dollars be paid to said Attorneys.
