the right knee. The right knee is swollen by rheumatic in-
filtration. The right measures 17 inches in circumference.
The left knee measures 16 inches in circumference. Flexion
of each leg upon the thigh, is limited 50%, owing to pain
and contraction of tendons and ligaments at the knee joints.
No other joints or muscles affected. Heart--Apex impulse
felt in fifth interspace, 1-1/2 inch to right of left nip-
ple. Cardiac dullness extends from apex, to middle of sternum
and to fourth left chondrocostal articulation. Action is
regular, and valves are in good condition. No hypertrophy
or dilatation. No dyspnoea, cyanosis or oedema. Rheumatism.

congested. He has two internal piles, projecting from anus,
each 3/4 inch in diameter; blue and purple in color; ul-
cerated and sensitive, with tendency to bleed upon irrita-
tion. There is a slight prolapse of the rectum. No fissure,
fistula or stricture. Piles. Rating 8/18.He presents no scars or other evidence of gunshot wound of
either shoulder. No rating. No symptoms of General Debility.
No rating.Curvature of the Spine: He has a slight lateral curvature
of the spine, which is probably due to hard work in his
youth. There is no lesion of the spinal cord. No impair-
ment of mental, spinal or nervous functions. No chronic men-
ingitis. No vertigo, spasms, convulsions or nausea. No par-
alysis, local or general. Breathing regular. No difficulty
swallowing. No impairment of coordination of movements.
