DECLARATION FOR PENSION.

THE PENSION CERTIFICATE SHOULD NOT BE FORWARDED WITH THE APPLICATION.

On this 24th day of June, A. D. one thousand nine hundred and nine, personally appeared before me, a Justice of the Peace within and for the county and State aforesaid, Madison Hensell, who, being duly sworn according to law, declares that he is 76 years of age, and a resident of 611 Gilbert St. county of Baltimore, State of Md; and that he is the identical person who was ENROLLED at Berndt, Md. under the name of Madison Hensell, on the 21 day of November, 1863 as a private in Co. F. 9th Regt. U. S. Colored Troops - Cavalry (Here state rank, and company and regiment in the Army, or vessels if in the Navy.) in the service of the United States, in the Civil war, and was HONORABLY DISCHARGED at Fortress Monroe, on the 25 day of November, 1865. That he also served none (Here give a complete statement of all other services, if any.)

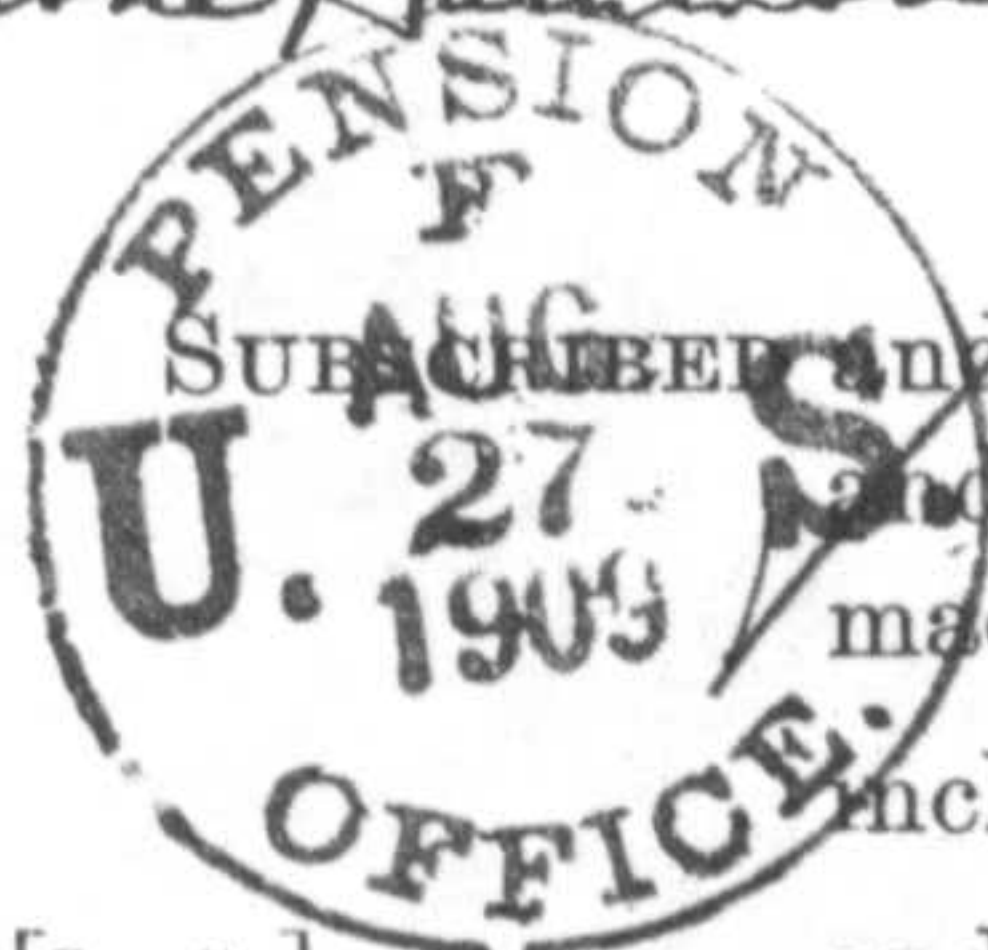
