WE HEREBY CERTIFY that in compliance with the requirements of the law* we have carefully examined this applicant, who claims that while in the service of the United States at or near a place named *Sugar Loaf Mountain Md.* and while in line of duty, on or about the day of *Winter*, 18*64*, he incurred *U. S. W. J. Muck, arm and left eye*

and that in consequence thereof he is *2/3rd* disabled for earning his subsistence by manual labor

His pulse-rate is *78* per minute; his respiration *17*; his temperature *98 1/2*; his height is *5* feet and *6* inches; he weighs *165* pounds, and states that he is *49* years of age.

Touching the cause and degree of the disability for which he claims a pension, he makes the following statement:

Here give the statement of the claimant fully, but as compactly as possible.

That he is disabled from these wounds, mostly from wound in right arm, so that he cannot do full work.

SUBJECTIVE SYMPTOMS.

Here give a full symptom picture of the case, embracing all the physical and rational signs, but confining it to the present condition of the claimant.

The examination reveals the following objective facts in support of his statements: *We find a somewhat stellate scar over left malar bone 3 inches below outer angle of eye, not adherent, not sensitive, slightly depressed, 1/2 inch in diameter. Another scar linear in shape, 1 inch long in anterior triangle of neck right side immediately over carotid artery, not adherent, not depressed, not sensitive. An elliptical scar 3/4 inch long, not adherent, not sensitive, not depressed, situated on right arm, posterior aspect, 1 inch above olecranon process when arm is extended. See diagram.*

OBJECTIVE SYMPTOMS.

From the existing condition and the history of this claimant, as stated by himself, it is, in our judgment, probable that the disability was incurred in the service as he claims, and that it has not been aggravated or prolonged by vicious habits. He is, in our opinion, entitled to a *1/8th*

Here give rating for each cause of disability, and state the aggregate.

rating for the disability caused by *wound of left cheek* *2/8th* for that caused by *wound of right side of neck* and *1/8th* for that caused by *wound of right arm*, the sum of which aggregates *3/8th total*
