DECLARATION FOR AN ORIGINAL PENSION OF A MOTHER.

STATE OF West Virginia, COUNTY OF Jefferson, ss:
 On this 20th day of June, A. D. one thousand eight hundred and eighty-seven
 personally appeared before me T. M. Salinger, Clerk Circuit Court of said Co.,
 the same being a court of record within and for the county and State aforesaid, Hester A. Bowman
 a resident of Shepherdstown, county of Jefferson, in the State of West Virginia
 aged 57 years, who, being duly sworn according to law, makes the following declaration in order to obtain the pension
 provided by Acts of Congress granting pensions to dependent mothers: That she is the ¹ widow of Garrett Bowman

and mother of George M. Harris
 who ² Enlisted under the name of George M. Harris
 at Baltimore, on the day of July, A. D. 1863

in ³ Company "C," 4th Regiment of Colored Infantry Vol.
 in the war of the rebellion, who lost his index finger and

his right hand at the battle of Petersburg Va
and died the 10th of October 1865 of Consumption
contracted while in the service

on the day of , A. D. 1863; that said son Geo. M. Harris

left neither widow nor child under sixteen years of age surviving; that she was

⁵ wholly dependent upon said son for support; that her husband, the aforesaid Garrett M. Bowman
died June 11th 1878, aged 63 years ⁶ said
Hester A. Bowman has not remarried

that there were surviving at date of said son's death, his brothers and sisters, who were under sixteen years of age, as follows:
