

DECLARATION FOR WIDOW'S PENSION.

ACT OF JUNE 27, 1890.

To be executed before a Court of Record or some Officer thereof having custody of its Seal, or a Notary Public, or a Justice of the Peace, whose Official Signature shall be verified by his own Official Seal, if he has one, or by the proper Clerk, under Seal.

State of Maryland, County of Talbot, ss:

On this February day of February, A. D. one thousand eight hundred and ninety four personally appeared before me, a Justice of the Peace within and for the county and State aforesaid, Maria Gibson aged 52 years, a resident of the Coppersville of Talbot county of Maryland, who, being duly sworn according to law, declares that she is the widow of Horace Gibson, who enlisted under the name of Horace Gibson, at on the day of , A. D. 18 , in Co. B. Seventh Here state rank, company, and regiment, if in military service, Regiment U. S. Colored Volunteers Infantry or vessel, if in the Navy.

and served at least ninety days in the service of the United States in the late War of the Rebellion, who was honorably discharged , and died on or about the 10th day of February, 1894.
The cause of death need not be stated.

That she was married under the name of Maria Gibson to said Horace Gibson on the 29th day of June, 1867, by Rev Peter Burrows, at Easton Maryland, there being no legal barrier to said marriage. Neither having been previously married
If there was a former marriage of claimant or her husband, state it here and how dissolved.

That she has not remarried since the death of the said Horace Gibson

That she is without other means of support than her daily labor; that names and dates of birth of all the children now living under sixteen years of age of the soldier are as follows:
