We hereby certify that in compliance with the requirements of the law we have carefully examined this applicant, who states that he is suffering from the following disability, incurred in the service, viz: Rheumatism; Injury to Right Shoulder; Disease of Throat and Lungs.

He makes the following statement upon which he bases his claim for ORIGINAL

Claims to have Rheumatism in right arm and both legs.  
Claims to have had a gathering in the throat every year since leaving the service.  
Makes no claim for disease of the lungs.

Here give a full description of the disabilities, in accordance with pars. 5, 6, 51, 52, &c., of Book of Instructions for 1889

Upon examination we find the following objective conditions: Pulse rate, 72; respiration, 18; temperature, N; height, 5 feet 9 inches; weight, 159 pounds; age, 48 years. General physical condition good.  
He claims that while lying in his bunk, a needle entered just outside of vertebrae border of right scapula and was extracted several months after on anterior aspect of right arm just in front of tendon of deltoid.  
Scar is circular; 1/2 inch in diameter; superficial.  
Claims severe pain on motion through arm and shoulder, which is probably of rheumatic nature.  
No crepitation or deformity of joints. Has pain on motion in both knees.  
Heart, Lungs and Abdominal organs normal.  
From his statement he evidently suffers with occasional attacks of Tonsillitis, which is the disease of throat claimed. No evidence at present.  
No other disability exists.
