

## Instructions.

The witness should, after filling the blank spaces, state in the body of the blank and in his own handwriting the following

1. If he treated the soldier for the disability in question during his service either as his regimental surgeon or while he may have been at home on furlough, he will state his physical condition at such times, the nature and duration of his disability and the dates of treatment.

2. Whether he has treated said soldier since his discharge.

If he has he should state—

(a) At about what date he first treated him.

(b) What his physical condition was with reference to the disability on which claim is based, when he first treated him, giving a full description or diagnosis of it.

(c) Period during which he has treated him, giving approximate dates where exact dates cannot be given; and if dates of prescriptions or visits cannot be given he should state why.

## 3. VERY IMPORTANT—

He will also state what has been the degree of soldier's incapacity for manual labor, by reason of the disabilities on which this claim is based, during each month or year of the period of his treatment; in other words, what has been the average loss of time from labor, per month or year, or about what proportion of a sound, able-bodied man's work he has been able to perform, whether  $\frac{1}{2}$ ,  $\frac{1}{3}$ ,  $\frac{1}{4}$ , or as the case may have been.



The Physician should make his statement a complete narrative and not simply answers to the marginal notes.

In the above entitled case personally appeared Dr. R. E. Warner

who, being duly sworn, declares in relation to the aforesaid case as follows: I have practiced medicine during the last Seventeen years. I became acquainted with the said soldier in the year 1892

Became acquainted with Mr Osborn Suckitt about thirty days ago. Never treated him for anything. Upon a careful and personal examination found a tumor about the size of a wall nut on the outside of the left thigh. It seemed to be connected with the muscle or rather attached to it. He gives as the cause of the tumor the injury to the ankle on the left side, which consisted of a broken fibula, good repair. The ankles were sprained at the same time, the left worse. And now that ankle is still swollen and I think the bone enlarged. As occurs in these cases, Rheumatism exists and is aggravated by humid weather.

My opinion is that ~~he~~ as he asserts, he is considerably disabled, and is unfitted by one-half for the performance of manual labor.

These injuries he says were caused by being thrown from a Railroad Car by drunken soldiers while returning to military duty after a furlough.

I further declare that I have no interest in said case, and am not concerned in its prosecution.
