

DECLARATION FOR WIDOW'S PENSION.

STATE OF Maryland
COUNTY OF Anne Arundel
On this 31st day of May, A. D. one thousand nine hundred and 16
personally appeared before me, a Notary Public within
and for the county and State aforesaid, Martha Price, aged about 68
years, a resident of Annapolis, county of Anne Arundel, State
of Maryland, who, being duly sworn according to law, makes the following declaration in order to
obtain pension under the provisions of the ACT OF CONGRESS APPROVED APRIL 19, 1908.

That she is the widow of Daniel Brice, who was
on Roll under the name of Daniel Brice, at
Annapolis, on the 24th day of February, 1864
as a Private in Co. D. 30th Regiment U.S. Col. Inf., and
honorably discharged Dec. 10, 1865, having served ninety days or more during the late civil war.

That he also served _____

That he was not in the military or naval service of the United States otherwise than as stated above.

That she was married under the name of Martha Crookwell
to said soldier at Annapolis, Md., on the 25th day
of October, 1866, by Rev. Richard Lane;
that there was no legal barrier to the marriage; that she had not been previously married; that the soldier had not
been previously married,

and that neither she nor said soldier married otherwise than as stated above.

That the said soldier died the 8th of May, 1916, at Annapolis Maryland;
that she was not divorced from him, and that she has not remarried since his death.

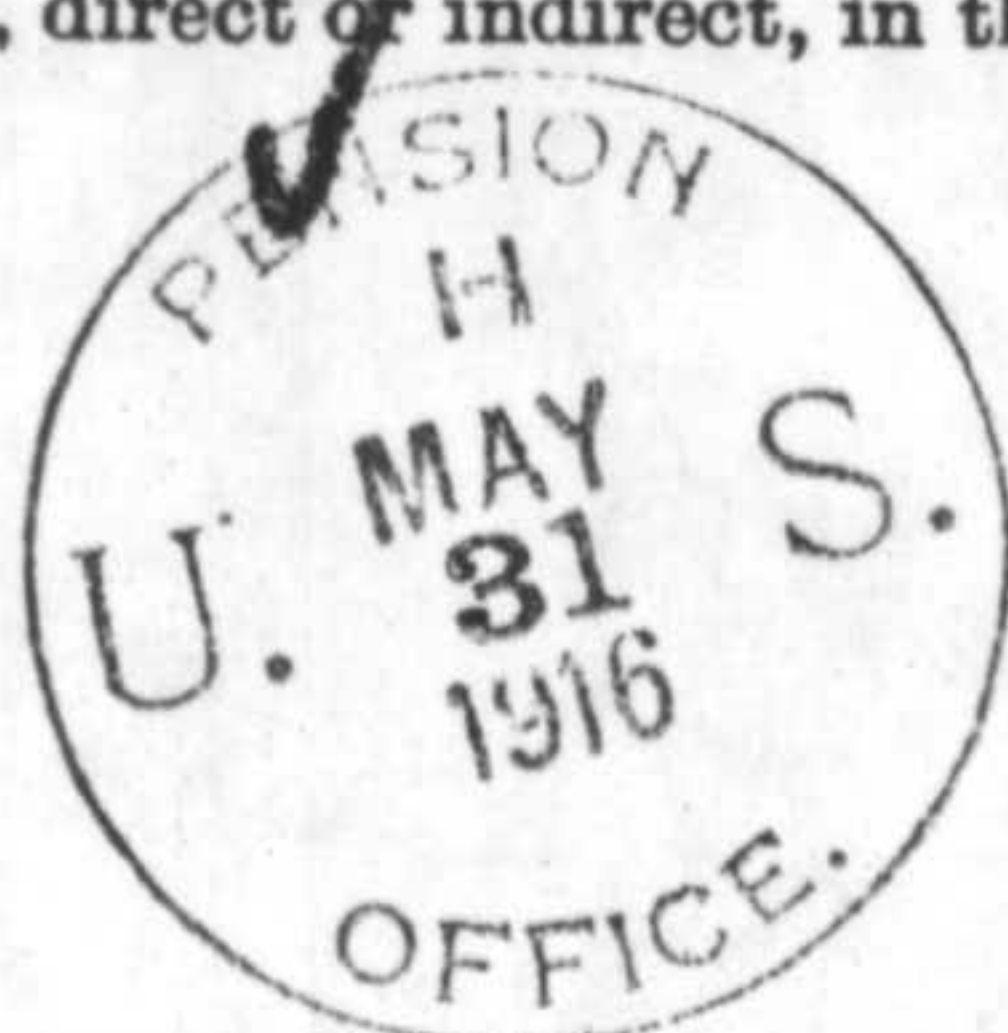
Also personally appeared Charles H. Wootton, residing in
