

Soldier's Application for Bounty.

(INJURIES INCURRED IN LINE OF DUTY.)

I, Daniel Bruce, a resident of the (1) City of Annapolis in the State of Maryland on oath say, that my age is 22 years, and that I am the identical Daniel Bruce who at enrollment was a resident of the (1) City of Annapolis in the State of Maryland and late a private in Company D commanded by Captain Eleazar Whiting in the 38th Regiment of (2) U.S. Col^d Troops commanded by Col^d Jackson in the War of 1861, and who (3) served in the service of the United States at Annapolis in the State of Maryland on the 24th day of February A. D. 1861 for the terms of three years and was honorably discharged at Plymouth Island in the State of North Carolina on or about the 10th day of December A. D. 1863; all of which should more fully appear on reference to the muster and pay rolls of said company. Also by such other evidence as my attorney herein below named may file in support hereof.

That I was discharged upon Surgeon's Certificate of Disability, which are or should be, on file in the Office of the Adjutant General of the United States, at Washington City, District of Columbia, transmitted by the proper authorities, in obedience to paragraph 168, pages 30 and 31, Revised Army Regulations.

That I was discharged by reason of (4) Wound out of Regt per G O 249 At Res Sept 16 1865. And I further declare that I have not bartered sold assigned transferred loaned exchanged or given away my final discharge papers or any interest in the bounty provided by this or any other act of congress, but held the same for his claim in the hands of B. D. Hyam my Attorney

That I bear true allegiance to the Government, Constitution, and Laws of the United States, and have never, in any manner, been engaged in or aided or abetted the rebellion therein, either directly or indirectly, so help me God.

I make this application to recover the Bounty to which I may be entitled by reason of my above named services under the Acts of Congress, approved July 22, 1861, or July, 1862, or of March 3, 1863, or of March 3, 1865, or by virtue of any other act or acts now enacted, or that may hereafter be enacted.

I hereby constitute and appoint B. D. Hyam of the (1) City of Washington in the State of D.C. with full power of substitution and revocation, my true and lawful attorney irrevocable, to prosecute this claim, and procure the Treasury Warrant which may issue thereon, and to do all lawful acts and things whatsoever, touching the premises, except drawing the money, which will be hereafter provided for. And revoking and countermanding all other authority herewith conflicting—my said attorney is hereby authorized to obtain all necessary proofs to the successful establishment of this claim, the same as I might were I personally present.
