On this..... day of....., A. D. one thousand eight hundred and eighty..... personally appeared before me, a Deputy Clerk of the Superior Court, a court of record within and for the County and State aforesaid, Nathaniel Hickman aged 44 years, a resident of the City of Baltimore, county of.....

State of Maryland, who, being duly sworn according to law, declares that he is the identical Nathaniel Hickman Private who was ENROLLED on the third day of November, 1863, in Company (H) of the 73 Regiment of United States Col. Irs commanded by Capt Russel Hall

and was honorably DISCHARGED at Indianola Texas on the 13th day of October, 1866; that his personal description is as follows: Age, 18 when enlisted years; height 5 feet 4 inches; complexion, black; hair, black; eyes, black

That while a member of the organization aforesaid, in the service and in the line of his duty at Benedict Charles Co, in the State of Maryland on or about the last day of November, 1864, he had Pleurisy & Pneumonia having Rheumatism in left side

Pleurisy Pneumonia Rheumatism of left side, arm and leg
Hemorrhages & Cough, Bleeding of the Teeth, Gums and Swelled
Throat, Scurvy, Rheumatism generally, Hemorrhage of Lungs

That during November the last part of the year 1864 had Pleurisy & Rheumatism & Pneumonia which left him with Rheumatism in left side, arm and leg, also hemorrhages while drilling in Jacksonville Florida his Dr was Dr. Bell in 1867 of Dr. Drummond's accom. Co. Dr. Bell, Dr. Bell, Corner of Sharp & the street Baltimore attended him for Rheumatism & general Complaints in 1873

That he was treated in hospitals as follows: Benedict Hospital at Maryland County Maryland under treatment of Dr. Stewart

at Indianola Texas by Dr. Morris attacked with Rheumatism at Deep Bottom Va was very sick in Fort Harrison Va was in Bomb proof sick house Petersburg in camp, also at Milton Mead standing under the Dr. & in Fort of Charleston S.C. also when Regiment to Camp Baldern Va.

That he has..... been employed in the military or naval service otherwise than as stated above

Here state what

the service was, whether prior or subsequent to that stated above, and the dates at which it began and ended.

That since leaving the service this applicant has resided in the City of Baltimore (most of the time) in the State of Maryland, and his occupation has been that of a porter & white trash when able

That prior to his entry into the service above named he was a man of good, sound, physical health, being when enrolled a domestic servant. That he is now totally disabled from obtaining his subsistence by manual labor by reason of his injuries, above described, received in the service of the United States; and he therefore makes this declaration for the purpose of being placed on the invalid pension roll of the United States.

He hereby appoints, with full power of substitution and revocation, F. E. P. Brooke his true and lawful attorney

to prosecute his claim. That he has not received not applied for a Pension. That his
