DECLARATION FOR ORIGINAL INVALID PENSION.

personally appeared before me, Deputy Clerk of the Superior Court, a court of record
within and for the county and State aforesaid, Nathaniel Hickman, aged 39 years,
a resident of the City of Baltimore county of _____

State of Maryland, who, being duly sworn according to law, declares that he is the
identical Nathan Hickman, who was ENROLLED on the 3rd day
of November, 1863, in company (H) of the 7th regiment of U.S.C. Troops
commanded by Capt Russel Hall, and was honorably DISCHARGED at

Indianola Texas on the 13th day of October, 1866; that his
personal description is as follows: Age, 39 years; height, 5 feet 7 inches; complexion, dark;
hair, dark; eyes, dark. That while a member of the organization aforesaid, in the service

and in the line of his duty at Benedict, in the State of Maryland
on or about the Last day of November, 1864, he had Pleurisy
