in the service, viz: Rheumatism and resulting disease of heart & disease of lungs. Results of scurvy & asthma. Results of mumps & ch. diarrhoea. Deafness of left ear; partial loss of eyesight. Results of jaundice and effects. \$8.00. dollars per month.

He makes the following statement upon which he bases his claim for INCREASE

Here give the claimant's statement as briefly and as compactly as possible.

Claims rheumatism in the upper and lower extremities with pain and palpitation in the heart. Cough with shortness of breath Scurvy in the teeth. Diarrhoea in the summer. Slight deafness and partial loss of eyesight.

Upon examination we find the following objective conditions: Pulse rate, 84; respiration, 24; temperature, N; height, 5 feet 5 inches; weight, 140 pounds; age, 45 years. General physical condition is good.

Here give a full description of the disabilities, in accordance with pars. 5, 6, 51, 52, &c., of Book of Instructions for 1889

Rheumatism: No crepitation or deformity in the joints.

Complains of pain on handling in shoulders and knees.

Heart: Apex in the normal position: Action rapid and strong:

Some roughness of second sound of the heart. No valvular lesion

Chest: Measurements: Rest 34 1/2. Inspiration 35 1/2. Expiration 33 1/2... No depression in the clavicular spaces.

Lungs: Slight increase in vocal resonance over the upper lobe of right lung and also over the lower lobe posteriorly.

Respiratory sounds are harsh. Vesicular murmur faint.

No rales.. Slight wheezing on inspiration. No evidence of

Pleurisy. Probably suffers with Ch. Bronchitis with occasional attacks of Asthma.

Scurvy: No scars of scurvy ulceration on body:

Gums are spongy, slightly.. Mucous membrane of mouth is irritated. Teeth are all gone from the upper jaw except the central incisors, canine, and second molar with a few blackened snags.

Lower jaw: First bicuspid is missing and all the molars.

Alveolus is absorbed. Remaining teeth are much discolored.

Liver: Slightly enlarged and sensitive. No hemorrhoids.

No objective evidence of diarrhoea, or of jaundice.

Slight Naso-pharyngeal catarrh.

Ears: Hearing; right normal. Left; 4/40.

Eyes: Slight failure of vision due to age.

Left varicocele. Tumor is two inches in diameter; vessels the size of a small quill. Testicle somewhat atrophied.

No other disability.
