ordered that the 1st Guardians accounts under Act of assembly of 1820 of Frances Ann, Joseph H. and William E. Kirby ofphans children of Wm H. Kirby decd be received filed and recorded.

on application of J. H. Barber Adm^r of Thos C. Browne decd the Court extend the time of settlement of said decd Estate to 18 instead of 15 months, the same being an insolvent Estate.

ordered that Charles J. Sollaway Adm^r Sarah Sollaway decd give notice required by Law to the Creditors of decd to present their respective claims by causing the said notice to be published in one of the Centerville News papers.

Joseph Maffey Administrator and Mary Lane Maffey Administratrix of Wm H. Kirby decd this day returned a list of Disparate Debts due the said W. H. Kirby decd and has marked opposite each claim whether the same shall be paid on or not foreclosed upon according to his knowledge of the parties and what he believes would be to the interest and advantage of the Estate of the said Kirby. The Court have examined the said list of Debts and order it to be received and recorded and that the Administrators due or do not proceed on the said claims as they are respectively marked as afore said, the Court adopting the said marked or entries as the rule of action of the said Administrators.
