among those entitled to the same under the will, and that the residuum
in Cash divided among the children of James Callahan has been
obtained by your petitioner awaiting the arrival of age of the said children
of James Callahan - that he has recently been advised that there are errors in
said last account and in the distribution of the balance working injustice
to your petitioner and John Kests Jr who is a legatee under the said last will
and testament, that he failed to claim an allowance for the completion
of the building in the course of erection on the farm devised to the said
John Kests Jr at the time of the death of the Testator, which under the
directions of the aforesaid last Will and Testament your petitioner as executor
