

was authorized and directed to finish and to pay for the same out of the personal estate of the said deceased, He further failed to have distributed to John Keels Jr the amount of two separate debts returned by your petitioner as due from the said John Keels Jr and which your petitioner is advised belonged to and should have been distributed to the said John Keels under the provisions of the last will and Testament aforesaid from the fact that the single bill returned was for property furnished the said John Keels in setting up farming for which under the will he was not to be held accountable and the open account being for rent of farm which under the will he was ~~not~~ have free from any charge of rent whatever

That these several errors may be corrected and thereby justice be administered to all interested your petitioner prays your honors to direct said estate to be opened and that your petitioner be authorized and directed to pass a further account and distribution in conformity to this his prayer and under the direction of this Court as in duty bound he will ever pray &c

Upon the above petition being considered and their exhibition of certain necessary vouchers It is ordered and adjudged this twenty fourth day of February in the year Eighteen hundred and fifty two by the Judges of Queen Anne County Orphans Court and the authority thereof that the Estate of John Keels decd be opened and that the executor (Mathias George) pass another and final or administration account on said estate and make a new distribution of the balance thereof under the direction of this Court; that the errors stated in the foregoing petition may be corrected and that he charge himself with a additional assets if any have come to hand and be allowed for any further disbursements made by him according to Law.
