

WIDOW'S CLAIM FOR PENSION.

ON THIS 15th day of August, 1889, personally appeared before me, a Clerk of Circuit Court #2 of a Court of Record in and for the County and State aforesaid, Susan a resident of 852 McKim Street in the City of Baltimore and State of Maryland aged 50 years, who being duly sworn, makes the following declaration, in order to obtain the Pension provided by the Act of Congress approved July 14, 1862. That she is the widow of John Conner alias Robert Sidderman who enlisted as a Private in Co D. 1st Regt U.S.C.T. under the assumed name of Robert Sidderman in the War of 1861; that her maiden name was Susan Sherwood and that she was married to said John Conner alias Robt Sidderman on or about the 5th day of March 1878, at Baltimore in the City of Maryland by Rev Father M Wall and that she knows of no record evidence of said marriage. enclosed

SHE FURTHER DECLARES that said John Conner alias Robert Sidderman her husband, died at Baltimore City, in the State of Maryland, on or about the 2nd day of December, 1886 of disease of Kidney, resulting from chronic Colic and general debility contracted in the Military Service of the United States. She also declares that she has remained a widow ever since the death of said John Conner alias Robt Sidderman and that she has not in any manner been engaged in, or aided or abetted, the rebellion in the United States; and she hereby appoints George W. F. Vernon of No 108 N Paul Street Baltimore Md as her lawful Attorney, with power of substitution, and authorizes him to present and prosecute this claim. The following are the names, date of birth, and place of residence of all the children of her deceased husband who were under sixteen years of age at the time of his death: Mary E. Conner born August 12 1872, and John Conner May 29th 1883
