Be it remembered that on the eighth day of October in the year Eighteen hundred and Eight the following Deed of Mortgage was brought to be recorded to wit This Indenture, made this thirtieth day of September in the year of our Lord One Thousand Eight hundred and Eight Between Philip Reed of said County and State of Maryland of the one part and Samuel Ringgold and Tench Ringgold Trustees of a certain Thomas Ringgold both of Washington County and State aforesaid of the other part whereas the said Philip Reed by his Bond or Obligation duly executed bearing date on the twelfth day of December Eighteen hundred and seven stands bound unto the said Samuel Ringgold and Tench Ringgold Trustees as aforesaid their certain Attornies their Executors Administrators or Assigns in the sum of twenty two thousand four hundred dollars Current Money of the United States with a condition thereunder written for the payment of the sum of seven Thousand two hundred Dollars Current Money of the United States with legal interest thereon in manner following that is to say the sum of one thousand four hundred and forty dollars one fifth part thereof with legal interest on the whole sum from the first day of January next ensuing the date above written on or before the first day of January which shall be in the year Eighteen hundred and nine the like sum of One Thousand four hundred and forty dollars one other fifth part thereof with legal interest on the whole sum then due on or before the first day of January which shall be in the year Eighteen hundred and ten the like sum of One Thousand four hundred
