Sudden Death Of Wm. McKenney.

William McKenney, one of the most representative citizens and biggest financiers in Queen Anne's county, died suddenly at his home in Centerville, at 10:30 Saturday night. Mr. McKenney was president of the Centerville National Bank and for many years had been actively connected with the Maryland State Bankers' Association. He was president of the board of trustees of the County Almshouse and was vestrman of St. Paul's P. E. Church.

Mr. McKenney had been at his office working. He dropped dead in the bath room of his home, death being the result of an attack of acute indigestion. He suffered from an attack of this malady a few weeks ago. Mr. McKenney was born in Centerville, December 7, 1872. His father was the late Gen. William McKenney, who died in 1897. His mother was Miss Eleanor Ridegley Goldsborough, who died in 1877.

In addition to his widow, Mr. McKenney leaves three children, William McKenney, Jr., Miss Maria McKenney and Miss Elizabeth McKenney. All are residents of Centerville, though the last named at present is away at college. The deceased was a liberal man, always took a great interest in all that pertained to the uplift and advancement of his town and county. The funeral took place on Tuesday afternoon from the P. E. Church and was one of the largest attended in the history of Centerville.

Death Of A Fine Lady.

Died at her residence, 1302 McCulloch St., Baltimore, on Friday, June 3, Harriet L. Westcott Hill, aged 84 years. Mrs. Hill was the daughter of the late George B. and Mary Anne Hinson Westcott and until her marriage lived in Chestertown. At an early age she married the late Thomas Hill, of Baltimore, and has since made her home in that city. She is survived by two sons, Malcolm W. Hill and Norman A. Hill, and seven grand-children. Mrs. Hill was refined and cultured in the highest degree. She was possessed of a brilliant mind and until enfeebled by age wrote a great deal of work. Her most active work pertained to the uplift and advancement of her country. For many years she was Regent of the D. R. of Maryland and did much historical research. Kent county is indebted to her giving to the present generation many of the interesting events of its past history. She was one of the most active workers in the erection of the monument at Caulk's Field and the tomb of Philip Reed at U. S. She gave the tablet in St. Paul's Church, containing the names of the original vestry of that parish. She always retained the deepest interest for her native county and was one of the most active workers who will feel deeply her loss. Her funeral took place at her home on Monday at three p. m., interment in Greenmount Cemetery.

TO MAKE RURAL SURVEY

In an effort to meet the more apparent and immediate needs of the farm women for improved home and community life, the Home Demonstration Department of the University of Maryland Extension Service, is making a survey of rural home conditions over attempted in the State. Miss Venia M. Kellar, State Home Demonstration Agent, who is directing the survey, has prepared a questionnaire of 77 questions which will be distributed through the home demonstration agents in each county and thru farm women's organizations. The questions are so worded that they can be easily answered and the replies, it is expected, will be fairly representative of general conditions throughout the State. Primarily the survey is designed to discover the types of home demonstration work which may be most effectively carried on in the various communities. It should answer, however, many other questions about rural life which are now more or less matters of speculation. From the replies, it should be possible to form a more accurate idea of the real value of the work which the farm women are performing and of the conditions under which she is working. For instance, it may be possible to summarize from the answers, the percentage of farm homes which have modern improvements and are equipped with the numerous labor saving devices which are common in city homes. Miss Hill has distributed 100 questionnaires in this county through the various organizations. June the 10th is the date set for the completion of this survey and in a survey of this kind in which the primary aim is for the betterment of farm home conditions 100% report is expected.

The object of the Bill is to procure a decree of order with reference to the corpus of the Trust funds created by the last will and testament of John Whittington, deceased. THE BILL STATES: First—Your Petitioners show that the said John Whittington of Kent County, Maryland, by his last will and testament, duly executed, devised to the first place in Wills Liber E. Crouse, No. 1, Folio 177, etc., certified copy of which will is filed among these proceedings, being marked "A," and numbered 1, a sum of money to be paid to the said Corinne Stout and bequested to my son John F.
