LOCAL MATTERS.

Colt Killed.—Mr. William D. Shinn had a valuable yearling colt killed by lightning last week. The suffering animal did not die until the following day after being struck by the bolt.

Will Open Early.—The present prospects are for a heavy tomato crop and an early opening of the Kent county canneries. Mr. William H. Brown, representing George N. Numsem, states that the outlook is for a heavy crop of fine fruit. He thinks that the Kent county packers will commence work in two weeks.

Dust Say Commissioners.—The time for receiving bids to operate the town sprinkler expired on Wednesday night. Up to that time no bids were received, and with a \$600 sprinkling outfit on their hands, the commissioners see no way to start the sprinkler. It now looks as though we will feast on dust during the summer and fall.

Caught Big Fish.—Mr. Kennard Carter harpooned an 18-pound rock fish from Chester bridge on Friday. The fish measured 3 feet in length. The big fellow during the entire day could be seen in the vicinity of the bridge and created considerable excitement among bridge fishermen. Mr. Carter sold the fish to Mr. James T. Anthony for \$1.00.

Shooting Accident.—Baynard Gale, the 16 or 17-year old son of Mr. and Mrs. Walter Gale, accidentally shot himself in the fleshy portion of the leg on Saturday. Young Gale was handling an old rusty weapon when in some way it was discharged inflicting a painful but not serious wound. The injured boy was hurried to Chestertown and the wound was treated by Dr. H. L. Dood.

Granted a Divorce.—Mary J. Maslin, employed in a shirt factory in Baltimore, was granted an absolute divorce on Tuesday from Frank M. Maslin, custody of their child, a daughter 8 years old, and \$150 a week alimony until the child is fifteen years old. They were married April 24, 1893, in Kent county, and separated in October, 1900. The divorce was granted for unfaithfulness.

Mr. Copper Injured.—Deputy Treasurer Whittier C. Gopper made a narrow escape from serious injury on Monday by the wrecking of his bicycle. Mr. Copper had just ridden into town and when in front of the post office the frame of his wheel gave way, throwing the rider with great force to the ground. Injuries were sustained on one leg, and one shoulder was badly bruised.

Apple Shipments.—Not in many years have the shipments of apples from Kent been so heavy as during the present season. Thousands of baskets have gone to market and the crop is far from being entirely gathered. An official of the Chester River Steamboat Company said: "We have never before carried as many apples from Kent." Mr. William S. Collins and Mr. Romie Byron are the heaviest shippers from Chestertown.

Will Burn the Note.—The two hundred and fifty dollar balance of the indebtedness of the Kennedyville M. P. Church, for the remodeling of the church and for some other purposes, has been paid and Pastor Rowe expects to burn the last evidence of such indebtedness, in the shape of a trustees' note, at the conclusion of the morning services, on Sunday next, August 3. This will be a joyous service to both pastor and people.

Summary Justice.—Justice Melvin dealt out prompt and substantial justice to Samuel Ferris, on Monday. Ferris was charged with assault upon Richard, the 11-year-old son of Mr. J. A. Kennard, and for assault upon the boy's mother. For the assault upon Mrs. Kennard the justice imposed a fine of \$1 and cost or ten days in jail. For the assault upon the boy the fine was \$10 and costs and thirty days in jail. Ferris is a basket maker from Delaware.

Miss Hobbs' Resignation.—Miss Katharine K. Hobbs, A. M., principal of the Normal Department at Washington College, has resigned to accept the vice-principalship of the New Normal School, at Frostburg. No action has as yet been taken by the board of visitors and governors on the resignation. No appointment has yet been made to fill the vacancy caused by the resignation of Miss Edith R. Riley, A. B., who has accepted a position in Alabama.

Women Baseballists.—The novelty of women baseballists will be seen in Chestertown on Tuesday next. The Chicago Stars, an aggregation of young women which has defeated the strongest teams on the Eastern Shore, will play against a team composed of the strongest of our local players, on the college campus. These stars of the Washington College champions, —Burris, Massey, Brice, Crew, Jefferson, Bennett and Tarbuton, will be supplemented by Capt. Eldridge Ellison of the Princeton team of a few years ago, and will constitute the home team. The Chicago Stars will come in their own \$10,000 special pullman. They defeated the strong Dover team 6 to 4 in a ten-inning game.

Interesting Phenomena.—Editor Aker, of the Queenstown News, notes several unusual facts in connection with life in the waters in the vicinity of Queenstown. The supply of crabs, both hard and soft, has not reached a quarter of the usual amount up to the present time. Something very unusual is that so far there have been no sea nettles in the waters at all, although they generally put in their appearance about the first of July and by this time the water is usually full of them. The third unusual occurrence is the fact that sea grass has made its re-appearance in the creeks and rivers after an absence of about 14 years. Up to about 1888 most of the shallow water in this section was covered to a depth of about six feet with long grass or weeds. This disappeared and very little has grown until this year.

Caught Under Landslide.—A workman on the B. & D. B. Railroad was seriously injured in a landslide this week. The man, who was about sixty years of age, was at work with the repair train in a gravel-bank between Lynch's and Kennedyville. The bank had been undermined and at an unexpected moment a great mass of earth fell catching the man under it. Fortunately for him his head was caught against a car, otherwise he would have been entirely covered by many tons of earth. As it was, only his mouth and nose were left uncovered, but this was sufficient to prevent suffocation. By the most diligent work it required twenty-five minutes to extricate him. He was painfully bruised and it was feared had sustained internal injuries. Dr. Barwick, of Kennedyville, was summoned and rendered medical aid.

The Tomato Aphis.—So far as can be learned the aphis, a new enemy of the tomato, which is doing great damage to the crop in New Jersey, has not made its appearance in the Kent county patches. Nor has the aphis put in an appearance at any point on the Maryland and Delaware peninsula. A Delaware exchange says: "Our farmers can congratulate themselves that the 'tomato aphis' has not struck Delaware yet. New Jersey has a new pest to contend with and tomato growers are distressed over the appearance of what threatens to destroy their crops. The tips of the plants are covered with large size insects and among these is appearing a large linden slug. The insect is what is known as the 'tomato aphis,' which lives on the juices of the plant, and the slug is a larva and a voracious feeder upon the aphis only. This larva is friendly and calls for protection. The perfect insect wages a no less relentless warfare and is possessed of an insatiable appetite."

*Potatoes have been clearing the grower less than 50 cents per barrel in the Baltimore market. They have been clearing 45 cents per basket in Chestertown.

*An Easton brick manufacturer will furnish 20,000 bricks to the commissioners of Chestertown.

*The teamsters at the Strawboard mill did not strike for a raise in wages, but for a uniform day. The matter has been satisfactorily arranged and the men have returned to work.

The Cannon street warehouse belonging to the Isaac Robinson Company is being torn down for use in building quarters for Bohemians at the Chestertown and Still Pond canneries.

*Fritz Johnson, a colored boy who left Chestertown about ten years ago, is reported to be president of a Philadelphia bank having a capital stock of \$70,000.

*Mr. H. H. Klinefelter, in Queen Anne, is having Mr. Frank M. Miller put his cannery in order for work this season.

*Mr. W. C. A. Thompson made a big catch of fine perch and rock fish down the river, on Monday.

*The barn on the Clark farm was struck by lightning, but was not seriously damaged.

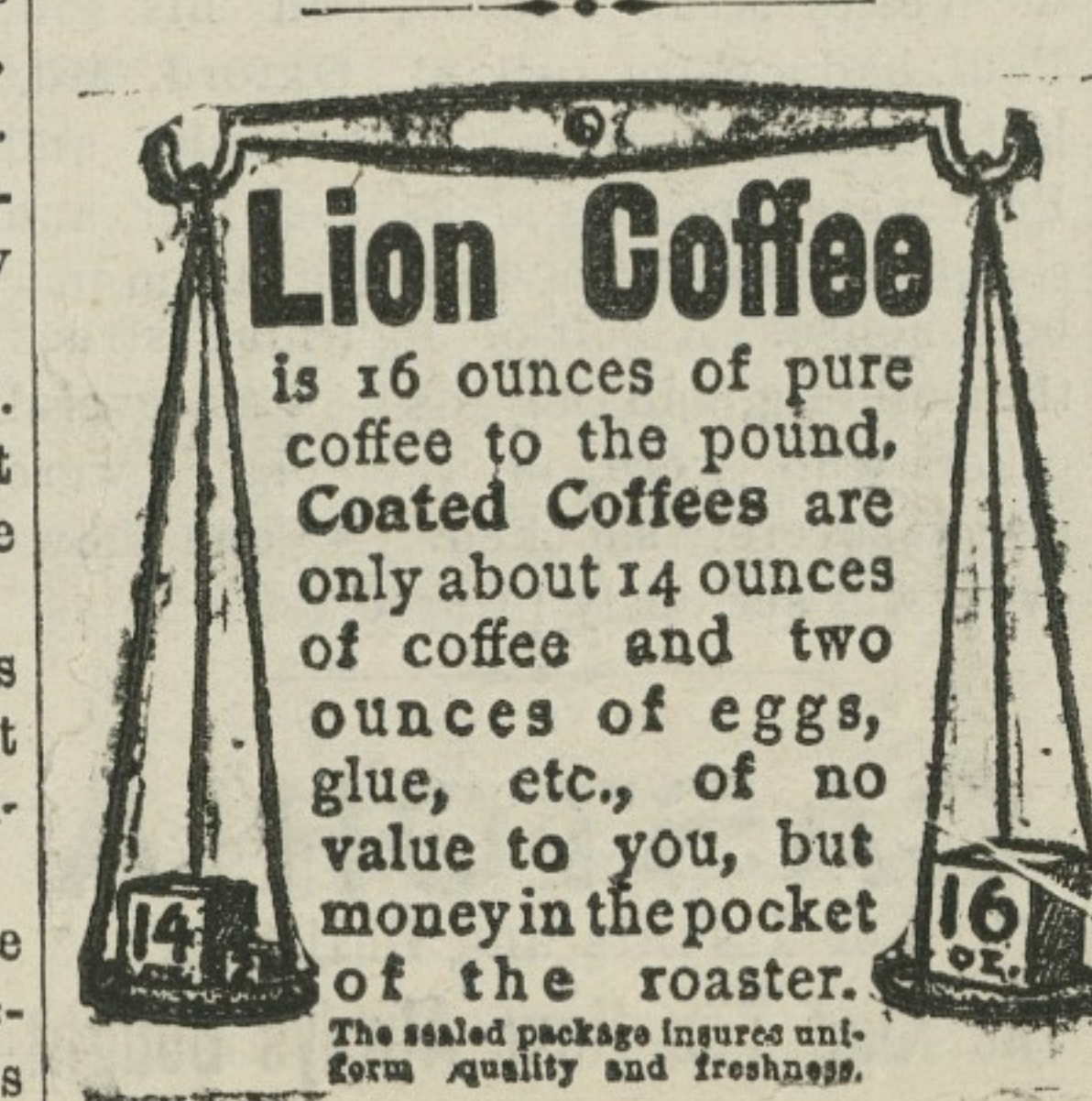
Wheat—The arrivals of southern wheat today were slightly freer than on yesterday, and the market 1 cent firmer at the opening. Demand fairly good and steamer No. 2 red in relatively better request, this resulting in sales, where No. 2 red and steamer No. 2 were sold in connection at 1 cent over the price of No. 2 red, where sold independently.

For example, sales on grade were made 73 1/2 cents for No. 2 red, 71 1/2 for steamer 2 red, and 68 cents for rejected, while cargoes No. 2 red, sold separately, at 72 1/2 cents and steamer No. 2 red at 71 1/2 cents.

Corn—The arrivals of southern corn today were confined to a few bag lots of white, which sold by sample at 67 cent's. Market inactive and easier. Quote prime yellow at nominal at 67 1/2 cent's. Demand for corn tame at the moment.

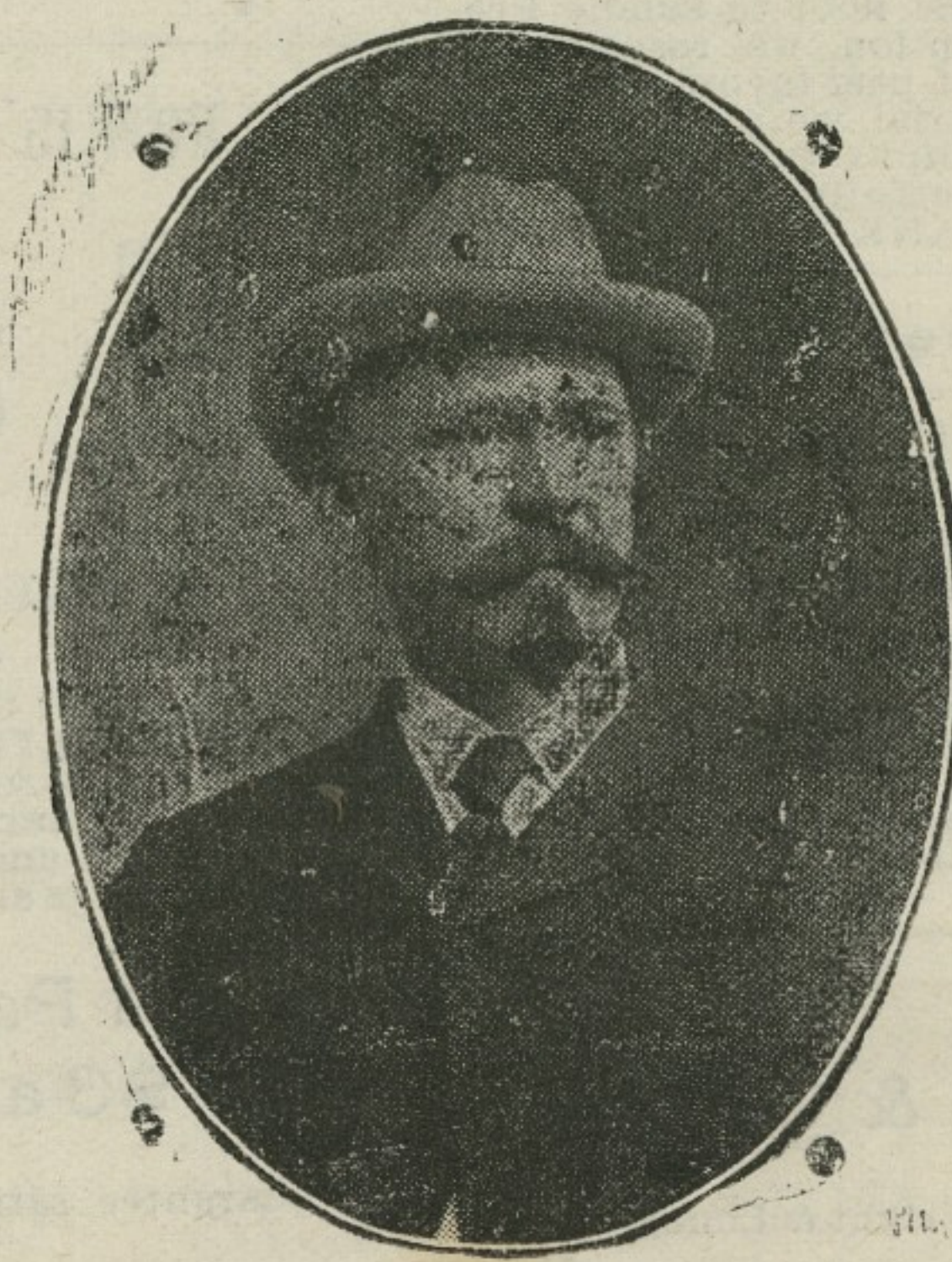
