LOCAL MATTERS.

The Coldest.—The coldest point reached by the mercury during the present week was 19° at 8 o'clock on Tuesday night. By 9 o'clock the mercury had raised two degrees. This is the record of the government spirits thermometer at the home of M. deK. Smith, Esq.

A Rural Mail Box Order.—An order has been issued by the Post Office Department to the effect that the use of wooden boxes along the rural mail delivery routes should be abandoned after December 1. It provides that only substantial tin or metal boxes shall be used, and that all boxes on the same rural delivery route shall be substantially alike.

Horses Selling Law.—Stock and farming implements at the sale of Mrs. Lillie Strong and Capt. C. A. Leary sold only fairly well this week. Horses on both occasions sold low. The immediate demands of Kent county farmers are practically met and the season of high priced horses is considered about over for some months. Good stock, however, should continue to bring good prices.

Off For the South.—Mr. Thomas J. Willis will leave on Tuesday for Jacksonville, Florida, where he will spend the winter. A young man who spent some time at Mr. Willis' home years ago went to the Southern city and made money, and now, after repeated invitations the Kent county fruit-grower, will pay a long-intended visit to his friend in the land of oranges and flowers.

Cecil Cases in Kent.—With the McKenzie-Tome Institute damage case disposed of and the damage case of Gathers against the P. W. & B. R. R. set for trial at the April term of the Kent county court, another \$10,000 damage case, that of Mrs. Agnes Edmunds against Chesapeake City, has been moved from Elkton to this county. These removed cases are luxuries which come a trifle high.

Heavy Corn Yield.—Mr. John P. Nicholson has housed a crop of corn which will in all probability not be surpassed in Kent county this year. By actual measurement Mr. Nicholson's crop is 80 bushels of marketable corn per acre. "Doc" William Cooper reports a crop of 3,800 bushels off 60 acres. From 20 acres of the 60 he harvested 271 barrels or 1355 bushels. His average on the entire 60 acres was 55 bushels per acre.

Chester River Draw.—Though it is not officially stated, it is understood that the board of commissioners will not have the draw of Chester bridge turned off until after the Christmas holiday. When it was fully appreciated what the proposed interruption to travel across Chester bridge meant at this season of the year, both to the merchants and other business men of Chestertown, as well as to those who use Chester bridge, it was decided to wait until after the new year to commence work. This is a wise move on the part of the commissioners board.

This Young Lady Can Shoot.—Miss Estella Crew, daughter of Mr. Jas. T. Crew, proprietor of Hotel Betterton, is not only one of the most accomplished musicians in Kent, but has an enviable record as a marksman. Miss Crew on Saturday determined to try her double barrel buck loading gun at wild ducks, on the ducking grounds of the Chesapeake, near her home. During the trip two fine ducks took to wing within range of her gun, and she brought both down in quick succession. Miss Crew treated the incident very much as a matter-of-course, though she had done what half the gunners of Betterton would have failed to do had they tried.

Big Corn Husking.—The recent mention in the Transcript of "big" corn husking and other "big" things in Kent, has given rise to many reminiscences of "big work in yonder times." Mr. William Ford and Mr. Frank Lamb have indulged in this pleasant but sometimes depressing diversion and vouch for the assertion that Mr. John Lusby, in a wager with Mr. Solomon Spear, husked 16 barrels of "snapped" corn in one day. Mr. Spear husked 15 barrels. Mr. Lamb says that the old-time corn husker could keep an ear of corn in the air all the time. Several practical farmers think it not impossible to husk thirty ears of "snapped" corn per minute.

A Genuine Surprise.—Two weeks ago Mr. Thomas G. Wroth, "the shoe man," advertised that he would give away every hundredth pair of shoes, it mattered not what the amount of the purchase or who the purchaser might be. On Friday of last week a young lady came in and selected a pair of ladies' shoes. Nothing was said of the fact that it was the hundredth pair of shoes sold since the offer was made, until the package was wrapped and Mr. Wroth had received the money. He then handed her both the shoes and the amount of the sale. The fair purchaser's amazement may be more easily imagined than described.

Dr. Schwatka's Escape.—Dr. J. B. Schwatka, of Baltimore, son of Mr. John A. Schwatka, of Rock Hall, had a narrow escape from serious injury on Saturday afternoon about 5.45 o'clock, while driving on Eager street, near Greenmount, Baltimore. Just as the carriage crossed the railway tracks at the corner, car 742 of the York Road line crashed into the vehicle, overturning it and knocking down the horse. Dr. Schwatka was thrown heavily to the ground, but was able to go home unattended. The carriage was damaged about \$25 and the fender of the car was broken.

Will Not go to Ridgely.—Mr. E. E. Gambrill, who has been negotiating with the authorities at Ridgely, Caroline county, with a view to starting a textile mill at that place, has decided to remain as superintendent or manager at the Unicorn Mills, near Millington. Mr. Gambrill stated that in the event of his establishing the plant there, he would expect the town to exempt the plant from municipal taxes for two years and a building furnished free of rent for one year, and pay freight on the machines from Philadelphia to Ridgely not exceeding \$150.

*Glover Greenwood has purchased of John D. Urie, Esq., a small dwelling at the foot of Cross street.

*Bad, very bad roads prevailed the earlier part of the week.

*Philemon Lloyd has been appointed by the commissioners' board of Cecil county, keeper of Sassafras river bridge.

AFTER THE GUNNERS.

What Will Become of This Wild Goose Chase?

As a sequel to the recent trick played by Dr. William Hunt, of Frankford, Pennsylvania, and his associates, upon officer Charles L. Gill, States Attorney John D. Urie has had the Governor of Maryland issue requisition papers upon the Governor of Pennsylvania for the extradition of Dr. Hunt and his friends. The Frankford physician is charged with having attempted to bribe Constable Charles Gill, who made the arrest in the first instance.

The case grows out of the violation of the gunning laws of Kent county, the particulars of which have been published in a former issue of the Transcript. The accused and a party of friends visited Kent as the guests of Mr. Hazazar, on Plum Point, on a gunning expedition, without the necessary license. They were arrested by Constable Chas. Gill, who allowed them to return to the home of Mr. Hazazar upon their promise to appear in Chestertown the next day for a hearing. Instead of keeping their promise the gentlemen took the first boat at Betterton for Philadelphia, and have since refused to appear in answer to warrants issued. Mr. Gill says that Dr. Hunt offered him money to be allowed to go free, and upon his affidavit to this effect Gov. Smith has signed and caused the extradition papers to be executed. The papers have been placed in the hands of Sheriff Fletcher, but no definite action has been taken.

Apart from costing the county a goodly sum, Mr. Urie's fee and other costs there is little probability that anything will result from the chase after the Pennsylvania sportsman.

MRS. SARAH A. WELCH.

Mrs. Sarah A. Welch, wife of Dr. William H. Welch, of Washington, D. C., died at her home in that city on Sunday afternoon, of heart trouble, in the 64th year of her age. She was a daughter of the late Col. Joseph Wickes, of Chestertown, and a sister of Judge Joseph A. Wickes, of Chestertown, and Judge Pere L. Wickes, of Baltimore.

A husband and four children survive her. The children are: W. H. Welch, of Washington, D. C.; Joseph W. Welch, of New York; George L. Welch, of Philadelphia, and Mrs. George B. Fife, of New York.

Funeral services were held at her Washington home on Tuesday evening, and were attended by Mr. Lewin W. Wickes and Miss Josephine Wickes, of Chestertown. Judge Joseph A. Wickes has been confined to his bed for several weeks by sickness. The interment was made in Greenwood cemetery, Brooklyn, N. Y. on Wednesday morning.

MR. CONRAD'S RECITAL.

This Talented Musician Will Again Play in Chestertown.

Mr. Luther Conradi, the talented Baltimore pianist who last year delighted a large audience by his playing in Stam's Hall, will, it is expected, give a second recital during Christmas week, the proceeds to go into the treasury of the Chestertown Ladies' Improvement Society.

Mr. Conradi's recital last year was one of the most delightful as well as one of the most notable events within the musical history of Chestertown, and his reappearance this season will doubtless be the occasion for a great outpouring of lovers of classical music in Kent.

On Saturday afternoon last he gave the first of a series of private afternoon recitals at Music Hall, Baltimore. At this concert the pianist had the assistance of Dr. Thomas S. Baker. The program was devoted entirely to the works of Chopin and included many of his best known compositions.

The Baltimore Sun said: "He did ample credit to his growing reputation as a conscientious and talented player."

Mr. Baker sang three songs of Chopin and did what was possible to make them interesting. But Chopin as a song writer is not a success, largely due to the fact that the rhythm of his music cannot be fitted to either English or German text. The accompaniments were played by Miss Elizabeth Moore.

Mr. Conradi has recently been engaged to play with the Philadelphia Orchestra and will appear in February in York, Pa.
