TOMATO CONTRACTS.

Important Decision Rendered by Judge Lloyd at Cambridge—Contracts Being Made For 1903.

The Canning & Mercantile Co. and several other canners have agreed on \$8 per ton, the same as last year, as the price to be paid for growing tomatoes in Kent county this season. The tomato crop in this county last year proved to be one of, if not the best paying crop raised by our farmers. The tomato is to a large extent making up to our agriculturists the loss of the peach crop which was so extensively and successfully grown here for many years, but which has now become almost extinct because of the yellows which made its appearance in the county some eight or ten years ago.

What is regarded as a most important decision and of special interest to growers and canners throughout the State was handed down by Judge Lloyd at Cambridge, last Friday, in the case of Charles Webster against Isaac H. Wright.

The case involved the right of Webster to the entire crop of Wright for 1901 at 10 cents per basket. There was only a verbal contract between the parties. Wright delivered to Webster 500 baskets of tomatoes at 10 cents per basket, and when the price in open market went to 25 cents per basket he began to sell elsewhere.

Webster brought suit against Wright, asking for specific performance of the contract: that Wright be restrained from delivering his tomatoes elsewhere, and alleging that such delivery would inflict irreparable injury on the plaintiff, as he could not secure tomatoes to supply the deficiency in his pack elsewhere.

Judge Lloyd granted a preliminary injunction restraining Wright from delivering his tomatoes to any one else, Webster giving bond to indemnify Wright in case the defendant won.

Wright held that no contract existed, and that he had the right to sell his crop to whom he pleased. Judge Lloyd ruled that a contract did exist; that there was no sufficient supply in the market from which Webster could be supplied the deficiency in his pack; that Webster's right could be enforced by injunction; that Wright should account to Webster for the tomatoes which he had delivered to other parties before the injunction was granted, paying as his damage the difference between the contract and market price for tomatoes.

The past year has been a favorable tomato year for both growers and packers. The year to come promises now to be equally favorable to both the growers and packers, and already they are making preparation. We hear of a very large acreage to be put into the tomato crop throughout this section of the Eastern Shore. In Queen Anne's canners are now contracting at \$7 and \$7.50 per ton.—*Queenstown News.*

BUSINESS CHANGE.

Mr. R. Bergen has sold out. This announcement was made to the Chestertown public this week, and it caused quite a ripple of interest in business circles. The stand where Mr. Bergen has conducted business is one of the most conspicuous in the town, the business itself one of the largest, and the face of genial Ralph one of the most familiar in that section of our city. The prospect of a change, then, was sufficient to set tongues a-wagging. Mr. Bergen started business in Chestertown in 1883, just 20 years ago. He came to Kent from Baltimore where he had gained enough experience by clerking in a dry goods store to start him on the road to a successful business career. He opened up on the corner now occupied by Chas. S. Smith, where he remained for six years. His wife conducted a millinery business at the same time in the room now occupied by J. H. Sides as a jewelry store. Their rapidly increasing business made their quarters too small, however, and when Wm. T. Wright closed his business in the house where J. B. Burchinal had conducted a store previously, they moved in there where they have remained ever since. Combined, Mr. and Mrs. Bergen have built up by industry and strict attention to business a splendid trade. By strict business methods both have gained a host of friends, and pride themselves upon the fact that their enemies are represented by the zero sign. Mr. and Mrs. Bergen will remain here about six weeks, when they will remove permanently to the city. Their handsome home property, purchased in 1890, will be on the market, and some one will be given a chance to buy a most desirable house and lot.

Mr. and Mrs. Bergen leave with the good wishes of the community, and it is to be hoped that when they take their departure it may not be the last seen of them in Chestertown.

Mr. Arlington L. Sparks, senior member of the new firm of Sparks & Jefferson, who have purchased the business of Mr. Bergen, has been head clerk of the Bergen firm for 11 years. He is about 28 years of age, a native of Queen Anne's county and a son of Mr. Samuel E. Sparks, of Crumpton, Md. Mr. Sparks' connection with the business has, of late years, been almost as prominent as that of his employer, and his close attention, unremitting diligence and accommodating spirit will undoubtedly retain all the customers of the old firm, and it is to be hoped secure him many more.

Mr. Harry F. Jefferson, the junior member of the new firm, is a son of Mr. Charles H. Jefferson, of Queen Anne, for years a judge of the Orphan's Court of that county. He is about 25 years of age, and has been up to the present employed in the office of Mr. Wilbur W. Hubbard, manufacturer of fertilizers. Mr. Jefferson is a young man of good business capacity, fine address and we predict for him success in his new venture.

The change from the old firm to the new was completed on Wednesday, February 4, 1903, and the two young men invite the patronage of the community, promising the same fair treatment always accorded those who have been in the habit of patronizing the stand.

SWEPT BY CYCLONE.

Chestertown experienced the tail-end of a cyclone last Wednesday evening. Dark purple clouds appeared in the western sky, threatening in their peculiar formation, and lighted up by flashes of lightning, which were followed by peals of thunder, most unusual phenomena at this time of the year. Between six and seven p. m. wind struck Chestertown and blew with terrific force. On college hill it was specially noticeable, and it roared and tore around the buildings with an awful noise. News reached here between 7 and 8 o'clock p. m. that Wilmington, Delaware, had met the full force of the storm; that about 100 buildings had been wrecked and numbers of persons injured though none killed. The *Evening Journal* has the following to say about the storm in Wilmington: "A cyclone of but one minute's duration visited this city last evening shortly before 6 o'clock, leaving over 100 unroofed and wrecked houses in its wake. A number of people were injured but no serious cases have been reported.

"The storm was heralded by a terrific downpour of rain and hail followed by the fast approach of an immense black cloud coming from the south in a north-easterly direction. Lightning played in the heavens and thunder crashed at short intervals. The wind, which had been dead but a short time before, attained a fearful velocity, sweeping along and carrying destruction in its path. Houses were unroofed in a twinkling, trees twisted like so many straws, and in some instances the entire upper stories of buildings were cut away, the debris flying through the air and crashing with loud reports upon other structures and in the streets.

WILLS PROBATED.

In the Orphans' Court on Tuesday the wills of Mrs. Mary J. Archibald and Mrs. Caroline Bennett were probated and their executors duly qualified. Messrs John M. and James Archibald are the executors for their mother, and Hope H. Barroll, Esq., is executor for Mrs. Bennett. Mrs. Archibald's will devises, after the payment of her just debts, her estate as follows: To her daughter, Rachel Archibald Hill, she bequeaths the house and lot in Kennedyville, also all the furniture in same, including piano, and also all money and other property of every kind, character and description whatsoever, whether real, personal or mixed, except a life insurance policy of \$2,500, dower rents and silversware. She gives and devises to each of her children all dower rents or arrears of dower which may be due her by them at her death.

She leaves to her son, William, \$1000 which is to be held in trust for him by her daughter, Mrs. Rachel Archibald Hill, and the proceeds of same are to be paid to the said William and to no other, but if in the discretion of Mrs. Hill she should deem it wise, she may pay any part or the whole sum of the \$1000 to the said son William. But if the said sum of \$1000 is never paid to the said William and he should die without issue, then the said \$1000 is to be paid to her two sons, John M. and James, if living, if not, then to their issue, share and share alike.

To her son John M. and James Archibald, she leaves \$500 each of the insurance money, and \$100 to her daughter, Mrs. Anna M. Hurlock, and the remaining \$400 is to be used for the payment of her funeral and other expenses and debts except those for which she is surety for her son William. All her silverware she leaves to her daughter, Mrs. Annie M. Hurlock, except her knives, forks and spoons which she bequeaths to her grandson, Harry Archibald Hill.

The will of Mrs. Caroline Bennett disposes of her estate as follows: The proceeds of her life insurance policy is left to Mr. Sam'l Burgess to be applied to the payment of funeral expenses and should any be left after said expenses, are taken out, she devises it to her daughter, Mrs. Mary R. Jester. The remainder of her estate is left one third each to her daughters, Mrs. Mary R. Jester, and Mrs. Annie G. Wilhelm and the children of her daughter, the late Mrs. Sophia H. Greenwood. The latter is to be held in trust by the Orphan's Court.

SPORTING NOTES.

Yale's champion gymnast this year is a Cuban, L. deSola, of Havana. This honor fell to the lot of our young townsman, Eldridge Eliason, in 1901.

Baltimore will probably be represented this year in the Eastern League, a minor professional league of ball players. Edward Hanlon, a former Baltimore manager, now managing the Brooklyn club, will probably be at the head of the team, ably assisted by the prince of ball players familiarly known as "Robbie" Wilbert Robinson. Some persons think, however, that Hanlon is providing a way of escape in the event of the American League's establishing a club in New York city. He may think three clubs are too many for Greater New York, and it is just possible he may transfer the Brooklyn club to Baltimore, thereby giving that city a franchise in the National League.

The mild weather which preceded the cold snap of the last few days brought out on the ball field some of the talent from which the college team will be selected this year. Outside a battery the team will probably be better than last year. No losses have been sustained which cannot be well supplied. Trutt will probably play Noble's position, and Crew will take Gunby's place at second. This, with Massey and Burris will make a strong infield. Jefferson will probably be transferred from centre field to left and the other two positions will be supplied from Carmine, S. Beck, H. Leck, Schutz, Garey, Moore and others. The old reliable back stop, Marine, will be back probably, and with a good pitcher, the team would be hard to beat.

Rival Telephone Lines.—The Diamond State Telephone Company is experiencing some trouble in the lower section of the Eastern Shore of Maryland and Virginia in getting possession of all the lines down in Worcester and Somerset, Md., and Accomac, Va. The Pocomoke line is extending its wires to Crisfield, and it already has its lines in Virginia, which territory it controls. The Pocomoke line, as stated in a former issue of the Transcript, belongs mainly to Dr. W. H. Walters, a brother of Miss Nellie Walters, formerly of Chestertown, and at present teaching in Kent, near Kennedyville.

OBITUARY.

MRS. SUSANNA COLEMAN.

Mrs. Susanna Coleman, widow of the late Capt. James U. Coleman, died last Wednesday at the home of her son, Wm. B. Coleman, on Waterstreet. Mrs. Coleman was taken sick on the Friday before and succumbed quickly to the ravages of pneumonia. She was buried yesterday at 10:30 A. M. Funeral service were held at the house, conducted by the Rev. Dr. Greenfield, assisted by Rev. E. P. Roberts, interment at Chester cemetery. Undertaker Ferguson had charge of the funeral arrangements. The bearers were: Her three sons, James W., William B., and S. J. Coleman; William Ayres, William A. Wheatley and J. Frank Wheatley.

PROF. EDWIN R. JUMP.

Prof. Edwin R. Jump, principal of the high school at Oxford, Talbot county, Md., died of Bright's Disease, on Sunday last, at the home of his brother, Wm. F. Jump, Cordova, Md. Mr. Jump was a graduate of Washington College, class of '80, a bright scholar and good disciplinarian. He leaves four brothers, one of whom, Howard A., was also a graduate of Washington College, class '96. Mr. Jump was always devoted to his alma mater, and as late as last September visited Chestertown for the purpose of entering a student who had graduated at the Oxford High School.

WILLIAM ROGERS.

Mr. William Rogers, a former resident of Galena, this county, died at his home in Washington D. C., Monday night. His remains were brought to Kent county and interred in Galena cemetery. A. P. Prettyman and S. P. Shipman conducted funeral services Thursday afternoon at 1 o'clock. The deceased was for a number of years postmaster at Galena. He leaves three children, viz: F. B. and W. C. Rogers, of Philadelphia, and Mrs. William A. Whitaker, of Galena.

ANNE ELIZABETH PIERCE.

Anna Elizabeth, the ten-year-old daughter of Mr. and Mrs. T. A. R. Pierce, of near Black's station, died on Monday of gastric fever.
