CLARENCE W. PERKINS, Esq., a member of the Baltimore City bar and son of the late Eben F. Perkins, Esq., of Chestertown, was unanimously elected chairman of the Young Men's Democratic League, of Baltimore, Saturday evening last. This league will form an important factor in the coming fall campaign. Mr. Perkins is being urged by his city friends for the nomination for the State Senate from his district.

MR. THOMAS D. BOWERS, having finished his work at Havre de Grace yesterday, will hereafter be actively connected with the publication of the TRANSCRIPT. Mr. Bowers is a Kent county man, well and favorably known, and with a desire to identify himself with his native soil and its people, has decided to give up the profession of teacher and enter that of journalism. Backed by a thorough education, good business capacity, and youthful energy, the TRANSCRIPT feels justified in recommending him to the public and welcoming him as an associate editor of the TRANSCRIPT.

So well pleased were the trustees of the Havre de Grace school with Mr. Bowers' work as principal of that institution the past year, that they wrote to the Board of Directors of the Transcript Publishing Co., asking them to release him as one of the editors of this journal and let him return as principal of that school for another year. A petition signed by over 250 patrons of the school and tax-payers of Havre de Grace requesting his return, accompanied the letter. ### COUNTY FINANCES.

#### The Missing Link.

The story goes that once upon a time two little boys went out into the wood to look for berries. They had the consent of their parents, but with the provision that they should not wander away and get lost. But intent upon their mission and thinking not of the distance, they wandered so far into the woods that they were entirely lost. Night came, and their parents in the most desperate straits, set out with all the neighbors to find the lost babes. The wood was thoroughly searched, bells were rung and trumpets were sounded, and lo! and behold, when the children were found they were almost within the shadow of their own home. "Berry" and "Look" have something in common, because both words begin with "b" and the fact that a book has been lost suggests the analogy to the above story. Where has the book gone?

Mr. Blacklock, the expert accountant, who is investigating the county finances, found the "Levy Ledger" missing, and upon making a demand for the book to the County Commissioners, learned that it had mysteriously disappeared after having been in the possession of Messrs. Townshend and Willson during the period of their investigation, just a few weeks ago. The Commissioners state the book has been lost. Perhaps the book, like the babes, has gone out into the wood to look for berries. Now such a statement as this, coming from such a responsible body of men as the County Commissioners, seems so absolutely ridiculous that it should receive just such comment as it merits.

It seems like a political farce to accuse any Democrat of deliberately and willfully purloining the book, when the office of the county commissioners is under the control of a Republican board, and its interests are guarded by a Republican clerk, which board and which clerk are directly responsible for the safe-keeping of all the appurtenances of the office, and are liable to indictment by the grand jury for the disappearance of anything so important as a "Levy Ledger." It is a great reflection upon the intelligence of the board and its clerk to suppose that they would be so negligent. Perhaps the book will turn up after awhile, and it may not be so far from home either.

### DEMOCRATIC PRIMARIES.

The adjourned meeting of the Democratic Executive Committee is called to meet in Chestertown on Tuesday next, July 7, at 2:30 P. M.

At this meeting the plan of holding and conducting the primaries will be determined. The following is the plan used in 1901 and resulted then in placing a strong and representative ticket before the people. While the number of delegates in each district in 1901 was ten, some suggest that six, others eight and others ten, the same number as in 1901, be decided upon by the committee:

The Democratic voters will meet in their respective election districts and precincts on—between the hours of 2 and 6 o'clock P. M., for the purpose of appointing ten delegates from each district, to meet in Chestertown on— to nominate candidates.

If there is any contest for the election of delegates and a desire is expressed for a vote, the judges named in each shall appoint two clerks and shall open and close the polls at the hours herein prescribed, and when the polls are opened, shall receive the votes of all Democrats offering to vote, whose names shall appear upon the registration books and who shall vote in the districts where they are registered, and shall also receive the votes of all young Democrats, who, on account of their age are not registered but who will be entitled to registration and to vote at the ensuing November election. And, upon the closing of the polls at the hours herein directed, the said judges shall proceed to count the votes cast, and shall certify to the person receiving the highest number of votes as delegates. Whereupon it shall be the duty of the delegates to proceed to Chestertown on said Tuesday in August, and cast the vote of the district in convention and nominate the county ticket.

Should no desire be expressed for a ballot, then the district meetings may select delegates by a viva voce vote, or by committee nominations. If a ballot is desired then those present shall select judges and clerks.

In districts where there are two precincts it is advised that each precinct be accorded five delegates.

### MEETING OF THE STATE CENTRAL COMMITTEE.

At a meeting of the Democratic State Central Committee held at the Eutaw House, Baltimore, Thursday, it was decided to hold the State Convention in September, the date of which will be named by Chairman Vandiver later. The sentiment for Governor was largely in favor of Hon. Edwin Warfield.

In commenting on the meeting the Baltimore Sun says:

"Not in years has there been so notable gathering of Democrats from all sections of the State and from Baltimore as assembled at the Eutaw House yesterday afternoon to attend the meeting of the Democratic State Central Committee."

"Practically every faction of the party was represented at the meeting, and Democratic leaders who have been fighting each other for some time met in amity and manifested a fraternal spirit. The proceedings of the committee were harmonious."

The Baltimore Herald says editorially:

"We cordially congratulate the Democrats of Maryland upon the unusually fine meeting of the State Central Committee held in this city yesterday. It was altogether the best that has assembled in the past eight years, and it shows that the democrats are keenly interested in their organization and in the contest which will be fought at the polls in November."

"Such interest as that manifested yesterday proves that the best intelligence of the democracy is aroused. It is a good augury for the character of the ticket which will be placed in the field."

### PEOPLE'S COLUMN.

#### COUNTY FINANCES.

Chestertown, July 3, 1903.

TO THE CHESTERTOWN TRANSCRIPT: Messrs. Editors:—Your continued calling attention to the disastrous condition of the finances of Kent county, resulted very properly in a prompt investigation by the grand jury. When the grand jury took the matter up it was with the full understanding that "all the books" were to be seen and examined by Mr. Blacklock, its expert. Mr. Blacklock has been most careful, and in accordance with the system of all experts he asks for every missing link, whether a book or voucher.

In his examination he finds that the "Levy Ledger" with statements from 1892 to 1900 is not in the commissioners' office. He made a demand for this book. Was told "The book cannot be found."

When the commissioners through their attorney, Mr. Townshend, and their newly found expert, Mr. Willson, gave the public their \$1000 investigation, which even they themselves do not understand, these two "experts" had this "Levy Ledger." They used it in their investigation. Did they find in it any thing which it would be best "for the party's sake," not to have disclosed? If not, why, should the present expert not have it?

The Commissioners are responsible for its safe-keeping. This book may be memoranda and notes and explanations and private marks contained in it, throw a flood of light upon what Mr. Blacklock just at this moment needs. It is equally true it may not do so. But whether it does or not, why at this critical juncture has it been mislaid, purloined,—has it run away, or has it been run away with?

"Suppression veri suggestio falsi" is a proverb among lawyers, equally applicable to the County Commissioners and every one who has been allowed to handle that book. These latin words simply mean,—The suppression of the truth—suggests an unlawful, illegal device to prevent the truth from being known.

The assertion that this book was taken away by any one "for the purpose of biasing the minds of the people against the present commissioners" is utterly absurd. It reflects upon the mind that conceals it up, and shows the true state of alarm which exists among those responsible for the safekeeping of this book. They view asant the fact that its loss has been placed in the hands of the Grand Jury for its action by Mr. Blacklock. But for Mr. Blacklock the absence of the book would never have been known. He don't know what those he contains. He wants to. Part of it he can verify from other sources, but he wants original and not secondary evidence.

If the investigation has run into politics, it is never originally intended to get there. A letter published in your paper early in February last showed such investigation was needed, and it was suggested then that to avoid its being a political question the investigation be at once instituted. It could all have been completed and ended by the last of March. But heh! heh! determined not to permit it, against the advice of the ablest Republicans in the party, I am told, deferred action until the scheme to have Mr. Willson and Mr. Townshend examined and thus dupe the public, was hit upon.

The tax-payers must face the situation that a rate for this year only of \$1.25 will not nearly meet the present deficiency, with a blast of trumpets, they proclaim it will. Only \$3,000 in this levy I am told is for public schools. It should have been \$16,000, in fact more, and less for roads. How will they make up all these deficiencies which will have accumulated next year? We cannot possibly escape next year also a rate of \$1.35 and more if we insist and see that all claims against the county are filed (and by law compelled to be filed) prior to June 1st, 1904. There are too many who have been placed like Mr. James Bradley, of Chestertown, has been placed with his levies, gentlemen, and they are known.
