Local Matters.

Band Engaged.—The Galena band has been engaged by the Tolchester management to furnish music during the Fair to be held Aug. 25 to 28. This assures good music.

Scholarship Appointment.—Master Charles Wheatley, son of Mr. William A. Wheatley, has been appointed to a scholarship in Washington College as the result of a competitive examination held on Wednesday, August 5. Several young men of the county took the examination. The scholarship was made vacant by the resignation of Mr. William Maslin.

Held by Federal Jurors.—Jervis Maxwell Jewell, who was arrested some time ago on the charge of fraudulently obtaining money from pensioners of the government by representing himself to be a pension examiner, was given a hearing before United States Commissioner Rogers on Thursday and committed for the action of the Federal Grand Jury in default of \$5,000 bail.

The Prohibition Convention.—The Prohibition Convention was held in Still Pond on Wednesday morning at eleven o'clock, and the following ticket was named: Senate, G. W. Covington; Delegates, B. F. Fell From Step Ladder.—Mrs. Lizzie Hines, of Baltimore, widow of the late John W. Hines, of Chestertown, while arranging some draperies about her home the other day, fell from a step ladder, sustaining painful injuries about the head and face. A doctor was summoned, and found it necessary to take sixteen stitches in the wound inflicted. Mrs. Hines' many friends in the community regret to hear of the accident, and hope for her speedy recovery.

Lot Sold.—The Thomas Mann lot, on Washington avenue, was sold on Tuesday morning by Lewin W. Wickes, Esq., trustee, to Mr. Alvin M. Culp for \$450, subject to a lien of \$500, held by the Board of Visitors and Governors of Washington College. As stated exclusively in the Transcript some weeks ago, Mr. Culp will begin grading the lot preparatory to the erection of six modern residences, three fronting on Washington avenue and three on Kent street extended.

Stole His Money.—Raymond Waters, a colored bootblack, was arrested on Saturday morning on suspicion of having stolen \$26.00 from John Chinaman on Friday evening. John has recently opened a laundry in the store room adjoining Mr. W. Ambrose Carroll's shoe store, and had his money in the rear apartment of the store. Waters, in company with other boys, had been playing in the back yard, and his familiarity with the premises and his suspicious actions induced John to have him arrested. The Chinaman had no positive knowledge as to who took the money. Waters was given a hearing on Monday evening before Justice Willard Melvin, who imposed a fine of \$15 and 6 days in jail for opening a letter belonging to Mr. J. H. Sides. The evidence against Waters of theft was not sufficient and the case was dismissed.

Business Change.—Mr. N. Liberman will return to Kent county about the first of September and occupy his old stand at Melitota, where Messrs. M. M. Rasin and Son has been conducting a successful business for the past several years. Mr. Liberman will be remembered by the citizens in that neighborhood as an energetic and progressive merchant, and his return will be welcomed by a large number of friends and patrons, while Messrs. M. M. Rasin and Son's retirement from the general mercantile business will be regretted by their many friends and customers. The Messrs. Rasin will, however, continue to live in Melitota, and will give their undivided attention to the fertilizer, lime, cement, farm implement and carriage business which they will prosecute harder than ever. We wish both firms success.

Peach Shipments.—Mr. John Shriver is the peach king of Quaker Neck, having shipped 150 baskets of peaches to date, netting that many or more dollars. This is more than all the rest of the farmers in Quaker Neck together have shipped from Cliff wharf. Mr. Robert Ford, on the Biddle Hossinger farm, in Quaker Neck, has shipped some very fine fruit, for which he has received good prices. Mr. B. F. Rash is the one farmer near town, and in fact, in the county, who has anything like a fair crop of peaches. Mr. Rash has shipped to date 400 baskets for which he has received from 90 cents to \$1.10 per basket. Mr. Rash stated to the Transcript representative the other day that the numerous rains have had such a bad effect on his fruit, causing so much of it to rot, that out of a prospect of 4000 baskets, he will not have more than 2000.

Whiskey Cases.—Hayward Middleton, of Rock Hall, was before Justice Willard Melvin on Thursday morning charged with selling whiskey and beer on twelve different counts. Justice Melvin held the accused for the action of the grand jury on six of the charges, the bail in each case being \$250. Middleton is in jail, having been unable to furnish bail. The other six charges were dismissed. William White, also of Rock Hall, was before the same justice on Thursday on five charges for the same offence. All the charges were dismissed.

P. O. S. of A. State Officers.—The Eighth Annual Session of the Maryland State Camp of the P. O. S. of A. was held this week in Frederick City. The keys of the city were delivered to the visiting delegates by Mayor Smith, and an address of welcome was delivered by Justice John Wood, to which the president of the camp, Mr. Wm. E. Valliant, of Chestertown, responded. President Valliant delivered his annual address, reporting the institution of seven new camps during the year. Three camps have surrendered, giving a net gain of four in the number of camps. The increase in membership has been 400. Rock Hall Md., was chosen as the meeting place of the Camp in 1904. The following officers and delegates to national camp were elected: president, Prof. W. J. Heaps; vice-pres. Wm. J. Carter; conductor, Wm. A. Burke; inspector, Wm. E. Gray; guard, Charles Deitrich; trustees, Chas. H. Brown and John A. Little; delegates to National Camp, William E. Valliant, James Marine, J. Bibb Mills and A. M. Geisbert.

CONTRACT PRESENTED.

James W. Chapman, Jr., Esq., of Baltimore, counsel for Nathaniel T. Meglins, of Lathimore, who has been granted a franchise to establish a gas plant in Chestertown, has drawn up a contract for the same and presented it to the Board of Town Commissioners for approval. At a meeting of the Board held on Wednesday evening the provisions of the contract were discussed and were declared unsatisfactory because of the fact that there were no provisions stated with regard to the number of feet of gas to be furnished to citizens and corporations of the town. The contract was returned to Mr. Chapman with the following stipulations: That the petitioner must guarantee in his contract to furnish the citizens and corporations of the town with 22 candle power gas which is not to exceed the cost of \$1.50 per 1000 feet, and that the building must be completed within six months from the expiration of the time allowed in the franchise for commencing the work. The franchise is to extend over a period of thirty years, instead of being perpetual. It is believed that Mr. Chapman and Mr. Meglins will accept the demands of the commissioners.

AN HISTORIC CHECK.

Mrs. William J. Vannort, while looking over some old papers which she had stored in one of her trunks the other day, found a check which has rather a significant history. The check had been placed in the trunk by Mrs. Vannort's daughter while the former was visiting Baltimore, in June, 1895, and as Mrs. Vannort had no occasion to go to the trunk, the check had been entirely forgotten. At the time of receiving the piece of paper, Mrs. Vannort was a large stockholder in the Hygienic Ice Company, of Washington, D. C. The check was drawn for \$60, and is dated June 29, 1895, it being the semi-annual interest on the amount of her bonds. The Hygienic Ice Company deposited its money in the National Bank of the Republic, which was at that time owned by a Col. Lemon, on which bank the check is drawn. Col. Wm. J. Vannort placed the check in the Kent County Savings Bank for collection. It was sent to Washington for payment and returned protested. It has since been learned that owing to the rapid advance of the premium on U. S. Bonds at that time of which the securities of the bank were composed, Col. Lemon disposed of the stock of the bank, and the Hygienic Ice Company has become a part of the American Ice Company Trust. Col. Vannort went to Washington the other day for the purpose of investigating the matter further, and through a friend introduced to Mr. Samuel W. Curriden, who is the treasurer of the Hygienic Ice Company, and by whom the check was signed. Mr. Curriden informed the Colonel that the bank had gone into liquidation, and that the ice company has become a part of the trust, but that he would investigate the matter and see if he could not have the check acknowledged. Col. Vannort has the check in his possession at present.
