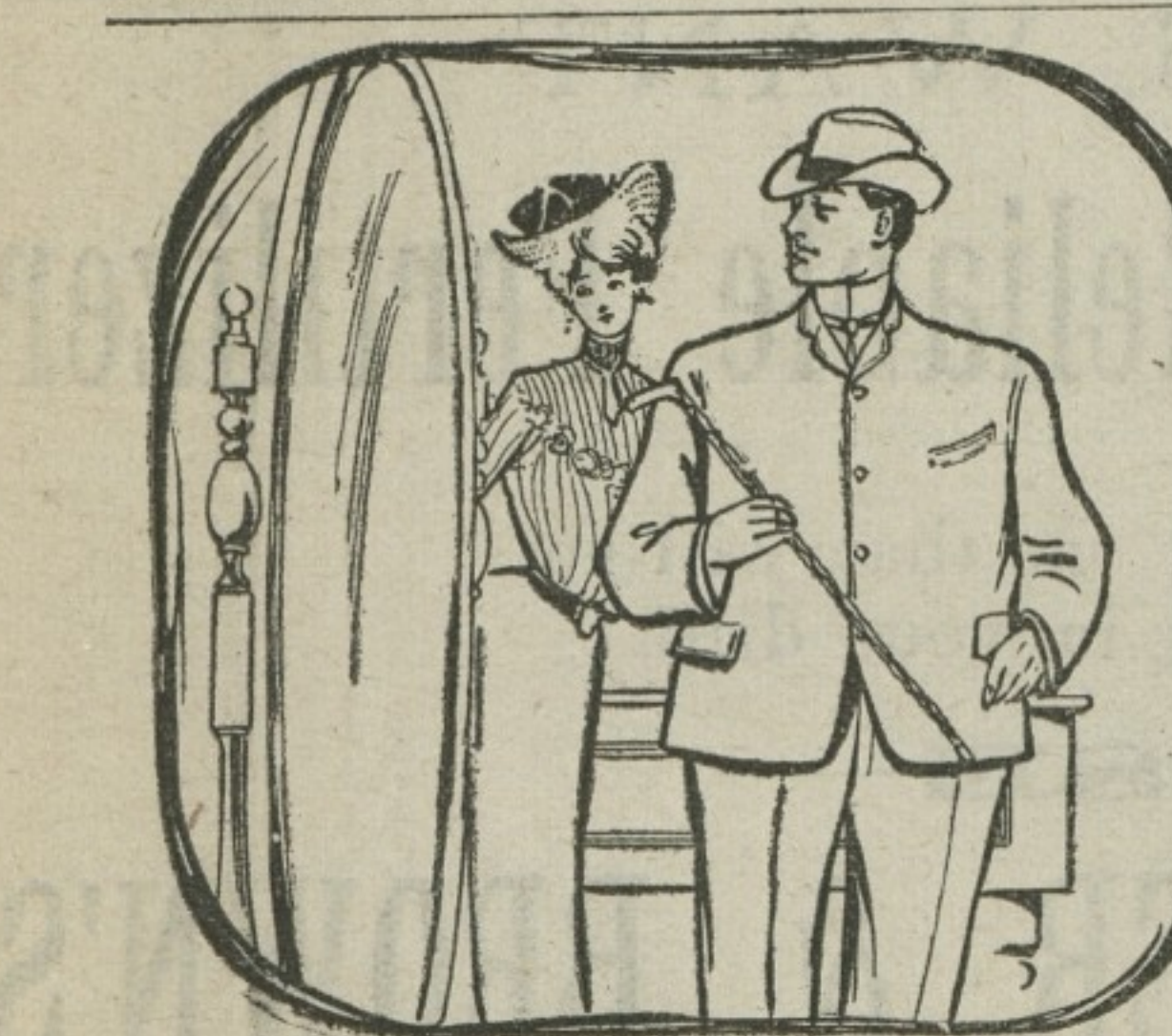

TEACHERS' INSTITUTE.

A PROFITABLE SESSION OF THREE DAYS.

Good Speakers Present and Able Addresses the Rule—The Institute a Social Event.

The County Teachers assembled in the handsome Assembly Hall of the Chestertown Public School on Tuesday morning for a three days Institute. The large stage had been beautifully decorated with bunting and palms for the occasion and this together with the charming countenances of the teachers presented a scene of real beauty when Examiner Peterson called the Institute to order. Nearly every teacher in the county responded to the roll call on the opening day indicating that the teachers are thoroughly interested in the great work of education, and appreciate the value of Institute work. The exercises on Tuesday morning were opened with prayer by Prof. L. Jefferson Smyth, principal of the Chestertown Public School, after which Prof. Peterson introduced Dr. W. Frank Hines, president of the School Board, who delivered the address of welcome. Dr. Hines delivered a short but very appropriate and encouraging address in which he stated that the schools of the county are in better condition than they have been for many years past, and that Kent's force of teachers is as intelligent and loyal to their work as any teachers in the State. Dr. M. Bates Steyens, the efficient and up-to-date State Superintendent of Education was present and introduced Dr. James W. Cain, the newly elected President of Washington College, as the next speaker. This was the Doctor's first appearance before a Kent county audience and the impression he created was indeed favorable. He delivered a very scholarly and pointed address on the subject of "Etymology." The ease with which the Dr. handled his subject showed him to be a thorough master of English and the Languages. In closing his address Dr. Cain stated that he is delighted to come to Kent county to take up the work of education. He stated that he desired to be considered one of Kent county's teachers, one who could be approached on all occasions and ready at all times to assist the public school teachers in their work whenever his duties would allow him to do so. He made a most favorable impression upon all who heard him. Perhaps the busiest man at the Institute was Prof. Murdaugh, the principal of the Frostburg State Normal School. Prof. Murdaugh is a practical educator and all of the subjects upon which he spoke were practical subjects. He is a thorough master of the art of teaching and all of his lectures abounded in those things which are most useful for a teacher to know. At the morning session on Tuesday Prof. Murdaugh discussed "The Recitation," and at the afternoon session he lectured on "Desk Work." A very interesting round table was conducted at the Tuesday afternoon session on the subject of Grammar by Prof. Milton Melvin, principal of the Morgne school. He was very ably assisted by a number of the teachers of the county. Dr. Stephenson delivered a forcible address on the general work of the teachers and matters pertaining to education. One of the most pleasing features of the session on Tuesday morning was a soprano solo "Fair Genevieve," beautifully rendered by Miss Helen Wilkins, one of the sweetest singers in Kent county.

WEDNESDAY'S SESSION.

The opening exercises were in charge of Prof. Peterson, the music being conducted in a pleasing manner by Mr. Gilbert B. Taylor, principal of the Millington school. A very instructive and interesting Round Table in Reading was conducted by Miss Helen Link, assisted by several of the teachers. History was discussed by Mr. Thos. D. Bowers and a Round Table in Arithmetic with Miss Hardcastle as leader assisted by the teachers proved to be highly profitable. Prof. Murdaugh closed the morning session with a very practical and forcible lecture on "The Art of Questioning." The afternoon session was consumed in the discussion of History by Mr. Bowers, "Modern Lesson in Nature Study" by Miss Hardcastle, The Rational Method in Reading by Miss Smith and "Psychology applied to Teaching" by Prof. Murdaugh.

THURSDAY'S SESSION.

On Thursday morning Miss Hardcastle continued the Round Table in Arithmetic assisted by the teachers, lectures on History was concluded by Mr. Bowers, and Prof. Murdaugh lectured on "The Psychology of Thoroughness." The afternoon session was devoted to "Model Lessons in Nature Study" by Miss Hardcastle, "The Ration-

Some very fine specimens of pencil drawing were exhibited by the Rock Hall School, during the sessions of the institute.

Miss Bessie Wheatley's recitation on Thursday afternoon was not only finely rendered, but was very reasonable. It was entitled "Bill Johnson and de Watermelon."

Prof. Murdaugh spoke very instructively for nearly two hours on Thursday afternoon on the subject "The true purpose of the Common School." According to the Professor's idea, the true purpose of the common schools is to provide the boys and girls of the day with such an education as will enable them to earn their bread and butter, as well as to fit them for useful citizens.

The music, under the leadership of Prof. Taylor, was very well rendered.

The handsome piano which was presented to the school by Mr. William Walter Chapman, cashier of the Chestertown National Bank last June, was very much admired by the teachers and visitors.

Janitor Silcox was untiring in his efforts to assist the teachers in their duties. He has prepared the building in a most excellent manner for the opening on Monday morning.

Kellogg & Co. were displaying quite a number of new text books and periodicals, School Journals, etc., on the second floor hall during the Institute.

The lectures of Misses Smith and Hardcastle in Nature Study and Rational Method of Reading were very profitable.
