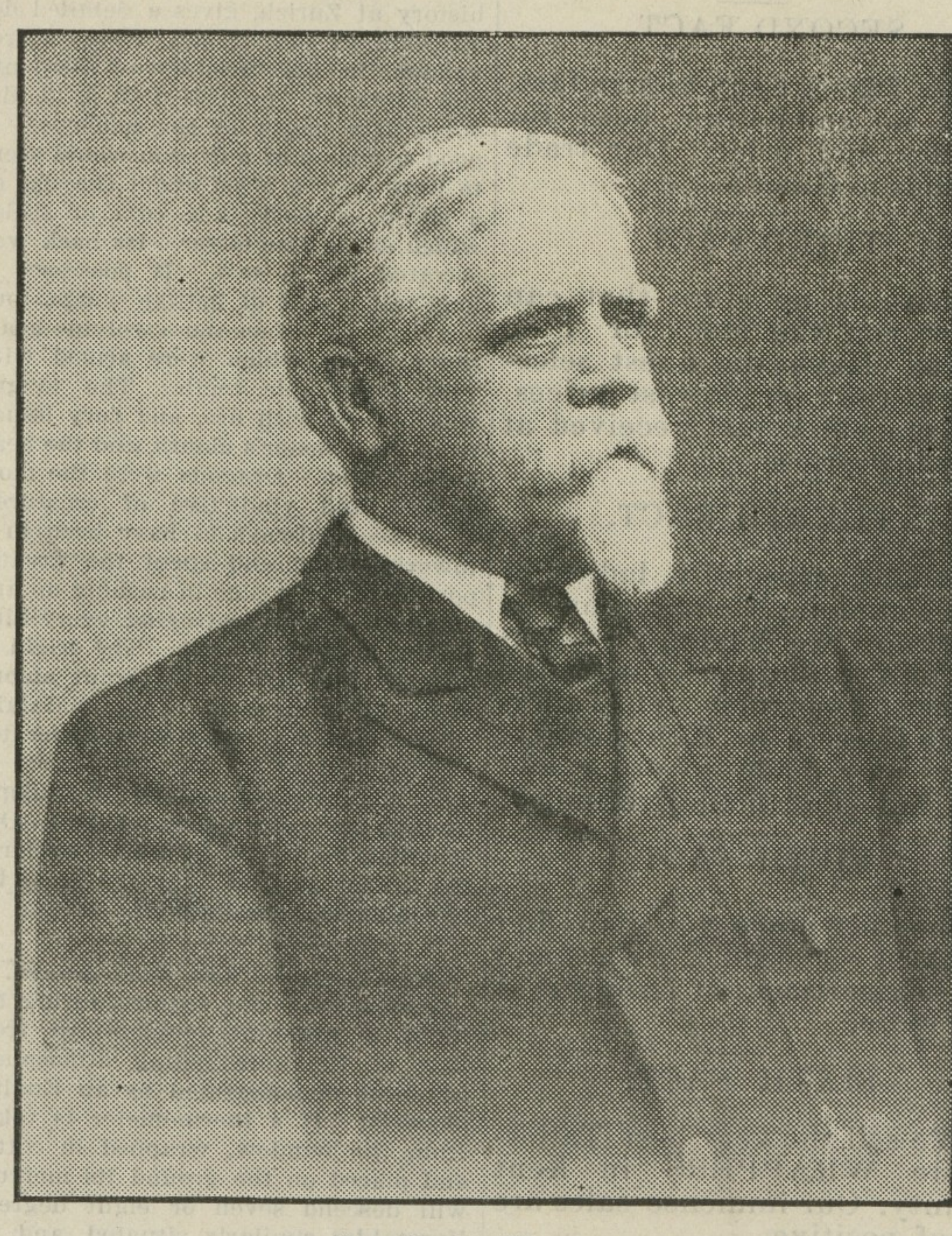
DEATHS OF A WEEK.
The Silent Reaper Cleans Precious Sheaves Among the Young and Old.

MRS. MARTHA FISHER.
Mrs. Martha Isabella, wife of Dr. Samuel G. Fisher, a former Clerk of the Circuit Court for Kent county, died at her late residence on Queen street on Monday afternoon at four o'clock, aged 69 years. Mrs. Fisher had been in failing health for some time, and yet with a patience borne of a noble christian character, she had waited submissively for the coming of the summons guarded and administered unto by her aged and devoted husband and loving children. Mrs. Fisher was a member of one of the oldest and most respected families in Kent county, having been the daughter of the late John Constable, who, during his life time, was a large landholder and representative citizen. Mrs. Fisher was a life-long Methodist Protestant, the church of her father's choice, and in her younger days and prior to her removal to Chestertown, was an active member of Wesley Chapel Methodist Protestant Church. The deceased was the sister of the late Stephenson Constable, Mrs. Richard Jones, William R. Constable, of Baltimore, and Mrs. Dr. Samuel Beck, whose families have been prominent in Kent county affairs for a long time. She is also related to Albert Constable, Esq., of Elkton, and Mrs. William S. Walker, of St. Louis. Funeral services were held from her late residence on Wednesday afternoon at 1 o'clock, Rev. D. J. Greenfield officiating. Interment was made in Wesley Chapel cemetery. The pall-bearers were: Messrs. J. K. Aldridge, W. W. Beck, Horace Caustable, R. W. Jones, William Constable and Jacob E. Tugent. Undertaker John N. Dodd had charge of the funeral arrangements. The deceased is survived by her husband, Dr. Samuel G. Fisher and two children, Dr. Samuel G. Fisher, a prominent physician of Port Deposit, and Miss Ellen Fisher, all of whom have the sympathy of the community in their great bereavement.

ARCHIE BECK BOWERS.
Mr. Archie B. Bowers, one of the most popular and highly respected young men of Kent county, died at the residence of his brother, Mr. George Bowers, in Wornton, last Saturday, of consumption, aged thirty-three years. Mr. Bowers held a responsible position with the Chester River Steamboat Company, in which capacity he gained the esteem of the company and the respect of the traveling public by his affable disposition and strict attention to duty. Mr. Bowers was a very ambitious young man, and felt that he could breast the dangers and hardships incident to a life in the gold mining regions of the Klondike, and thither he went more than a year ago in the hope that he would better his fortune. It was not long after his arrival there until the severe climate began to have its effect upon his system, and he contracted a severe cold, which culminated in that dreaded disease, consumption. Mr. Bowers left the Klondike for New Mexico in search of relief. He remained there for some months, but failing to find that which he sought, he left New Mexico some weeks ago, traveling the whole distance alone. He reached Betterton at about four o'clock last Saturday morning week. He was met by his brother George, who took him to his home in Wornton. Everything was done for the comfort and care of the beloved brother, but the disease had made such progress that his tired body succumbed after having been home just one week. Mr. Bowers was a man of high character and reputation, and his early death is greatly to be regretted. Funeral services were held at the residence of his brother George on Sunday afternoon at 2 o'clock, Rev. J. M. Sheridan officiating. Interment was made in St. Paul cemetery. The pall-bearers were his five brothers—Messrs. George, Thomas, Robert, Raymond and Elsworth, and his cousin, John Parrott. Undertaker Wm. H. Krusen had charge of the funeral arrangements.

MRS. ANNIE E. STORKE.
Mrs. Annie E. Storke, wife of Mr. Don G. Storke, died at her residence on Front St. on Tuesday evening at 7 o'clock of Apoplexy, aged 60 years. Mrs. Storke's death was very sudden, she having but a short while before her death returned from assisting Mrs. Jonathan Anthony in her household. Mrs. Storke was a good woman, and enjoyed the respect of the entire community. Funeral services were held from her late residence on Thursday afternoon, Rev. Dr. E. P. Roberts, officiating. Interment in the Friends burying ground near Lynch's. The pall-bearers were her three sons, Thomas, William and Charles, and her son-in-law, Mr. Noblett. Undertaker John N. Dodd had charge of the funeral arrangements. The deceased is survived by her husband, and three sons, and three daughters, Thomas, William and Charles, and Mrs. Martha Norris, Mrs. Gertrude Brodser, of Philadelphia, and Mrs. Annie Noblett, of Cecil county.

SAMUEL C. TARBUTTON.
Mr. Samuel C. Tarbutton, an old and highly respected citizen of Queen Anne's county, died at his late residence in Crumpton on Thursday of last week, of kidney trouble, aged 86 years. Notwithstanding his extreme age, the deceased had been active and vigorous, and only a week before his death visited his son Mr. W. J. Tarbutton, near Mellota. Mr. Tarbutton was a native of Queen Anne's, having lived nearly all his life near Crumpton. Funeral services were held at his late residence on Saturday morning at 10 o'clock, interment in the family burying ground near Crumpton. Rev. J. A. Arters, pastor of the M. E. Church officiated. Mr. Tarbutton is survived by four sons and one daughter, William J., of Mellota; George R. John S., and Hiram G. Tarbutton and Mrs. Sarah C. Battis. Undertaker Bradley had charge of the funeral arrangements.

A Great Convention.
Maryland's Democracy Assembled in a Unique Convention and Nominates a Ticket That Will Surely Win.
GREAT ENTHUSIASM MANIFESTED.

At a convention, that in point of numbers, enthusiasm and spectacular features surpassed any ever held in the State, the Democratic State ticket was nominated on Wednesday evening at Music Hall. A platform outlining the party doctrines in ringing phrases was adopted, and the rafters of the big building rang with the cheers of thousands of Democrats and the hand-clapping of many ladies. Spree will not allow an extended account of the Convention, but suffice it to say that the ticket is of such strength, and the enthusiasm manifested at the Convention was so great as to make Democratic victory in November absolutely sure. Col. Spencer C. Jones, of Montgomery, was made chairman of the Convention, and in assuming the position made a strong speech, urging that individual aspirations be subordinated to the good of the party.

The nomination of the candidates for Governor, Attorney General and Comptroller, were made by acclamation, and strong speeches from sterling Democrats, landed the various qualifications of the candidates for the respective positions on the ticket. Col. Jones, as presiding officer, whose privilege it was, named Hon. Murray Vandiver as Chairman of the State Central Committee to serve for two years. The following State Central Committee for Kent County was named: Adam F. Huey, Samuel J. Wickes and John M. Comegys.

The platform upon which the party will make its fight deals with those questions which most intimately concern the prosperity and welfare of the people of the State. It is as follows:

PLATFORM ADOPTED BY DEMOCRATIC STATE CONVENTION.

- First—The representatives of the Democratic party of Maryland, in State convention assembled, heartily commend the administration of Gov. John Walter Smith.
- Second—He has diligently and faithfully discharged the many and varied duties of his office and fully made good his assurances to the people that under his administration as Governor the laws would be vigorously enforced, the public revenues carefully guarded and peace and good order resolutely maintained.
- Third—The efficient and successful management of the affairs of the State in Democratic hands for the last four years justly entitles us to claim a continuation of the confidence and support of the people.
- Fourth—The good government which we are now enjoying under Democratic administration cannot possibly be made better by the Republican party; but, on the contrary, dependent for its existence as that party in this State is upon its solid negro vote, it is manifest that the defeat of our ticket at the coming election will bring back upon us the evils and dangers from which our triumph in 1890 so fortunately delivered us.
- Fifth—We believe that the political destinies of Maryland should be shaped and controlled by the white people of the State, and while we disclaim any purpose to do any injustice whatever to our colored population we declare without reserve our resolute purpose to preserve in every conservative and constitutional way the political ascendancy of our race.
- Sixth—The continuance in power of the Democratic party in this State means:
First—The continued rigid enforcement of the laws which have insured safety to person and protection to property.
Second—Continued economy in the expenditure of the people's money, but without parsimony, and progress without extravagance.
Third—It is a guarantee of the early extinguishment of the State debt and a speedy reduction in taxation.
Fourth—It will result in such amendments to our present excellent election law, which has done so much to lessen the evils of bribery, to assure the secrecy of the ballot and to promote intelligent voting, as experience has shown may be necessary to preserve the purity of our elections, without which good government is impossible.
Fifth—The success of our party means that the public schools of the State will be further fostered, expanded and improved, so that opportunity shall be given to every child to obtain a fair education.
Sixth—Maryland, among the first of the States in the Union to recognize that the welfare of all the people largely depends upon the improvement of public highways, created facilities for cheap transportation. That policy resulted in greatly increasing our prosperity and gave to the city of Baltimore an opportunity to share in the commerce of the country. The time has now arrived when we must return, to some extent, to the former policy of improving the highways. Good roads will cheapen the cost of transportation of Maryland's products and will add greatly to the value of property and to the comfort of all the people of the State. Our success will assure legislation to this end.
- Seventh—The products of the Chesapeake Bay and its tributaries have furnished remunerative employment for thousands of our citizens. Their right, their opportunity, to pursue their vocations must be guaranteed and it is alike the duty and the interest of the State to foster and increase the supply of the natural products of our great inland sea.
- Eighth—The Democratic party has shown by example that public improvements in the State and in the city of Baltimore can be made with economy and without suspicion or taint of jobbery. We propose to continue that policy, so that Baltimore city shall have the opportunity to construct its system of sewerage and the improvement of its streets under such restrictions as will insure strict economy by business methods absolutely divorced from party advantage.
- Ninth—The Primary Election Law passed by a Democratic Legislature and signed by a Democratic Governor, has produced good results, and we are of opinion that its provisions, with such modifications as local circumstances may demand, should be extended to the whole State.
- Tenth—The election of a Democratic majority in both branches of the General Assembly will strengthen the hands of a Democratic Governor and contribute greatly towards the maintenance of good government in the State. It will also make certain the election to the United States Senate of a man who will truly represent the essential principles which the Democratic party has advocated from Jefferson's time to our own, and who would scorn to malign and attack the white people of the South in their efforts to properly solve the great questions resulting from the enfranchisement of the negroes.

School Notes.

The Chestertown Public School is very much crowded. Several of the rooms have more pupils than they have seating capacity. The Sixth and Seventh grades have been divided and placed in other rooms.

The First grade has been divided and one section of the Primer grade attends school in the morning and the other section in the afternoon.

These divisions have been caused by the unusual attendance this year. At least forty new scholars have been enrolled during the past week.
