COUNTY FINANCES.

We regret very much that the editor of the Republican organ should doubt the veracity of our statements or the high character and ability of gentlemen who engage in conversations with us relative to the condition of Kent county's finances. It has always been our desire to state the truth in regard to this all important matter to the tax-payers of the county and to furnish them with such information as will convince them of the true state of affairs in the Republican Commissioners' office. It is not our purpose to gratify the editor of the Republican organ by divulging the name of the county commissioner referred to in our editorial of last week, but we desire to state that he is a man who thoroughly understands the business of the commissioners' office, and who knows what a mismanagement is when he sees it. One of the best evidences of defeat and an inability to meet issues in their proper light is the proneness on the part of some people to abuse and to utter lack of argument in dealing with public questions. The Republican organ has shown its inability to cope with this question by its unjust resort to abuse and false insinuations, and it has demonstrated beyond question the entire lack of argument of justice in its attitude towards the county finance question by endeavoring to fill the minds of the voters of the county with fair elections and the Haman Oyster Bill. With Louis E. McComas, the Czar Imperial of the Republican party, and the staunch advocate of the iniquitous Force Bill in the United States, tied around the neck of this same party like a mill stone that will drag their cause to destruction in November next, it is poor policy for the Republican organ to go to advocating fair elections. Better come a little nearer home and a little nearer the pockets of the tax-payers, and advocate a fair and just administration of the County's finances, and then the voters of Kent county will have more faith in the sincerity of their desire for fair elections. The desire for fair and square dealing by the Republican machine in Kent county certainly becomes ludicrous when looked at from the standpoint of the present disgusting mismanagement of our county finances. If the editors of the Republican organ will also take the trouble to look up the conditions that caused the defeat of the Haman Oyster Bill in the last Legislature, they will find that the vote of a Democrat and not a Republican killed it, and if they will fill their minds with the "oyster plank" in the Democratic platform they will see what the Democrats pledge themselves to do with regard to oyster legislation. Democratic pledges are as equally well kept as are Republican pledges.

THE STATE TICKET.

Scarcely in the history of the Democratic party has a stronger ticket been nominated than that by the State Convention on Wednesday evening. The nomination of Hon. Edwin Warfield, of Howard county, for Governor of the State was a foregone conclusion. His campaign for the nomination, conducted on the sure basis of securing popular approbation in advance, settled all questioning as to the head of the ticket. He is distinctively the candidate of the whole party, and his nomination by acclamation is the surest evidence of the fact that he is the choice of a united party for the high office to which he aspires. Mr. Warfield is perfectly qualified in every way to administer the affairs of the State most acceptably and with credit to himself and the people. He is popular with all classes of people, Republicans as well as Democrats; he has always been identified with public affairs and is one of the most progressive and prosperous business men in Maryland. Above all he is a man of undaunted christian character, and for this reason commands the esteem and respect of the people of the entire State.

Mr. William S. Bryan, Jr., the nominee for Attorney General is a lawyer of great ability, and is popular throughout the State both with the Bench and Bar. No man could have been chosen who is better qualified to fill the responsible position of Attorney General than he, because of his broad experience and ability as a lawyer. Dr. Gordon T. Atkinson, the nominee for Comptroller, is comparatively a new man in State politics, but none the less strong on this account. He has always been prominent in the affairs of Somerset County, and is extremely popular in the lower counties of the Shore. Hon. Joshua W. Miles, who nominated Dr. Atkinson, described him as "a simple, honest, christian gentleman," the noblest qualities of a strong character. He is one of Somerset's most prominent practicing physicians, and is a partner in one of the largest drug concerns on the Eastern Shore. He is regarded as one of the most successful business men on the Shore, having for several years been president of the Bank in Christfield and a director in several others.

The geographical distribution of the ticket is most wise, and its intellectual and business capacity is regarded as unimpeachable. With such standard bearers as Warfield, Atkinson and Bryan, the Democratic party is sure of election in November, and we are confident that their names will inspire such harmony and activity throughout the counties of the State, as to insure the election of the Democratic county ticket. As Col. Spencer C. Jones so aptly stated in his address before the Convention, let individual aspirations be subordinated to the good of our party, and let us stand shoulder to shoulder in our efforts to elect not only the Democratic State ticket, but our entire county ticket. The platform of the party furnishes us the issues upon which to wage our battles and to win our victory. Let not Kent county be a party to the dragging of our fair State from the rule of the white man, but let us elect our entire County ticket that the affairs of the County may be administered for the benefit of the tax-payers and for the prosperity and welfare of the people.

COUNTY FINANCES.

Further Evidence of Incompetency and Gross Mismanagement of the County Finances by the Republican Board of County Commissioners.

Day by day the most startling disclosures concerning the mismanagement of the county finances by the present Board of Republican County Commissioners are coming to light. Here is another evidence of the fact that the Republican party is utterly incompetent to manage the affairs of Kent county.

According to the levy of May 26, 1903, the taxable basis of the property of the Fourth District, as estimated by the present Board of County Commissioners is \$1,061,026. It has been found by competent authority that the actual basis is only \$965,116—a difference in the taxable basis for one district alone of \$95,910, which at the rate of \$1.35 on the \$100, will make a difference of \$1,294.76 in taxes. Now, if the Surplus Fund of \$252.84 which appears in the levy of May 26, 1903, be deducted from this \$1,294.76 it will leave \$1,041.95, an actual difference in taxes which the county Treasurer will be unable to collect on this year's levy. This mistake in addition of figures, but it means that this \$1,041.95 will have to be added to next year's levy, together with the \$5,811.58 which remains unpaid, as well as all the other deficiencies. Tax payers, this difference of \$1,041.95 is a difference in taxes for only one district. We have not been able to figure on the other districts yet, but we'll get them later. If this difference of \$1,041.95 had been added to the \$5,811.58 which remained unpaid at the time of striking the levy of May 26, 1903, it would have made the tax rate for this year \$1.43. If the Republican organ will be frank enough to tell the tax-payers of the county what the tax rate will be for next year, in view of all these disclosures that are being made from day to day, they may be able to anticipate what is in store for their pocketbooks next year.

No doubt the Republican organ will intimate that this statement is false in its next issue, just as it did with regard to our conversation with the Republican commissioner of unquestioned ability and veracity in its issue of Wednesday, but we have it down in black and white, and the tax-payers may see it by looking over the books. And there are more to follow.

THE DAYS for registration this fall will be September 29 and October 6. These are the only days on which voters may be registered. The registration officers will sit on Tuesday, October 13, for the purpose of correcting and revising the lists. No new names will be registered on that day. Voters should attend to this.

JUDGE ALBERT RITCHIE, of the Supreme Bench of Baltimore, died on Monday afternoon at Narragansett Pier, R. I., where he had been spending the summer. Judge Ritchie was regarded as one of the most eminent jurists of the State, and had long been prominent in the public affairs of both the city and the State. He is a great loss to the bench.

IT IS GRATIFYING to know that our Kent county boys are becoming prominent not only in the mercantile world but in the political world as well. Two Kent county boys who have won distinction in the political world recently and who are seeking even greater honors, are Clarence W. Perkins, Esq., and J. Henry Baker, Esq., of Baltimore. Mr. Perkins has been nominated for the State Senate by the Democrats in the Second Legislative District, of Baltimore City, and Mr. Baker has been nominated for the same position in the same district by the Republicans. Thus the two sons of Kent are opponents, and we may look for a battle royal.
