## OBITUARY.

### MRS. ANNA HUBBARD WATTS.

Mrs. Anna Hubbard Watts, wife of Prof. Rowland Watts, of Western Maryland College, died at their residence at the College in Westminster, on Friday evening last, of heart failure, superinduced by pleuro-pneumonia, aged 40 years. The news of Mrs. Watts' death reached Chester town on Saturday morning, and came like a bolt from a clear sky. It is not necessary for us to pen a eulogy of this good woman. The life that she led, her noble christian character, and lovely disposition, are too well known in this town, the scene of her girlhood days, to need any comment. In her life at Western Maryland College, associated as she was with strangers, and coming in contact with so many different dispositions, none knew her but to love her, none named her but to praise. Her life was a beautiful yet simple demonstration of the power of the influence of a sainted christian mother and lovely home, and wherever she went and in whatsoever sphere she was placed, in all things she was pleasant. Her influence, like the perfume of a beautiful rose, will live long after the body has crumbled to dust, and while the clay lies sleeping beside mother on the hill in the City of the Dead she has left to her loved ones the rich legacy of a noble and useful influence. The remains were brought to Chester town on the 6:20 train on Saturday evening and taken to the residence of her brother, Wilbur W. Hubbard, on Washington avenue, where funeral services were held on Monday afternoon at 1 o'clock, Rev. D. L. Greenfield officiating, assisted by Dr. Thomas H. Lewis, President of Western Maryland College. Interment was made in Chester cemetery. The pall bearers were Dr. James Roy Micou and Prof. E. J. Clarke, of Washington College, Dr. Fred Malone, of Greensboro, Md., and Messrs. J. D. Bacchus, Fred G. Usilton and R. H. Collins, of Chester town. The floral tributes were large and beautiful. Christ M. P. Sunday School, in which Mrs. Watts was at one time a faithful teacher sent an appropriate tribute, others coming from Western Maryland College, where the deceased had exerted such a lovely influence over the student body. Undertaker John M. Dadd had charge of the funeral arrangements. Her bereaved husband, father and relatives have the sympathy of the entire community.

### CHARLES BOYLES.

Mr. Charles Boyles, a prominent and highly respected young business man, died at the home of his uncle, Mr. J. Matthews, Golts, on Tuesday evening, of consumption, aged about 28 years. Mr. Boyles was for some years engaged in a successful mercantile business with Mr. A. S. Turner at Wornton Station, but owing to ill health was compelled to give up his business and seek a restoration to health. He spent sometime at Asheville, N. C., and felt so much improved in health that he removed to Golts Station about a year ago where he had been engaged in a prosperous business. The deceased was an honorary member of Washington Camp No. 61, O. S. of A., and was unmarried. Funeral services were held from the residence of his uncle yesterday morning at 10 o'clock, Rev. C. K. Morris officiating. Interment was made in St. Peter's cemetery, Smyrna, Del. The pall bearers were Messrs. Leon Stein, Isaac Jones, Manlove S. Jones, Elwood Morris, Charles Davis and Wm. Carrow.

### JAMES OGDEN.

James Ogden, the sixteen-year-old son of Mr. and Mrs. Alfred McGuire, died at the home of his parents in Gensena on Friday last of Typhoid fever. Funeral took place in the M. E. Church on Monday at 2 o'clock, Rev. C. K. Creed officiating, assisted by Rev. C. T. Prettyman. Interment was made in Galena cemetery. Undertaker W. H. Krusec had charge of the funeral. The pall bearers were Edward Caunan, Wm. Steel, David Steel, Philip Ireland, Raymond Prettyman, James H. McLuttre.

### MRS. WM. H. DADD.

Mrs. Wm. H. Dadd, died at her late residence on Calvert street, on Sunday morning last of throat consumption, aged 82 years. Funeral services were held on Wednesday afternoon from the residence, Rev.
