HOW THE COUNTY COMMISSIONERS' OFFICE SHOULD BE CONDUCTED.

The following are the recommendations made to the County Commissioners by Mr. Blacklock, the expert accountant, who, it will be remembered, made the investigation of the books and accounts of the Commissioners, of how the affairs of that office should be conducted:

RECOMMENDATIONS.

The following recommendations are respectfully submitted:

That the levy be made on the first day of July in every year, and that it include all outstanding claims up to the close of June 30th.

That the County Commissioners make, at the close of every levy year, a full and detailed statement of the revenues and expenses of the county for that levy year; the revenues and expenses being classified as follows:

Ordinary receipts, embracing receipts from taxes, licenses, fines, etc.
Extraordinary receipts, embracing receipts from the sale of public property, sale of county bonds, notes of the County Commissioners (if any are issued) reimbursement of expenses of Court cases removed from other counties, and the like.

Ordinary expenditures, embracing the current expenses of the county.
Extraordinary expenditures, embracing expenditures for public buildings, bridges, new roads, wharves, etc.; expenditures for redeeming county bonds, redeeming notes of the County Commissioners (if any have been issued) expenses of Court cases removed to other counties, and the like.

That the annual statement show in detail all outstanding claims against the county at the close of the levy year, and that all public officials be required to present to the County Commissioners a full and detailed statement of their claims against the county at the close of the levy year.

That all bills of public officials be audited by comparison with the original dockets, and that all bills for supplies and merchandise be certified as correct by the official receiving the goods.

That every person receiving a certificate of indebtedness in settlement of his bill, be required to state in writing on the bill that it has been so settled.

That the County Commissioners furnish the Treasurer, at the close of every meeting of the Board, a full and detailed statement of all certificates of indebtedness, and all orders on the Treasurer issued by the Board, and that he report for that purpose, a full and complete list, arranged in numerical order and according to date, of all certificates of indebtedness and orders on the Treasurer issued by the Board.

That at every regular meeting of the Board of County Commissioners, the Treasurer submit a full and complete list of all certificates of indebtedness and orders paid by him; and that all certificates of indebtedness be presented for payment directly to the Treasurer.

That the annual statement of the Board of County Commissioners show in detail all certificates of indebtedness, and all orders on the Treasurer that have not been paid up to the close of June 30th.

That the Treasurer receive and disburse all money of the County.
That the County Commissioners provide as soon as possible, a fire proof safe for the keeping of the current books and records of the County Commissioners, that are now stored in a vacant room in the jail, be placed in the office of the County Commissioners.
That a proper copying press be provided for the office of the County Commissioners, and that the methods of filing and indexing the records of the office, be placed on the most approved modern system.
That strict adherence be had to the recently inaugurated system of showing the following items in separate columns, namely:
1-Bills settled by check of the County Commissioners (until system is changed to the method of receiving all of the public money).
2-Bills settled by orders on the Treasurer to be paid by him in cash.
3-Bills settled by certificates of indebtedness.
Interest added to certificates.
Total amount of certificates.
