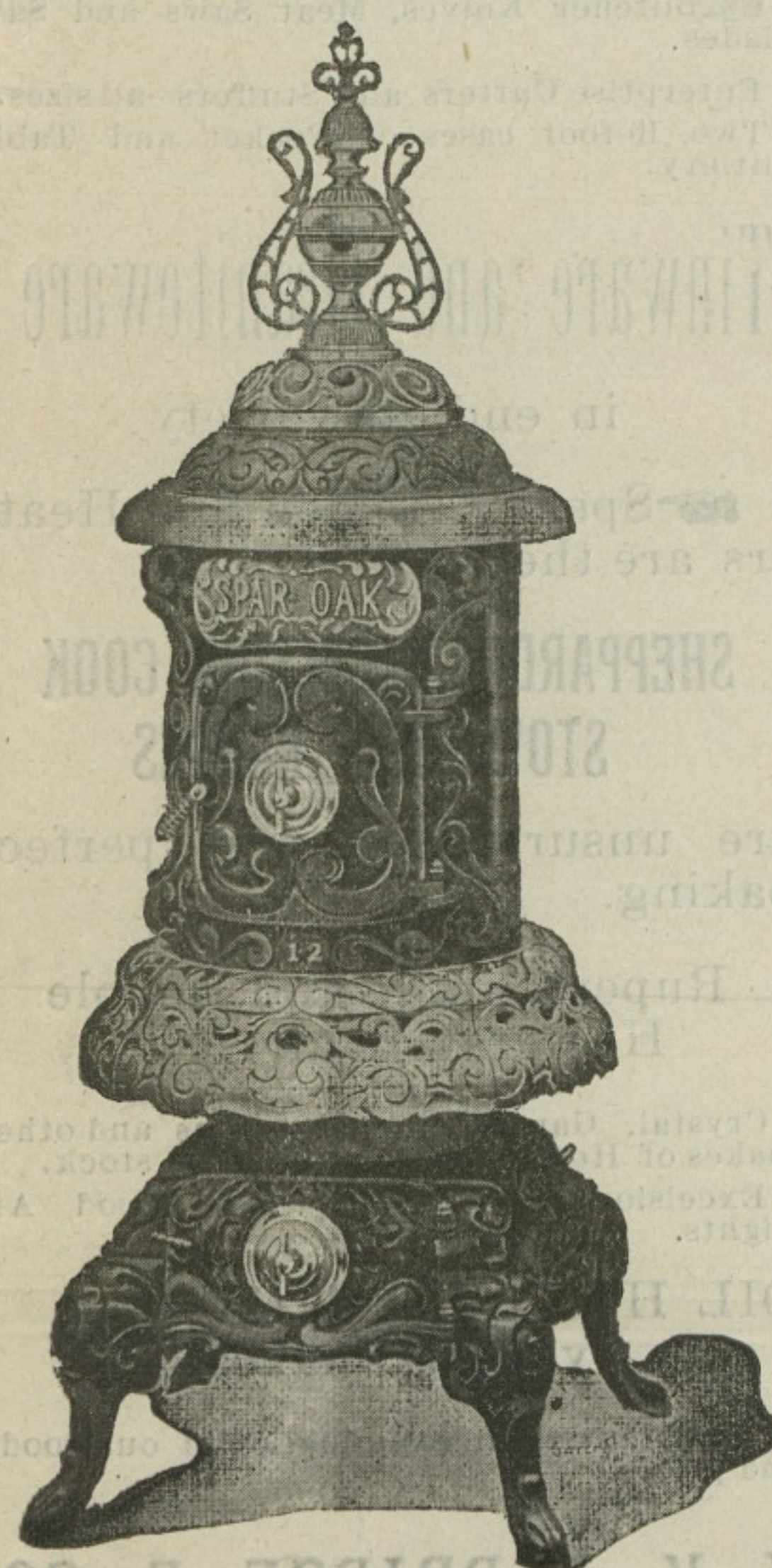

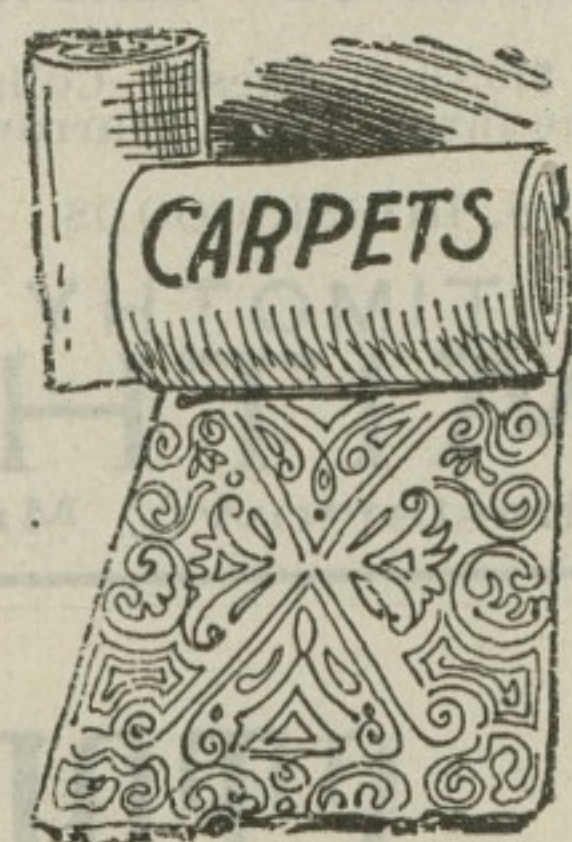

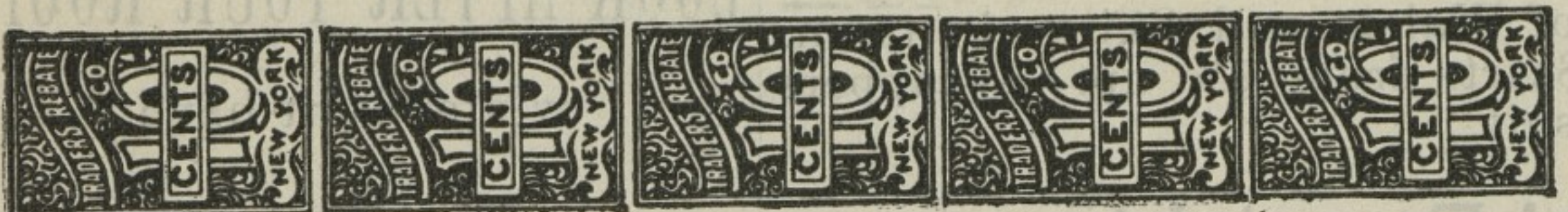

## HORSE SUFFERS THREE HOURS. With Foot Cut Off, it Stands Dying in the Street.

A horse with its hoof cut off, slowly bleeding to death for nearly three hours, attracted a large crowd on Dolphin street, between Madison avenue and McCulloh street, Baltimore, on Monday. The horse, a magnificent white one, attached to one of the wagons of the American Ice Company and driven by Samuel E. Dickerson, 1231 A style avenue, was struck by a car about 9 o'clock, and the hoof below the fetlock cut cleanly off, so that it hung by a string of skin. The wounded animal attempted to struggle to its feet, but was held down, while Driver Dickerson telephoned to the stable to Superintendent Peters. That official gave the driver authority to kill the animal, and Dickerson says he telephoned to the Northwestern Police Station to have an officer sent over to dispatch the sufferer. When the officer arrived the horse had been permitted to struggle up and stood on three legs, while blood dripped from the wound on one. Both Dickerson and Superintendent Peters, who arrived on the scene shortly afterward, appealed to the officer to shoot the horse. Mr. Peters, upon this being refused, said he would do it himself, but was told he would not be permitted to do so. Driver Dickerson says that the horse could not be killed until the arrival of the agents of the Society for the Prevention of Cruelty to Animals, who had been summoned.

As a consequence the horse stood bleeding in the street from 9 o'clock until nearly noon, when several of the society's officers appeared. Then a brawny negro, according to the statements of eye-witnesses, covered the horse's eyes with a bag and struck it a heavy blow with an ax. The blow, misdirected, only staggered the beast and he gave out a groan of anguish which was echoed by cries of indignation from the large crowd of spectators. Another blow and still another followed, with the same result. Then another negro took the ax and knocked the animal down, but it required a fifth blow to cause death. A prominent physician of the neighborhood says that he passed the place where the horse stood bleeding and suffering at 10.30 o'clock, an hour and a half after the accident, and that, despite his experience in the clinic room and in his profession, the sight so unnerved him that he was compelled to leave.

Mr. J. M. Crowley, 1130 McCulloh street, denounced the whole affair in strong terms and declared it without a parallel. Mr. Crowley said that he himself denied the two or three officers who were about the place that the horse be killed, but was not even answered. The spectators, he said, were wrought to a high pitch and severely condemned both the inactivity of the officers and the clumsy work of the society's agents in the case.
