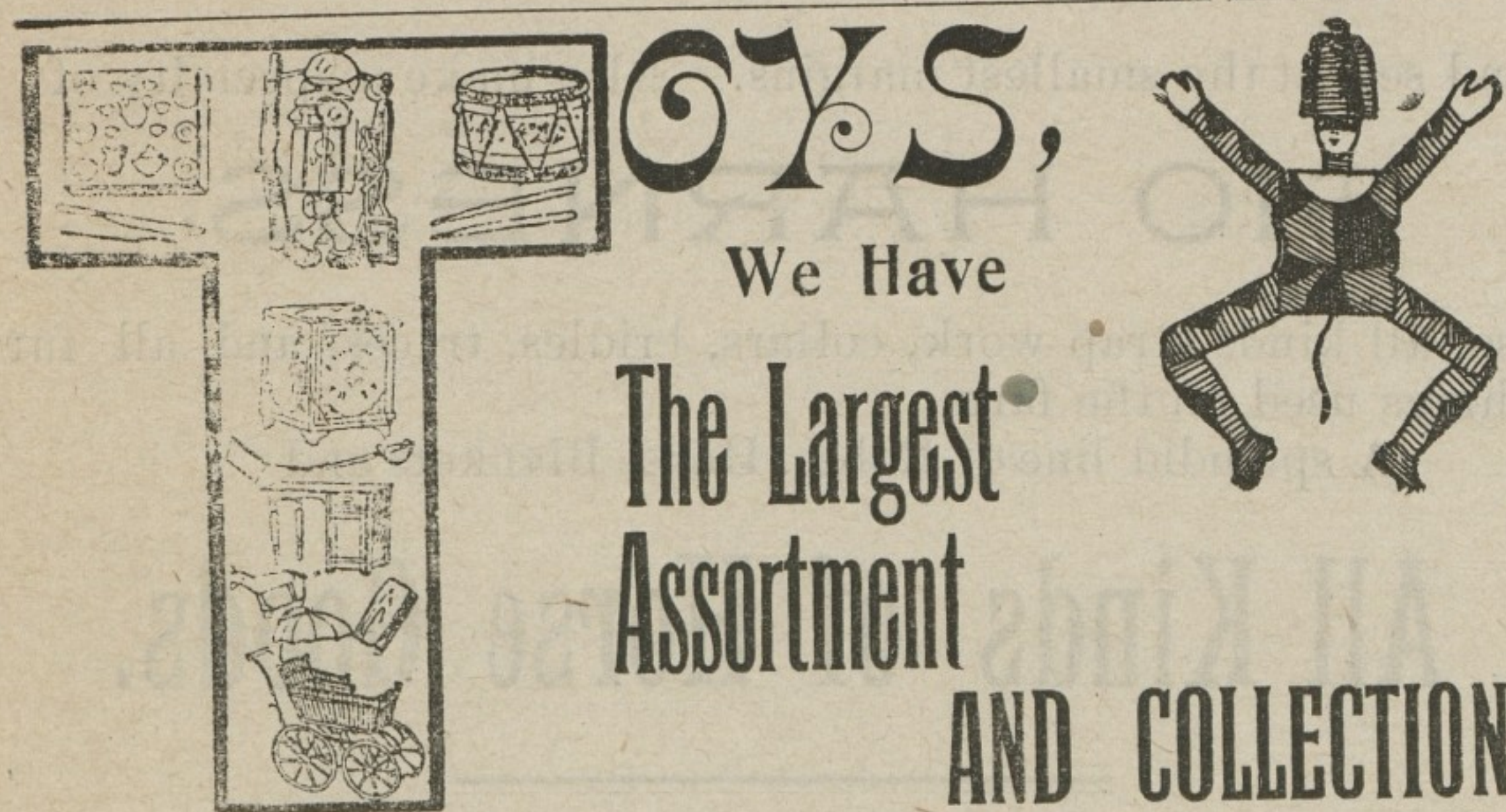

DR. WEEDON'S ANSWER TO DR. CAIN'S LETTER.

EDITORS OF THE CHESTERTOWN TRANSCRIPT, DEAR SIRS:—I read on Saturday last a communication in both the TRANSCRIPT and Kent News over the signature of J. W. Cain, President of Washington College, purporting to be a reply to an account of hazing at Washington College as given by the Enterprise, a newspaper published in Chestertown.

I have not seen the Enterprise. I do not know the editor of the paper, and I would not know him if I were to see him.

What President Cain has written for the TRANSCRIPT and News was published by them respectively. I have carefully read and shall direct attention thereto. I shall controvert his statement of so-called facts. The case referred to by him is now, and was then, in the hands of the law, and the production of his article at the time failed to accomplish its purpose. I think that I am in a much better position for obtaining the facts in the case referred to than President Cain, as I get my information from truthful lips that have never been polluted by the stain of falsehood; while he could only have obtained his from those who at the time were within the meshes of the law and who, President Cain has made statements so at variance with facts known by me that I am compelled to give a statement and let the public judge for themselves.

Summary as follows:

Master Augustine Eareckson left my home in Church Hill, Queen Anne Co., about half past eight o'clock, p. m., on Sunday Nov. 22nd, while for Washington College, arriving at his study room at ten o'clock, p. m. about an hour, he extinguished the light of his study room (complying with the regulations) and went to bed at 11 p. m. He did not lock his door because Master Finley, his roommate, was out. About half past twelve o'clock A. M. Monday morning, Nov. 23 Master Eareckson was awakened from sleep by the entrance into his room of Carey, Moore, Hughes and Wood (uninvited by him) who put their hands on him, hit him on the head with the innocent pillow from Master Finley's bed, which was in close proximity to his bed, leaving his person exposed. Master Eareckson then attempted to get up, but was held down by the hands of the assailants on his hands and knees upon Master Finley's bed, was struck on the head by Carey with a chair a terrific blow which fell him prostrate on his face upon Master Finley's bed. Having recovered himself somewhat, he got up on his feet, then it was that Moore and Hughes attacked him by choking him, pushed him back, and he was held down by Moore and Hughes, who were still choking him with their hands to his throat, and in the same time Carey and Wood held and pressed his body and limbs down upon the bed. When in this helpless position and almost exhausted condition, Moore placed his hand over the region of Eareckson's heart and called the attention of his pals and partners in the crime to its violent beating. Finally, his assailants released him, and he returned to his bed a wintry cold night, after having gathered his covers that had been thrown upon the floor by the dastardly outlaws.

But, alas! the friends were not done with him. As he lay in a wet bed, in a weakened, chilled and nervous condition, Carey was held over him by the intruders, while standing upon Eareckson's bed, and at the word given was let fall upon that child's prostrate form. The same act was repeated by belting Wood in like manner over him, back downward, and at the word given, he too, was let fall upon their victim. His room for a short time was vacated by the marauders. Perhaps they had gone to arrange a narrative of the foregoing contents of the innocent looking box of eatables (?) that had been sent from home. After being refreshed they again returned to his room and used upon him the toning-up cold-water cure.

After "doing him" in the classical slang of the place, Master Bryan was pulled into the room, Master Eareckson's room and was told by the arrant poltroon to sleep with him. Master Bryan replied that he could not do it, that the bed was too wet. Ultimately his tormentors quit his room and did not reappear.

When Master Finley came to his room, Master Eareckson asked him the time, and the reply was "only twenty minutes past one o'clock A. M."—an early hour for a lad to go to roost.

While this brutal and lawless assault was going on, the electric light in the hall was alternately turned on and off, affording Eareckson ample opportunity to fully identify his assailants, which he did. Master Eareckson's room-mate, in his bed, the next night (morning) suffering from headache and great bodily pain the result of the foul night attack in wild, windy, wooly West Hill, President Cain to the contrary notwithstanding.

There was no policeman, no watchman, no protector, no professor, in that night. Master Eareckson arose and dressed himself Monday morning, went over to the refectory at breakfast hour, but only drank a few sips of milk. He tried his utmost to keep up during the day, but shortly after the dinner hour he was compelled to take his bed—nervous and feverish, he remained in bed all of Monday afternoon, evening and night, with no one to look after him and administer to his needs. Master Eareckson could not arise Tuesday morning, so he requested Master Finley to ask President Cain to come to see him. President Cain called at his room at 3 o'clock P. M.

After Master Finley, his room-mate, and his friend Gill, had retired from the room, President Cain asked him a few questions, kindly applied the palm of his hand to Eareckson's forehead and left and never returned, probably the result of a gross mis-diagnosis, notwithstanding I had requested President Cain, that in case of a gross mis-diagnosis, he be injured, or become ill from any cause to telephone me without delay. He deceived me. Master Eareckson remained in bed, from the injuries he had received, all of said Tuesday and Tuesday night without attention and without nourishment. He arose Wednesday and was brought home.

I have not said anything about hazing—perhaps Webster and President Cain differ, it would be very natural that they should.

I have not said anything about the entry. Blackstone may differ from President Cain, and it would be surprising if he does not.

President Cain asserts that Master Eareckson was not sick (ill) as a result of the alleged assault. I emphatically contradict this assertion from my personal knowledge. I say he was.

I understand that in uno, falsus in omnibus. The statement made by President Cain is inaccurate—hence untrue. His statement has no foundation in fact and fails for the want of proper support.

The status of the case now is: that it is to be tried in the Circuit Court of Kent county by a jury of twelve men, good and true, when all will have the opportunity of hearing it thoroughly investigated, on both sides, discussed and a true verdict rendered.
