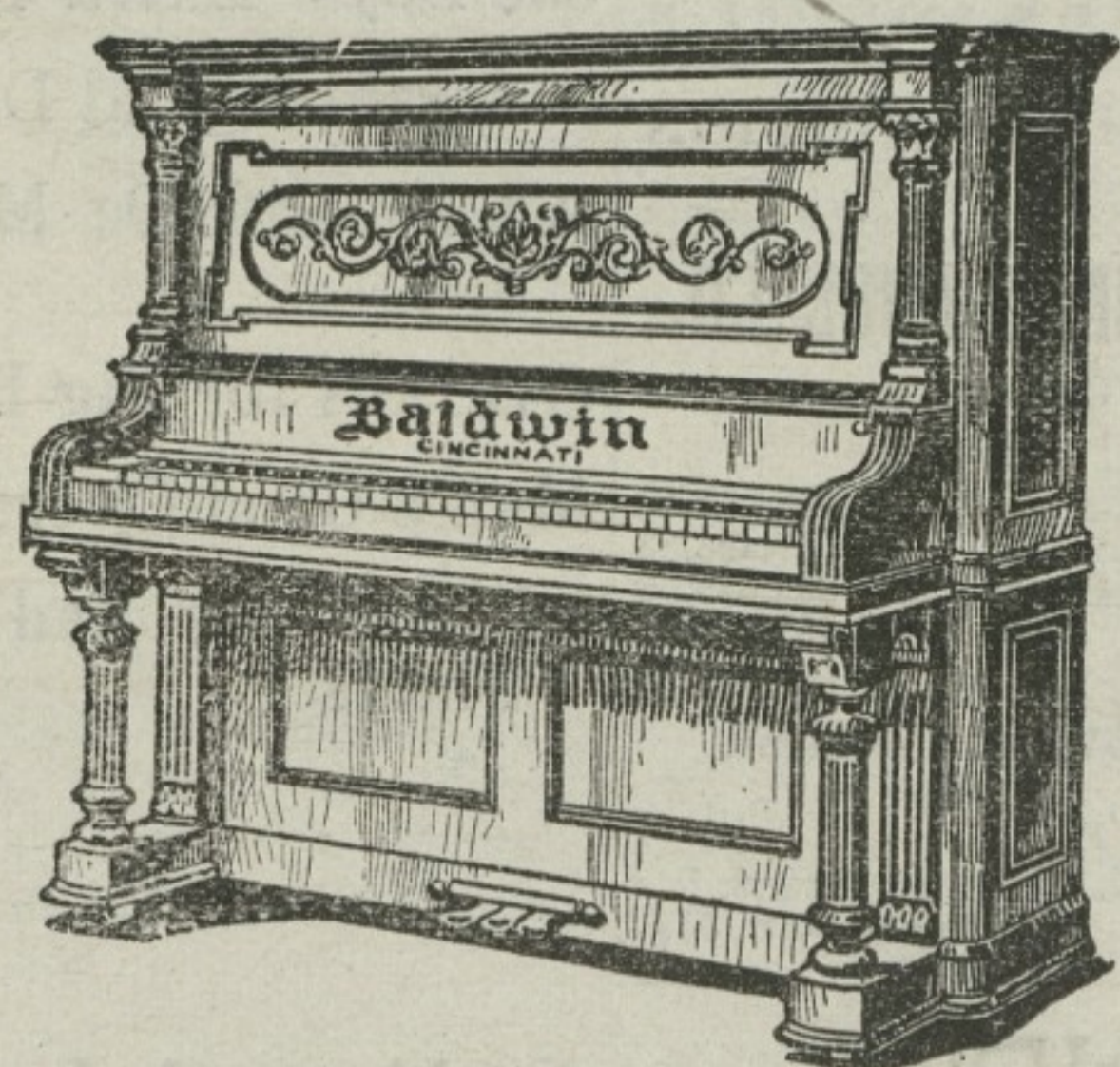

Hick's Forecasts for May.

Reactionary storm period is in progress as May comes in. Cloudiness and rain will pass easterly over the country from the 1st to 3rd, breaking into electrical storms in any localities on the 3rd.

A regular storm period is central on the 4th, covering the 4th to the 8th. Cloudiness and rain will attend and move promptly eastward over the country during the 6th, 7th and 8th. A decided change to cooler, with probable frost at night, will set in behind the storms to the westward about the 7th.

A reactionary storm period falls on the 11th, 12th and 13th. A regular storm period will be in force from the 15 to 20th, having its center on the 18th.

A reactionary storm period is central on the 23rd, 24th and 25th. Only moderate and brief change in weather conditions will take place between this and the closing storm period of the month, causing a prolonged threatening spell of weather, with possibly cooler about the 26th and 27th. A regular storm period covers the 28th to the 31st, being central on the 29th.
