Gov. CROTHERS has declared himself in favor of a reassessment of real estate throughout the State next year. It is likely that a bill for a general reassessment will be introduced at the next session of the Legislature.

THE ADDRESS OF Mr. W. B. Copper, past president of the Maryland Bankers Association, delivered last week, appears on page 7 in this issue. The address is a very able one, and deals with matters of vital interest to business people. Read it.

SO LONG as it seems assured that the speaker of the next House of Delegates is to go to the Western Shore, it is conceded that the Eastern Shore should have the president of the Senate. THE TRANSCRIPT is glad to present the claim of Senator Wm. M. Slay for the honor. Senator Slay is a holdover senator, and if he would accept he could fill the office with dignity. We should like to see him named.

SENATOR RAYNER has been paying his respects to Senator Aldrich in the U. S. Senate this week. Senator Rayner has shown his great brilliancy as an orator, and his course both by argument and vote has been in thorough accord with the highest principles of Democracy. He has voted every time in the people's interests and never once has he voted to impose a duty upon an actual necessity. He is a servant of whom Maryland may well afford to be proud. Send a Republican to Washington in his stead? Never.

SIDNEY P. TOWNSEND, Esq., of the Chestertown bar, was in Baltimore on Wednesday and stated that he was in favor of the nomination of a full Republican ticket for Kent. "No more bobtail tickets for Kent," says Mr. Townsend. He believes a full ticket will tend more easily to defeat the amendment in Kent. Mr. Townsend has been giving the amendment some hard raps through the columns of the American lately. He is regarded by the State leaders as the Republican leader in Kent now.

OUR REPUBLICAN friends need not revel in the belief that they are going to control the next Legislature. The people of this State want no return to the days of 1896. The conditions of labor under Republican rule will make the life of the farmer and tax-payers miserable. The people of Kent county remember too well the period from 1895 to 1903, to be willing to risk a return to those troublous days. The Democrats may have made some mistakes, and may have practiced greater economy along certain lines but the memory of past Republican administrations in this county and state is too fresh to cause the people even to think of a return thereto.

THE REPUBLICAN party is paving the way for its defeat at the election for the next congress as well as for the presidential election by its course on the tariff. The Chicago platform pledged the party to an honest revision of the tariff, so as to take the burden off the backs of the consumers; but the thing that Aldrich, the Republican leader of the Senate, has gotten together and called a tariff, is about the most disgraceful piece of graft of the present century. The revision of the tariff has been upward and not downward and the poor people's burden is all the heavier. It remains for President Taft to save the country from the grafters and the danger of a war between the classes.
